THE ABOVE OFFENSES WERE COMMITTED AS FOLLOWS:

DEPONENT STATES, BASED UPON INFORMATION PROVIDED BY THE POLICE PARTNER OF THE VI CTIM, PO BRIAN MOORE, TAX 949359, OF THE 105 PRECINCT ANTI-CRIME UNIT, THAT AT THE ABOVE MENTIONED DATE, TIME AND PLACE OF OCCURRENCE, WHILE RIDING IN THEIR POLICE VEHICLE, POLICE OFFICER MOORE AND HIS POLICE PARTNER DROVE SLOWLY ALONGSIDE THE DEFENDANT, DEMETRIUS BLACKWELL, AND INQUIRED AS TO WHAT HE POSSESSED IN THE WAISTBAND OF HIS PANTS.

DEPONENT FURTHER STATES, BASED UPON INFORMATION PROVIDED BY POLICE OFFICER MOORE 'S POLICE PARTNER, THAT THEY BOTH IDENTIFIED THEMSELVES AS POLICE OFFICERS AND C ONTINUED TO QUESTION THE DEFENDANT AS TO WHAT HE POSSESSED.

DEPONENT FURTHER STATES, BASED UPON INFORMATION PROVIDED BY POLICE OFFICER MOORE 'S POLICE PARTNER, THAT THE DEFENDANT THEN REMOVED A FIREARM FROM HIS WAISTBAND AND FIRED NUMEROUS SHOTS AT POLICE OFFICER MOORE AND POLICE OFFICER MOORE'S POLICE PARTNER, WHO WERE STILL IN THEIR POLICE VEHICLE.

DEPONENT FURTHER STATES, BASED UPON INFORMATION PROVIDED BY POLICE OFFICER MOORE 'S POLICE PARTNER, AS WELL AS OTHER PERSONS KNOWN TO THE NEW YORK CITY POLICE DE PARTMENT AND THE QUEENS COUNTY DISTRICT ATTORNEY'S OFFICE, THAT A SHOT STRUCK POLICE OFFICER MOORE IN HIS HEAD, CAUSING HIM TO SUFFER SEVER INJURIES TO HIS SKULL AND BRAIN REQUIRING SURGERY AND ADMISSION TO A LOCAL HOSPITAL.

DEPONENT FURTHER STATES THAT THE DEFENDANT'S DATE OF BIRTH IS APRIL 29, 1980.
