IN THAT THE DEFENDANTS, ACTING IN CONCERT, DID: with intent to cause serious physical injury to a person whom he knew or reasonably should have known to be a police or peace officer engaged in the course of performing official duties, cause such injury by means of a deadly weapon which was a firearm; intentionally cause serious physical injury by means of a deadly weapon or a dangerous instrument; with intent to seriously and permanently disfigure a person or to destroy, amputate or disable permanently a member or organ of that person, cause such injury to that person or a third person; intentionally cause physical injury while confined in a correctional facility pursuant to having been charged with or convicted of a crime; with intent to cause serious physical injury to another person, he causes such injury to such person or to a third person; intentionally cause physical injury by means of a deadly weapon or a dangerous instrument; intentionally cause physical injury; possess any dagger, dangerous knife, dirk, razor, stiletto, imitation pistol, or any other dangerous or deadly instrument or weapon with intent to use the same unlawfully against another; with intent to impede the normal breathing or circulation of the blood of another person, he or she applies pressure on the throat or neck of such person and with intent to harass, annoy or alarm another person struck, shoved, kicked

or otherwise subjected such other person to physical contact, or attempted or threatened to do the same.

THE GROUNDS FOR THE DEPONENT'S BELIEF ARE AS FOLLOWS:

Deponent is informed by CO RAY CALDERON of DOC, Shield# 15370, that at the above time and place, the defendants were acting in concert in that informant was working as a Correction Officer at George Motchan Detention Center when he was approached from behind by defendant GREEN who placed both of his arms around informant's neck and squeezed, causing informant to have difficulty breathing.

Deponent is further informed by informant that, while defendant GREEN was holding him, informant observed defendant WHITFIELD approach him with a sharp object in his hand. Deponent is further informed by informant that, he kicked defendant WHITFIELD in an attempt to avoid being cut, causing himself and defendant GREEN to fall backward onto the floor.

Deponent is further informed by informant that, defendant WHITFIELD then sliced him with said sharp object on the left side of his face from informant's forehead down to his cheek and his ear. Deponent is further informed by informant that, defendant WHITFIELD then sliced him with said sharp object on his right arm.

Deponent is further informed by informant that, as a result of the defendants actions, he was treated at a local Bronx hospital where he received approximately (20) stitches to his face and approximately (4) four stitches to his right wrist.

Deponent is further informed by informant that, he also suffered redness, swelling and substantial pain to his neck as well as annoyance, alarm and fear for his physical safety.
