AGGRAVATED MANSLAUGHTER

1ST DEGREE

The Grand Jurors of the State of New Jersey, for the County of Middlesex, upon their oaths, present that **KEVIN ROPER**, on or about June 7, 2014, in the Township of Cranbury, in the County of Middlesex, and within the jurisdiction of this Court, did commit aggravated manslaughter by causing the death of James McNair; contrary to the provisions of N.J.S.A. 2C:11-4a, and against the peace of this State, the Government and dignity of the same.

COUNT 2

VEHICULAR HOMICIDE

2ND DEGREE

The Grand Jurors of the State of New Jersey, for the County of Middlesex, upon their oaths, present that **KEVIN ROPER**, on or about June 7, 2014, in the Township of Cranbury, in the County of Middlesex, aforesaid, and within the jurisdiction of this Court, did drive a vehicle recklessly and thereby did cause the death of James McNair; contrary to the provisions of N.J.S.A. 2C:11-5, and against the peace of this State, the Government and dignity of the same.

COUNT 3

AGGRAVATED ASSAULT

3RD DEGREE

The Grand Jurors of the State of New Jersey, for the County of Middlesex, upon their oaths, present that **KEVIN ROPER**, on or about June 7, 2014, in the Township of Cranbury, in the County of Middlesex, and within the jurisdiction of this Court, did recklessly cause bodily injury to Tracy Morgan with a deadly weapon; contrary to the provisions of N.J.S.A. 2C:12-1b(3), and against the peace of this State, the Government and dignity of the same.

COUNT 4

AGGRAVATED ASSAULT

4TH DEGREE

The Grand Jurors of the State of New Jersey, for the County of Middlesex, upon their oaths, present that **KEVIN ROPER**, on or about June 7, 2014, in the Township of Cranbury, in the County of Middlesex, and within the jurisdiction of this Court, did drive a vehicle recklessly and thereby did cause serious bodily injury to Tracy Morgan; contrary to the provisions of N.J.S.A. 2C:12-1c, and against the peace of this State, the Government and dignity of the same.

COUNT 5

AGGRAVATED ASSAULT

3RD DEGREE

The Grand Jurors of the State of New Jersey, for the County of Middlesex, upon their oaths, present that **KEVIN ROPER**, on or about June 7, 2014, in the Township of Cranbury, in the County of Middlesex, and within the jurisdiction of this Court, did recklessly cause bodily injury to Ardley Fuqua, Jr. with a deadly weapon; contrary to the provisions of N.J.S.A. 2C:12-1b(3), and against the peace of this State, the Government and dignity of the same.

COUNT 6

AGGRAVATED ASSAULT

4TH DEGREE

The Grand Jurors of the State of New Jersey, for the County of Middlesex, upon their oaths, present that **KEVIN ROPER**, on or about June 7, 2014, in the Township of Cranbury, in the County of Middlesex, and within the jurisdiction of this Court, did drive a vehicle recklessly and thereby did cause serious bodily injury to Ardley Fuqua, Jr.; contrary to the provisions of N.J.S.A. 2C:12-1c, and against the peace of this State, the Government and dignity of the same.

COUNT 7

AGGRAVATED ASSAULT

3RD DEGREE

The Grand Jurors of the State of New Jersey, for the County of Middlesex, upon their oaths, present that **KEVIN ROPER**, on or about June 7, 2014, in the Township of Cranbury, in the County of Middlesex, and within the jurisdiction of this Court, did recklessly cause bodily injury to Harris Stanton. with a deadly weapon; contrary to the provisions of N.J.S.A. 2C:12-1b(3), and against the peace of this State, the Government and dignity of the same.

COUNT 8

AGGRAVATED ASSAULT

4TH DEGREE

The Grand Jurors of the State of New Jersey, for the County of Middlesex, upon their oaths, present that **KEVIN ROPER**, on or about June 7, 2014, in the Township of Cranbury, in the County of Middlesex, and within the jurisdiction of this Court, did drive a vehicle recklessly and thereby did cause serious bodily injury to Harris Stanton; contrary to the provisions of N.J.S.A. 2C:12-1c, and against the peace of this State, the Government and dignity of the same.

AGGRAVATED ASSAULT

3RD DEGREE

The Grand Jurors of the State of New Jersey, for the County of Middlesex, upon their oaths, present that **KEVIN ROPER**, on or about June 7, 2014, in the Township of Cranbury, in the County of Middlesex, and within the jurisdiction of this Court, did recklessly cause bodily injury to Jeffrey Millea with a deadly weapon; contrary to the provisions of N.J.S.A. 2C:12-1b(3), and against the peace of this State, the Government and dignity of the same.
