INTRODUCTION

1. The City brings this action against the owners and/or registrants of 76 ice cream trucks that engage in a shell game of vehicle transfers by which, through 2017, these individuals and their shell corporations have thwarted the collection of \$4,471,754.58 in judgments on defaulted traffic summonses. The City seeks to undo the fraudulent transfers by which corporate assets were placed out of reach, recover the judgment amount, with interest, and damages, and enjoin the defendants' continuing conspiracy to evade fines and judgments.

- 2. The defendants operate ice cream trucks in the most densely congested streets in New York City midtown Manhattan creating, for their own profit, unjustifiable risks to public safety by flouting traffic regulations while evading the financial consequences of doing business in that fashion by shuffling corporate assets. Between 2009 and 2017, the City issued in excess of 22,495 summonses to the defendants' trucks, all of which have gone into default.
- Defendants routinely thwart enforcement measures and evade the imposed penalties by transferring the ticketed trucks to dummy corporate entities for less than fair value, in collusive transactions. Thus, defendants repeatedly transfer the registration of their trucks at the State of New York's Department of Motor Vehicles ("DMV") among a host of shell corporations, shielding the vehicles from levy and seizure when the numerous underlying summonses, on which defendants invariably default, go to judgment.
- 4. Defendants' sole purpose in forming the shell corporations is to intentionally avoid payment of the outstanding parking debt owed to the City. When the City issues parking violations and the resulting fines are unpaid a required default notice is sent to the debtor; within 90 to 105 days after issuance, the violations become judgments. The debtor's property is then subject to levy by the Sheriff of the City of New York.
- 5. Defendants, knowing of the process and its timeline, rapidly transfer the registrations of their trucks from the judgment-debtor corporation to other shell corporations; the ticketed vehicles are no longer owned by the corporation incurring the fine, and the Sheriff can no longer levy on the offending truck. In stripping the judgment-debtor corporations of their sole asset the trucks the defendants intentionally thwart the City's enforcement of the outstanding parking judgments.

- 6. Each of the transfers of ownership is also a fraudulent transfer as to the City as judgment creditor in violation of the Debtor-Creditor Law.
- 7. All of the individual and corporate defendants named herein conspire with one another to engage in ongoing, rapid transfers of ownership that are intended to and do interfere with, thwart, hinder and delay the City's collection of judgments.
- 8. By the above-described scheme, each of the Individual Defendants named herein misuses the corporations they own and/or control, fails to observe the corporate form and operates the corporations without attention to corporate formalities, and is accordingly liable for the corporations' debts.

Midtown Parking Violations Between Mid-2012 and 2017

9. Defendants' trucks create dangerous situations and disrupt City traffic flow by stopping, standing, or parking in crosswalks (846 violations) or adjacent to fire hydrants (1,192 violations); defendants' trucks ignore red lights (93 violations), and block access to pedestrian ramps (63 violations). The photograph below taken on or about July 20, 2018, for example, shows one of the defendants' trucks, emblazoned with the hashtag "#NewYorkIceCream," selling while illegally standing in the bus lane on Fifth Avenue at its intersection with East 79th Street, just south of the Metropolitan Museum of Art::



10. The photograph below depicts another of the defendants' trucks parked illegally across from Lincoln Center on Columbus Avenue, near its intersection with West 64th Street, as shown in this photograph taken on or about July 1, 2018.




11. Other examples illustrate defendants' trucks flouting the law by illegally parking in the crosswalk on Fifth Avenue and 50th Street, between Rockefeller Center and St. Patrick's Cathedral, as shown in these photographs taken on or about on or about July 5, 2017:







12. Defendants have between 2009 and 2017 accumulated hundreds of violations concentrated throughout mid-town Manhattan, 98.5% of which were violations between 34th and 59th Streets and between 3rd and 8th Avenues in Manhattan, as shown by the below map of the violations' location.



13. To halt the evasion of City judgments and the threat to public safety caused by defendants' flouting of City parking and traffic rules, the City seeks an order i) authorizing the prejudgment attachment of 46 of the 76 trucks repeatedly transferred as part of this scheme, and that have each accumulated in excess of \$10,000 in judgments and/or unpaid fines, accounting for more than 99% of defendants' \$4.47 million in parking debt through 2017; ii) voiding the fraudulent transfers of trucks on which fines are owed and, entering judgment against the transferor corporations in favor of the City; iii) entering judgments against all defendants named herein, jointly and severally, in an amount sufficient to pay the City damages for interfering with the City's collection of its judgments, including but not limited to the approximate amount of \$4.47 million owed on the unpaid summonses; and iv) enjoining the individual and corporate defendants from transferring vehicle ownership for vehicles on which parking summonses have been issued or will be issued in the future.

PARTIES

- 14. The individuals named as defendants herein are the principals, shareholders and/or officers of the corporate defendants. The individuals dominate and misuse the corporations they own, operate or control in order to place corporate assets beyond the reach of creditors, and to insulate the corporate defendants from the payment of millions of dollars in judgment debt to the City. The individual defendants divert to themselves and others for their personal use corporate assets that otherwise would be recoverable to pay the enormous fines and penalties owed to the City.
- 15. The City is a municipal corporation organized pursuant to the laws of the State of New York.

Defendants "John Doe" and "Jane Doe", number 1 through 76, are fictitiously named parties, diligent investigation having failed to disclose their true names, the parties intended being any person or entity that is an owner, lessee, sublessee, transferor, transferee or operator of the 76 mobile ice trucks at issue, and any other person claiming any right, title or interest in the real or personal property which is the subject of this action. Defendants "John Doe" and "Jane Doe" are included in the terms "Corporate Defendants" and "Individual Defendants" as appropriate.

JURISDICTION

- 118. The Court has jurisdiction over the defendants pursuant to CPLR § 301.
- 119. Venue is appropriately laid in New York County as the City's principal place of business.

FACTS

- A. Defendants Transfer Judgment Debtors' Vehicles to Affiliated Shell Corporations for Less Than Fair Market Value
- 120. Pursuant to the scheme described above, between 2013 and 2017, defendants repeatedly transferred and continue to transfer the 76 trucks at issue here one Corporate Defendant to another at below-market sale prices, evading City judgments.
- and file a DMV vehicle registration/title application form, known as Form MV-82, requiring the registrant to state the vehicle's value, license plate number, name and address of the primary registrant, and vehicle identification number (VIN). Form MV-82 requires a representative of the registrant to certify that the information given in the application is true.
- 122. Between 2013 and 2017, the defendants conspired with one another to file hundreds of MV-82 forms for the 76 ice cream trucks at issue here, including the 46 ice cream trucks that the City seeks to attach. The defendants filed the MV-82 forms in order to transfer the trucks' ownership from a corporation saddled with pending or actual judgment debt to other shell corporations, thereby evading the City's enforcement of parking judgments. The MV-82 forms were signed by individuals claiming to be officers or other representatives of the corporations effecting the transfers.
- Athanasios Fotinakopoulos, also known as "A. Fotinakopoulos," "Tommy Fotinakopoulos," and "Tony Fotinakopoulos;" (b) Tommy Dalageorgos; (c) Antonio Tsatsaros; and (d) Michael Vasiadis, each of whom identified himself in DMV filings as an officer of multiple corporations. Each individual is identified in DMV filings as affiliated with one or more of the Corporate Defendants, and as a group, with all 93 Corporate Defendants.

- 124. The other two Individual Defendants, **Helen "Eleni" Fotinakopoulos** and **Dimitrios Tsirkos**, also have and have had roles in the defendants' scheme, including the following:
 - a. From 2013 through at least 2016, Helen "Eleni" Fotinakopoulos was listed on the lease agreements as a co-lessee for the ice cream truck with VIN # 5B4HP42W823340947, on which as detailed below in paragraphs 179 and 180 the defendants have incurred over \$128,000 in unpaid parking debt to the City During this period, there were multiple transfers of registrations and ownership of this ice cream truck among the defendants, with the corporate registrants during this period including Kong Ice Cream Inc., Robert Fun Ice Inc., Twirly Twirl Ice Inc., Icy Man Inc., Vuku Services Inc. and Ace Ice Inc., and with the registered owners including Athanasios Fotinakopolous, Tommy Dalageorgos, and Michael Vasiadis.
 - b. The defendants have also diverted to themselves, including to Helen "Eleni" Fotinakopoulos and Dimitrios Tsirkos, for their personal use corporate assets that otherwise would be recoverable to pay the fines and penalties owed to the City. Upon information and belief, both Ms. Fotinakopolous and Mr. Tsirkos along with the other Individual Defendants have diverted corporate monies to personal bank accounts and/or spent corporate monies on non-corporate purposes.
 - c. In addition, Tsirkos operates one or more of the three depots where the defendants store their ice cream trucks and is the co-owner, through a limited liability company, of the depot at 11-16 34th Avenue, Long Island City, New York, which is the registered principal place of business of multiple Corporate Defendants, including ACE ICE, Inc., Avery Ice Inc., CMC Ice Inc., Fevgo Ice Inc, Four Guys Ice Inc., Meathead Inc., Tavaga Ice Inc., Twirly Twirl Ice Inc., Very Berry Ice Inc., and X B Service Inc. Together with the other Individual Defendants, Tsirkos controls these corporations and the other Corporate Defendants.
- above are located at three depots: (a) 34-37 11th Street, Long Island City, New York, since 1994 owned by non-party Double Eleven Realty Corp.; (b) 31-65 Vernon Boulevard, Long Island City, New York, owned by non-party JAD Partners LLC since June 2012; and (c) 11-16 34th

Avenue, Long Island City, New York, since 2005 owned by Livadi LLC, whose members are defendant Dimitrios Tsirkos and his wife, non-party Nektaria Otta.

- at between \$100 and \$500, far below fair market value for vehicles of their type, age, and condition. As examples, MV-82 forms show below-market valuations in six registrations of the truck with VIN # 1GBHP32WXW3302540 between February 2015 and October 2016. The purported value ranged from (a) \$0 when Fotinakopoulos registered the truck in the name of Ice Mania Inc. in February 2015; (b) \$300 when Vasiadis registered the truck in the name of Umpa Ice Cream Inc. in July 2015; (c) \$199 when Fotinakopoulos registered the truck in the name of Pavema Ice Inc. in September 2015; (d) \$200 when Dalageorgos registered the truck in the name of Calvary Inc. in February 2016; (e) \$250 when Fotinakopoulos registered the truck in the name of Avery Ice Inc. in July 2016; and (f) \$200 when Fotinakopoulos registered the truck in the name of Frizus Ice Inc. in October 2016.
- 127. In addition to the DMV registration form (Form MV-82), New York vehicle sellers are required to provide vehicle buyers with damages disclosure statements on the back of the vehicle's New York State title certificates, printed on the two-sided DMV form identified as Form MV-999. In filing MV-82 forms with the DMV, prospective registrants demonstrate proof of vehicle ownership by providing certificates of title and damages disclosure statements.
- 128. These forms also illustrate that the defendants' scheme has no legitimate business purpose. Thus, for example, in the six above-described registrations between February 2015 and October 2016 of the truck with VIN # 1GBHP32WXW3302540 in paragraph 125, the sellers' damages disclosure statements show the truck was: (a) sold by Astralease Associates,

Inc. to Fotinakopoulos, purportedly as "president" of himself, on January 23, 2015; (b) sold by Fotinakopoulos, supposedly in his personal capacity, 1 to Michael Vasiadis, as vice president of Umpa Ice Cream Inc., on July 8, 2015; (c) sold by Antonio Kostas, as vice president of Umpa Ice Cream Inc., to Fotinakopoulos, as president of Pavema Ice Inc., on September 16, 2015; (d) sold by Tsatsaros, as vice president of Pavema Ice Inc., to Dalageorgos, as president of Calvary Inc. on February 22, 2016; (e) sold by Dalageorgos, as president of Calvary Inc., to Fotinakopoulos, as president of Avery Ice, Inc., on June 28, 2016; and (f) sold by Tsatsaros, as president of Avery Ice Inc., to Fotinakopoulos, as president of Frizus Ice Inc., on October 31, 2016, this despite Fotinakopolous supposedly having purchased the truck four months earlier in his capacity as president of Avery Ice Inc., with no documents filed with the DMV in the interim to report an intervening change in title or registration.

B. 93 Judgment Debtors Have Incurred \$4.47 Million in Parking Judgment Debt Across 76 Separate Ice Cream Trucks, from 2009 to 2017

- 129. The defendants owe \$4,471,754.58 in judgment debt, exclusive of interest, arising from parking violations on 76 ice cream trucks, each having a unique vehicle identification number (VIN), as required by federal law. The defendants' scheme involved repeatedly transferring and re-registering the vehicles for less than fair market value to avoid payment of the judgment debt.
- 130. Table 1 below summarizes the debt incurred by each Corporate Defendant ("Judgment Amount"), the dates between which the underlying parking violations occurred, and the number of trucks (by VIN number) associated with each debtor.

¹ The MV-82 form for the preceding period listed Ice Mania Inc. as the prospective vehicle registrant and title applicant, with Fotinakopolous executing the form on behalf of Ice Mania Inc.

C. The Defendants' Efforts To Interfere With The Collection of City Judgments

- 259. Each Individual Defendant controlled one or more of the Corporate Defendants, and every Corporate Defendant was controlled by one or more Individual Defendants. The Individual Defendants and the Corporate Defendants repeatedly transferred title ownership and/or changed the New York DMV registration for trucks having accumulated parking violation fines, with the intent of frustrating the City's efforts to collect upon the judgments owed by the Corporate Defendants.
- 260. The Individual Defendants caused the Corporate Defendants to be undercapitalized. Knowing that the Corporate Defendants owe the City millions of dollars in parking judgments, the Individual Defendants stripped assets from the Corporate Defendants through the truck transfers.
- 261. Representative examples of post-judgment transfers by the Individual and Corporate Defendants that were intended to interfere with the City's ability to collect the judgments include, but are not limited to, the following:
 - a. As the title owner and registrant for the ice cream truck with VIN # 1GBHP32WXW3302540 (Truck #1), defendant Hongway IceCream Inc. incurred \$19,975.24 in parking ticket violations between April 2012 and October 2012 a roughly six-month period spanning over 100 days during which time the earlier-issued tickets went into judgment status. Before the City could enforce those judgments, the defendants transferred the title ownership and registration for the truck so that by 2013 neither the ownership nor the registration remained in the name of Hongway IceCream Inc.
 - b. As the registrant for the ice cream truck with VIN # 5T4GP41W923343386 (Truck #2), defendant Calvary Inc. incurred \$32,389.15 in parking ticket violations between February 2016 and July 2016 a roughly five-month period spanning over 100 days during which time the earlier-issued tickets went into judgment status. Before the City could enforce those judgments, the defendants transferred the registration for the truck so that by the fall of 2016, defendant Avery Ice Inc. was the registrant rather than Calvary Inc.

- c. As the registrant for the ice cream truck with VIN # 1GDHP32R4X3500193 (Truck #12), defendant Icy Man Inc. incurred \$32,454.31 in parking ticket violations between April 2015 and September 2015 a roughly five-month period spanning over 100 days during which time the earlier-issued tickets went into judgment status. Before the City could enforce those judgments, the defendants transferred the registration for the truck so that by 2016, defendant Anoria Ice Inc. was the registrant rather than Icy Man Inc.
- d. As the title owner and registrant for the ice cream truck with VIN # 1GBHP32KXS3314968 (Truck #15), defendant Kavin Ice Cream Inc. incurred \$37,560.37 in parking ticket violations between March 2013 and August 2013 a roughly five-month period spanning over 100 days during which time the earlier-issued tickets went into judgment status. Before the City could enforce those judgments, the defendants transferred the title ownership and registration for the truck to defendant Gorten Ice Inc. so that by 2014 neither the ownership nor the registration remained in the name of Kavin Ice Cream Inc.
- e. As, respectively, the title owner and registrant for the ice cream truck with VIN # 1GBHP32KXS3314968 (Truck #15), defendants Laroco Inc. and Has Ice Inc. incurred \$28,208.51 in parking ticket violations between April 2015 and September 2015 a roughly five-month period spanning over 100 days during which time the earlier-issued tickets went into judgment status. Before the City could enforce those judgments, the defendants transferred the title ownership and registration for the truck to defendant Hos 214 Inc. so that by 2016 neither the ownership nor the registration remained in the name of Laroco Inc. or Has Ice Inc.
- f. As the title owner and registrant for the ice cream truck with VIN # 1GCJP32J0H3325636 (Truck #21), defendant Ice Mania Inc. incurred \$10,067.66 in parking ticket violations between June 2014 and July 2015 a roughly thirteen-month period spanning well over 100 days during which time the earlier-issued tickets went into judgment status. Before the City could enforce those judgments, the defendants transferred the title ownership and registration for the truck to defendant Cost Ice Inc. so that by late July 2015 neither the ownership nor the registration remained in the name of Ice Mania Inc.
- g. As the title owner and registrant for the ice cream truck with VIN # 1GCJP32J6J3333441 (Truck #25), defendant GeekIce Inc. incurred \$20,389.35 in parking ticket violations between April 2015 and September 2015 a roughly five-month period spanning over 100 days during which time the earlier-issued tickets went into

judgment status. Before the City could enforce those judgments, the defendants transferred the title ownership and registration for the truck to defendant Kiki Services Inc. so that by 2016 neither the ownership nor the registration remained in the name of GeekIce Inc.

h. As the title owner and registrant for the ice cream truck with VIN # 1GBHP32M1E3328442 (Truck #36), defendant Papia I Inc. incurred \$20,100.84 in parking ticket violations between April 2013 and October 2013 — a roughly six-month period spanning over 100 days — during which time the earlier-issued tickets went into judgment status. Before the City could enforce those judgments, the defendants transferred the title ownership and registration for the truck to defendant Hena Ice Inc. so that by 2014 neither the ownership nor the registration remained in the name of Papia I Inc.

D. The Individual Defendants' Liability For The Parking Summonses As Alter Egos of the Corporate Defendants

- 262. The Individual Defendants caused the Corporate Defendants to be incorporated and are their principals and shareholders.
- 263. The Corporate Defendants have no or very few employees. All actions of the Corporate Defendants are carried out by the Individual Defendants.
- 264. The Individual Defendants rarely or never observe corporate formalities with respect to the Corporate Defendants. The Individual Defendants rarely or never hold board meetings or shareholder meetings of the Corporate Defendants.
- 265. The Individual Defendants transfer assets between Corporate Defendants without observing purchase and sale formalities, in non-arms' length transactions and for inadequate consideration.
- 266. The Individual Defendants made no distinction between the Corporate Defendants' funds and the individuals' funds. The Individual Defendants make transfers of money or assets to themselves or their designees from the Corporate Defendants and/or spend corporate funds for non-corporate purposes.

- 267. The Individual Defendants so dominate the Corporate Defendants as to effectively eliminate any legal distinction between the Individual and the Corporate Defendants.
- 268. By misusing the Corporate Defendants in this fashion, the Individual Defendants obtain funds for their personal use by avoiding judgments that the Corporate Defendants would otherwise have had to pay.
- 269. The Corporate Defendants were and are alter egos of the Individual Defendants.
- 270. The Individual Defendants are liable for the Corporate Defendants' debts. The Individual Defendants are liable for their own bad acts and the bad acts of the Corporate Defendants, including tortious interference with the City's collection of parking judgments and for effecting fraudulent transfers under the New York Debtor and Creditor Law because, at all relevant times, the Individual Defendants dominated and controlled the Corporate Defendants.

E. Civil Conspiracy

- 271. The defendants conspired, on behalf of one another, to fraudulently and repeatedly transfer the Corporate Defendants' assets from defendant debtors to other shell corporations and thereby tortiously and intentionally interfere with the City's ability to collect judgments arising from the parking violations that the Corporate Defendants had incurred.
- 272. The Individual and Corporate Defendants, acting collectively by, through, and on behalf of one another, reached a common agreement or understanding to commit tortious acts, including, but not limited to:
 - a. Manipulating the finances of the Corporate Defendants for the purpose of concealing from the City the assets of the Corporate Defendants, thereby impairing the City's ability to collect judgment debt;
 - b. Rendering the Corporate Defendants insolvent and unable to pay judgment debt to the City by fraudulently transferring assets from the Corporate Defendants and otherwise divesting them of assets; and

- c. Deriving income for the personal use of the Individual Defendants that would otherwise have been paid by the Corporate Defendants as the outstanding parking and traffic penalties to the City.
- 273. The defendants' tortious collective activities were knowingly and purposefully designed and were performed in furtherance of the defendants' economic and pecuniary benefit.
- 274. As a result, the defendants are jointly and severally liable to the City for the damages resulting from the conspiracy.

F. Concert of Action

- 275. The defendants, for the benefit of their respective business interests and economic benefit in particular, had an understanding, explicit or tacit, to participate in a common plan or design to commit tortious acts, including, but not limited to:
 - a. Manipulating the finances of the Corporate Defendants for the purpose of concealing from the City the assets of the Corporate Defendants, thereby impairing the City's ability to collect judgment debt;
 - b. Rendering the Corporate Defendants insolvent and unable to pay judgment debt to the City by fraudulently transferring assets from the Corporate Defendants and otherwise divesting them of assets; and
 - c. Deriving income for the personal use of the Individual Defendants that would otherwise have been paid by the Corporate Defendants as the outstanding parking and traffic penalties to the City.
- 276. Each defendant knew or should have known that this understanding to participate in a common plan or design to so manipulate the Corporate Defendants' finances, conceal the assets of the Individual and Corporate Defendants, insulate them from judgment enforcement, and derive income for the Individual Defendants constituted numerous breaches of legal duties, and the defendants gave substantial aid and encouragement, each to the other, to further such common plan or design.

- 277. The defendants assisted and encouraged one another in committing the aforementioned tortious activities and in breaching legal duties, including the duty to pay judgments to the City and impairing the City's rights as a judgment creditor. The conduct of the defendants subjects the City and the public to unreasonable threats to public safety as a consequence of the defendants' flagrant and repeated violations of parking and traffic rules and regulations.
- 278. As a result, the defendants are jointly and severally liable to the City for the damages resulting from their concerted acts.

FIRST CAUSE OF ACTION (Tortious Interference With the Collection of Judgments)

- 279. The City repeats and realleges paragraphs 1 through 278 as if fully set forth herein.
- 280. The defendants willfully and tortiously transferred corporate assets and altered the registrations of corporate vehicles in non-arms' length transactions for less than fair value intending to evade the payment of judgments owed by the Corporate Defendants.
- 281. The City has suffered damages, including but not limited to the amount of the judgments, investigative costs, attorneys' fees as a result of the defendants' interference with the City's judgments, for which the Individual and Corporate Defendants are jointly and severally liable.

SECOND CAUSE OF ACTION (New York Debtor and Creditor Law § 273)

- 282. The City repeats and realleges paragraphs 1 through 278, as if fully set forth herein.
 - 283. The City is a creditor of the Corporate Defendants.

- 284. The repeated conveyances by the defendants of the 76 ice cream trucks that are the subject of this action for less than market value and without fair consideration rendered the Corporate Defendants insolvent.
- 285. Each of the defendants, including each Individual Defendant, was either a transferee or beneficiary of the conveyances, each of which hindered, delayed or defrauded the City as creditor, and for which defendants are jointly and severally liable to the City.
- 286. The City is entitled to judgment against the defendants, including each Individual Defendant, pursuant to Debtor and Creditor Law § 273, setting aside the transfers from any Corporate Defendant to any other defendant, together with incidental damages to be determined at trial.

THIRD CAUSE OF ACTION (New York Debtor and Creditor Law § 274)

- 287. The City repeats and realleges paragraphs 1 through 278, as if fully set forth herein.
 - 288. The City is a creditor of each of the 93 Corporate Defendants.
- 289. The interests of the Corporate Defendants in the 76 ice cream trucks that are the subject of this action were conveyed without fair consideration in the purchase-and-sale transactions that closed between 2013 and 2017.
- 290. The repeated conveyances by the defendants of those 76 ice cream trucks were made when the Corporate Defendants were or were about to engage in a business or transaction for which the property remaining in the hands of the corporations after the conveyance amounted to unreasonably small capital..
- 291. Any and all such conveyances occurring after any judgment owed to the City, are fraudulent as to the City.

292. Each of the defendants, including each Individual Defendant, was a transferee or beneficiary of the fraudulent conveyances, and is jointly and severally liable to the City. The City is entitled to judgment against the defendants, including each Individual Defendant, pursuant to Debtor and Creditor Law § 274, setting aside such transfers from any Corporate Defendant to any other defendant, together with incidental damages to be determined at trial.

FOURTH CAUSE OF ACTION (New York Debtor and Creditor Law § 275)

- 293. The City repeats and realleges paragraphs 1 through 278, as if fully set forth herein.
 - 294. The City is a creditor of the Corporate Defendants.
- 295. The interests of the Corporate Defendants in the 76 ice cream trucks that are the subject of this action were conveyed without fair consideration in the purchase-and-sale transactions that closed between 2013 and 2017.
- 296. At the time the defendants made these purchase-and-sale transactions, the defendants intended, knew, and/or believed, based on the abundant past history of the hundreds of parking and traffic judgments on the 76 ice cream trucks, that the Corporate Defendants would incur debts beyond their ability to pay as the judgments matured.
- 297. Any and all such conveyances occurring after any judgment owed to the City, are fraudulent as to the City.
- 298. Each of the defendants, including each Individual Defendant, was a transferee or beneficiary of the fraudulent conveyances, and is jointly and severally liable to the City.

299. The City is entitled to judgment against the defendants, including each Individual Defendant, pursuant to Debtor and Creditor Law § 275, setting aside such transfers from any Corporate Defendant to any other defendant, together with incidental damages to be determined at trial.

FIFTH CAUSE OF ACTION (New York Debtor and Creditor Law § 276)

- 300. The City repeats and realleges paragraphs 1 through 278, as if fully set forth herein.
 - 301. The City is a creditor of each of the 93 Corporate Defendants.
- 302. The repeated conveyances by the defendants of the 76 ice cream trucks that are the subject of this action for less than market value and without fair consideration were made with actual intent to hinder, delay or defraud the City as creditor.
 - 303. The conveyances are replete with the following badges of fraud:
 - (1) The lack or inadequacy of consideration;
 - (2) The family, friendship or close associate relationship between the parties;
 - (3) The retention of possession, benefit or use of the property in question;
 - (4) The financial condition of the parties sought to be charged both before and after the transaction in question;
 - (5) The existence or cumulative effect of a pattern or series of transactions or course of conduct after the incurring of debt, or pendency or threat of suits by creditors; and

- (6) The general chronology of the events and transactions under inquiry.
- 304. Each of the defendants, including each Individual Defendant, was a transferee or beneficiary of the fraudulent conveyances, and is jointly and severally liable to the City.
- 305. The City is entitled to judgment against the defendants, including each Individual Defendant, pursuant to Debtor and Creditor Law § 276, setting aside the transfers from any Corporate Defendant to any other defendant together with incidental damages to be determined at trial.

SIXTH CAUSE OF ACTION (New York Debtor and Creditor Law § 276-a)

- 306. The City repeats and realleges paragraphs 1 through 305, as if fully set forth herein.
- 307. The defendants' fraudulent conveyances of the 76 ice cream trucks that are the subject of this action were made with the actual intent of the defendants and their transferees to hinder, delay or defraud the City as creditor.
- 308. If the City recovers judgment in this action, the City shall be entitled to an award of attorneys' fees and disbursements incurred in this action pursuant to Debtor and Creditor Law § 276-a, and each of the defendants, including each Individual Defendant, shall be jointly and severally liable to the City for its attorneys' fees and disbursements, in an amount to be determined by the Court.

PRAYER FOR RELIEF

WHEREFORE, the City demands that judgment be entered as follows:

- (a) Ordering that the defendants, each of whom is jointly and severally liable,
- pay the City damages in an amount to be determined at trial for tortiously

interfering with the City's right to collect judgments against the Corporate

Defendants;

(b) Ordering that all of the fraudulent transfers of vehicle ownership and title

made in violation of New York Debtor and Creditor Law §§ 273, 274,

275, and 276 be deemed null and void and set aside, and entering

judgment against the defendants, jointly and severally in the amount of

\$4,471,754.58, plus interest, Sheriff's fees, and costs;

(c) Directing, pursuant to New York Debtor and Creditor Law § 276-a, that

the defendants pay the City's attorneys' fees and disbursements in

connection with this action; and

(d) Granting such other relief as this Court may deem just and proper.
