18 The Orange County District Attorney charges that in Orange
19 County, California, the law was violated as follows:

21 COUNT 1: On or about August 28, 2012, in violation of Section
22 11377(a) of the Health and Safety Code (POSSESSION OF A
23 CONTROLLED SUBSTANCE), a FELONY, NADIA MARIA DAVIS LOCKYER did
24 unlawfully possess methamphetamine, a controlled substance.

25
26 COUNT 2: On or about August 28, 2012, in violation of Section
27 11550(a) of the Health and Safety Code (USE AND UNDER THE
28 INFLUENCE OF A CONTROLLED SUBSTANCE), a MISDEMEANOR, NADIA MARIA
DAVIS LOCKYER did unlawfully use and was under the influence of
a controlled substance known as METHAMPHETAMINE.

30 COUNT 3: On or about August 28, 2012, in violation of Section
31 11364.1(a) of the Health and Safety Code (POSSESSION OF
32 CONTROLLED SUBSTANCE PARAPHERNALIA), a MISDEMEANOR, NADIA MARIA
33 DAVIS LOCKYER did unlawfully possess an opium pipe and a
34 device, contrivance, instrument, and paraphernalia to wit:
35 TUBULAR ALUMINUM FOIL WITH BURNED END, used for unlawfully
36 smoking a controlled substance.

1 COUNT 4: On or about August 28, 2012, in violation of Section
2 273a(b) of the Penal Code (CHILD ABUSE), a MISDEMEANOR, NADIA
3 MARIA DAVIS LOCKYER, under circumstances and conditions other
4 than those likely to produce great bodily harm and death, did
5 willfully and unlawfully injure, cause and permit a child to
suffer, and inflict unjustifiable physical pain and mental
suffering on CHILD DOE, a child.

7 that the foregoing is true and correct.
