The Undersigned, being sworn says, on information and belief, that RICHARD THOMAS did, in the County of Alameda, State of California, on or about November 4, 2013, commit a Felony, to wit: AGGRAVATED MAYHEM, a violation of section 205 of the PENAL CODE of California, in that said defendant(s) did unlawfully and under circumstances manifesting extreme indifference to the physical and psychological well being of another, intentionally cause permanent disability and disfigurement and deprivation of a limb, organ and body member of LUKE FLEISCHMAN.

It is further alleged that the above offense is a violent felony within the meaning of Penal Code section 667.5(c) and that pursuant to Penal Code section 1170(h)(3) an executed sentence for the offenses herein charged shall be served in the state prison.

SPEC ALLEG 16 YEARS OLD MINOR - 707(d) CLAUSE AS TO DEFENDANT RICHARD THOMAS. It is further alleged, pursuant to subdivision (d)(1) of Section 707 of the Welfare and Institutions code, that the defendant was a minor who was at least 16 years of age the time of the commission of the above offenses.

SPEC ALLEG 14 YR OLD MINOR DEATH OR LIFE CURRENT CRIME CLAUSE AS TO DEFENDANT RICHARD THOMAS

It is further alleged, pursuant to subdivision (d)(2)(a) of section 707 of the Welfare and Institutions code, that the defendant was a minor who was at least 14 years of age at the time of the commission of the above offenses.

HATE CRIME CLAUSE AS TO DEFENDANT RICHARD THOMAS

It is further alleged that the defendant RICHARD THOMAS committed the above offense in violation of Penal Code section 422.75(a), in that said offense was a hate crime as defined in Penal Code section 422.55.

SECOND COUNT

The Undersigned further deposes and says on Information and belief, that said RICHARD THOMAS did, in the County of Alameda, State of California, on or about November 4, 2013, commit a Felony, to wit: ASSAULT BY MEANS LIKELY TO PRODUCE GREAT BODILY INJURY, a violation of section 245(a)(4) of the PENAL CODE of California, in that said defendant(s) did willfully and unlawfully commit an assault on LUKE FLEISCHMAN by means of force likely to produce great bodily injury.

"NOTICE: Conviction of this offense will require you to provide specimens and samples pursuant to Penal Code section 296. Willful refusal to provide the specimens and samples is a crime."

GREAT BODILY INJURY CLAUSE AS TO DEFENDANT RICHARD THOMAS

It is further alleged as to count two, that in the commission of the above offense the said defendant RICHARD THOMAS, personally inflicted great bodily injury upon LUKE FLEISCHMAN, not an accomplice to the above offense, within the meaning of Penal Code Section 12022.7(a) and also causing the above offense to become a serious felony within the meaning of Penal Code Section 1192.7(c)(8).

"NOTICE: This offense is a serious felony and a violent felony within the meaning of Penal Code sections 1192.7(c)(8) and 667.5(c)(8)."

HATE CRIME CLAUSE AS TO DEFENDANT RICHARD THOMAS

It is further alleged that the defendant RICHARD THOMAS committed the above offense in violation of Penal Code section 422.75(a), in that said offense was a hate crime as defined in Penal Code section 422.55.

It is further alleged that the above offense is a violent felony within the meaning of Penal Code section 667.5(c) and that pursuant to Penal Code section 1170(h)(3) an executed sentence for the offenses herein charged shall be served in the state prison.

<u>SPEC ALLEG 16 YEARS OLD MINOR - 707(d) CLAUSE AS TO DEFENDANT RICHARD THOMAS</u> It is further alleged, pursuant to subdivision (d)(1) of Section 707 of the Welfare and Institutions code, that the defendant was a minor who was at least 16 years of age the time of the commission of the above offenses.

Pursuant to Penal Code Section 1054.5(b), the People are hereby informally requesting that defendant's counsel provide discovery to the People as required by Penal Code Section 1054.3.
