CURRENT SITUATION

Situation Summary:

Fire suppression repair continues as crews work to restore areas that were constructed to support the fire suppression efforts on the CZU Lightning Complex. The Damage Inspection teams have completed and the number of structures damage and destroyed is final. Hazard mitigation will continue along roadways, adhere to all roadway signs and traffic advisories. As traffic is reintroduced into these areas, people may be distracted by the damage and not be aware of their immediate surroundings. Please use caution when driving. Critical fire weather is expected throughout the week with higher temperatures and low humidities. This may influence fire activity and increase smoke production from the unburned fuels well within the fire perimeter.
