COMPLAINT

NOW COME Plaintiffs, BETTER GOVERNMENT ASSOCIATION ("BGA") and NBC SUBSIDIARY (WMAQ-TV) LLC ("NBC CHICAGO") (collectively "PLAINTIFFS"), by their undersigned attorneys, LOEVY & LOEVY, and bring this suit to remedy CHICAGO PUBLIC SCHOOLS' systematic failure to comply with the Freedom of Information Act. In support of their Complaint, PLAINTIFFS allege:

INTRODUCTION

- 1. This is a complaint under the Illinois Freedom of Information Act ("FOIA"), 5 ILCS 140/1 et seq.
- 2. Pursuant to the fundamental philosophy of the American constitutional form of government, the General Assembly has declared it to be the public policy of the State of Illinois that all persons are entitled to full and complete information regarding the affairs of government and the official acts and policies of those who represent them as public officials and public employees consistent with the terms of the Act. 5 ILCS 140/1.
- 3. Restraints on access to information, to the extent permitted by FOIA, are limited and narrow exceptions to the principle that the people of this state have a right to full disclosure

of information relating to the decisions, policies, procedures, rules, standards, and other aspects of government activity that affect the conduct of government and the lives of the people. *Id*.

- 4. All public records of a public body are presumed to be open to inspection or copying. Any public body that asserts that a record is exempt from disclosure has the burden of proving by clear and convincing evidence that it is exempt. 5 ILCS 140/1.2.
- 5. A public body is required to respond to FOIA requests within five business days, or, when specific criteria are met and the public body properly claims an extension of time within the five-day deadline, within another five business days. 5 ILCS 140/3(d), (e). Failure to respond to a FOIA request in a timely manner constitutes a denial. *Id*.
- 6. If the court determines that a public body willfully and intentionally failed to comply with FOIA, or otherwise acted in bad faith, the court shall impose upon the public body a civil penalty of not less than \$2,500 nor more than \$5,000 for each occurrence. 5 ILCS 14/11(j).
- 7. Under FOIA Section 11(h), "except as to causes the court considers to be of greater importance, proceedings arising under [FOIA] shall take precedence on the docket over all other causes and be assigned for hearing and trial at the earliest practicable date and expedited in every way."
- 8. Defendant CHICAGO PUBLIC SCHOOLS has willfully and intentionally violated FOIA by failing to respond to FOIA requests by BETTER GOVERNMENT ASSOCIATION and NBC CHICAGO for non-exempt records.
- 9. CHICAGO PUBLIC SCHOOLS has systematically failed to comply with FOIA requests in a timely manner and requires Court-supervised remedial changes to correct this systemic failure and achieve the transparency required under FOIA.

PARTIES

- 10. Plaintiff BETTER GOVERNMENT ASSOCIATION ("BGA") is a nonpartisan, Illinois non-profit corporation, whose mission is to educate the **public** about waste, inefficiencies, and corruption in government by acting as a watchdog agency uncovering and exposing this type of activity; to promote respect for the law; and to support public officials in the rightful performance of their duties. BGA was founded in 1923 to protect the integrity of the political process in Chicago.
- 11. Plaintiff NBC SUBSIDIARY (WMAQ-TV) LLC ("NBC CHICAGO") is an NBCUniversal owned and operated television station that has provided continuous local news coverage of the Chicago area for over sixty-five years. NBC Chicago broadcasts over thirty hours of locally produced newscasts each week. The station has received numerous awards for journalism, including awards from the Illinois Broadcaster's Association and a national Emmy Award for Outstanding Regional News coverage.
- 12. Defendant CHICAGO PUBLIC SCHOOLS is a public body located in Cook County, Illinois.

BGA'S FOIA REQUEST AND CHICAGO PUBLIC SCHOOLS' DENIAL

- 13. On April 29, 2014, BGA requested the following records from CHICAGO PUBLIC SCHOOLS: "copies of any and all settlement agreements, severance agreements and termination agreements approved or adopted from Jan. 1, 2013, until present." (Exhibit A)
- 14. All settlement agreements entered into by or on behalf of a public body are public records subject to inspection and copying by the public, provided that exempt information may be redacted. 5 ILCS 140/2.2. All records relating to the obligation, receipt, and use of public funds are public records subject to inspection and copying. 5 ILCS 140/2.5.

- 15. In response on May 6, 2014, CHICAGO PUBLIC SCHOOLS asserted that the request was unduly burdensome under FOIA Section 3(g), erroneously claiming that BGA made a request for "any and all information, without a specified timeframe." (Exhibit B)
- 16. BGA's request plainly sought a specific and discrete set of records for a specific and limited time period—something a public body charged with the education of over 400,000 schoolchildren and an annual budget of over \$5.5 billion should have readily available.
- 17. The same day as CHICAGO PUBLIC SCHOOLS' response, BGA responded: "If you look at our original FOIA request we do have a time frame—we're seeking documents since Jan. 1, 2013. Can you relay how many documents you are dealing with so I can assess the unduly burdensome argument asap?" (Exhibit C)
 - 18. CHICAGO PUBLIC SCHOOLS provided no further response.

NBC CHICAGO'S FOIA REQUEST AND CHICAGO PUBLIC SCHOOLS' DENIAL

- 19. On December 16, 2013, NBC CHICAGO requested the following records from CHICAGO PUBLIC SCHOOLS: "documents sufficient to show (1) a list of Chicago Public School buildings that are currently vacant and/or shuttered; (2) the cost to heat each of these buildings from September 1, 2013 to the present; (3) the cost to provide lighting for each of these buildings from September 1, 2013 to the present; and (4) the cost to provide water for each of these buildings from September 1, 2013 to the present." (Exhibit D)
- 20. On January 3, 2014, well after the five-day deadline to respond, CHICAGO PUBLIC SCHOOLS responded, stating: "Please extend us the courtesy of 6 additional business days to comply." (Exhibit E)

- 21. On January 29, 2014, well after the six additional business days it requested, CHICAGO PUBLIC SCHOOLS stated that it was working on the request and sought an additional three days to respond. (Exhibit F)
- 22. CHICAGO PUBLIC SCHOOLS has failed to provide any further response to NBC CHICAGO's December 16, 2013 request.

CHICAGO PUBLIC SCHOOLS' SYSTEMIC FAILURE TO COMPLY WITH FOIA

- 23. CHICAGO PUBLIC SCHOOLS has engaged in a pattern and practice of delay in responding to FOIA requests.
- 24. In February 2013, the Attorney General's Public Access Counselor issued a binding opinion against CHICAGO PUBLIC SCHOOLS for its failure to respond to a request in a timely and complete manner and its failure even to respond to the Public Access Counselor's request for review, in clear violation of multiple FOIA provisions. (Exhibit G)
- 25. According to records obtained from the Attorney General's Public Access Counselor, from January 2013 to March 2014, CHICAGO PUBLIC SCHOOLS failed to respond to more than 40 different FOIA requests in a timely manner. (Exhibit H)
- 26. Upon information and belief, based upon the recurring pattern of delay indicated by Attorney General records, discovery will further show that CHICAGO PUBLIC SCHOOLS fails to respond to FOIA requests in a timely manner on a consistent basis.
- 27. Despite the strong public interest in timely disclosure of information about CHICAGO PUBLIC SCHOOLS and the clear failure of CHICAGO PUBLIC SCHOOLS to comply with requests in a timely manner, upon information and belief, CHICAGO PUBLIC SCHOOLS devotes only one employee to handle the large volume of FOIA requests it receives,

which is plainly insufficient and amounts to at least a reckless disregard for its obligations under FOIA.

28. There is a strong interest from parents and the general public in transparency into the operation of CHICAGO PUBLIC SCHOOLS, and without Court intervention, CHICAGO PUBLIC SCHOOLS will continue to violate FOIA routinely, as evidenced at least by its continuing violations after the Attorney General's February 2013 binding opinion.

COUNT I – WILLFUL VIOLATIONS OF FOIA

- 29. The above paragraphs are incorporated by reference.
- 30. CHICAGO PUBLIC SCHOOLS is a public body under FOIA.
- 31. The records sought in BGA's request are not exempt.
- 32. The records sought in NBC CHICAGO's request are not exempt.
- 33. CHICAGO PUBLIC SCHOOLS willfully and intentionally violated FOIA by failing to respond to BGA's and NBC CHICAGO's requests.
- 34. CHICAGO PUBLIC SCHOOLS has an ongoing pattern and practice of failing to comply with FOIA in a timely manner.

WHEREFORE, PLAINTIFFS ask that the Court:

- i. in accordance with FOIA Section 11(f), afford this case precedence on the Court's docket except as to causes the Court considers to be of greater importance, assign this case for hearing and trial at the earliest practicable date, and expedite this case in every way;
- ii. declare that CHICAGO PUBLIC SCHOOLS has violated FOIA;
- iii. order CHICAGO PUBLIC SCHOOLS to produce the requested records under FOIA;

- iv. order CHICAGO PUBLIC SCHOOLS to undertake remedial measures under the supervision of this Court to correct its systemic failure to comply with FOIA;
- v. enjoin CHICAGO PUBLIC SCHOOLS from withholding non-exempt public records under FOIA;
- vi. order CHICAGO PUBLIC SCHOOLS to respond to FOIA requests within the required deadline;
- vii. award reasonable attorneys' fees and costs;
- viii. only in the event the Court does not enter systemic injunctive relief, award civil penalties of between \$2,500 and \$5,000 for each willful and intentional failure to comply with FOIA and any other act of bad faith in responding to the requests;
- ix. award such other relief the Court considers appropriate.

FREEDOM OF INFORMATION ACT: Duty to Respond to FOIA Requests

Dear Dr. Kugler and Ms. Daniels:

This binding opinion is issued pursuant to section 9.5(f) of the Freedom of Information Act (FOIA) (5 ILCS 120/9.5(f) (West 2011 Supp.)). For the reasons discussed below, this office concludes that the Chicago Public Schools (CPS) violated sections 3(d) and 9(a) of FOIA (5 ILCS 140/3(d), 9(a) (West 2010)), by failing to respond within five business days after receiving a FOIA request from Dr. John Kugler.

BACKGROUND

On December 19, 2012, Dr. Kugler submitted a FOIA request to CPS's FOIA Officer seeking "access to and copies of the *Emergency Management Plans*" referenced by a CPS official in three news media reports. (Emphasis in original.) The request further stated:

As a result of the recent murders of school children in Newtown, CT we are requesting a list or records identifying all

> documents * * * that show the Board has current and up-to-date Emergency Plans and training for all CPS staff, documents should include, but not be limited to:

1. A list or records identifying all CPS policies regarding emergency plans

2. A list or records identifying all CPS procedures regarding emergency plans

3. A list or records identifying all training logs and documents showing CPS emergency plans

 A list or records identifying all CPS directives and training requirements to local work units regarding showing CPS emergency plans

5. A list or records identifying all documents/posters showing CPS emergency plan contact numbers

6. A list or records identifying all documents showing updated CPS staff organizational chart for CPS emergency reporting

 A list or records identifying any and all other documents that show CPS is in full compliance of laws and regulations regarding emergency plans

8. A list or records identifying all communications requesting that each school perform its annual emergency drill if it hasn't already done so.

9. A list or records identifying all emergency plans which include a scenario for an active shooter. [2]

On December 27, 2012, Dr. Kugler submitted to the Public Access Bureau a copy of his December 19, 2012, FOIA request to CPS and a Request for Review alleging that CPS had failed to respond to his request.³ On January 4, 2013, the Public Access Bureau forwarded a copy of the Request for Review to CPS and asked CPS to provide a "written explanation of its receipt and handling of Dr. Kugler's December 19, 2012, FOIA request. If CPS has responded or issues a response to the FOIA request after receiving this letter, please provide a copy of that response." As of the date of this binding opinion, CPS has not responded to either Dr. Kugler or the Public Access Bureau.

ANALYSIS

"It is a fundamental obligation of government to operate openly and provide public records as expediently and efficiently as possible in compliance with this Act." 5 ILCS 140/1 (West 2010). Under section 1.2 of FOIA (5 ILCS 140/1.2 (West 2010)), "[a]ll records in the custody or possession of a public body are presumed to be open to inspection or copying." Section 3(a) of FOIA (5 ILCS 140/3(a) (West 2010)) provides that "[e]ach public body shall make available to any person for inspection or copying all public records, except as otherwise provided in Section 7 of this Act."

The procedures for responding to a FOIA request are clear. Section 3(b) of FOIA (5 ILCS 130/3(b) (West 2010)) provides that "each public body shall promptly provide, to any person who submits a request, a copy of any public record required to be disclosed by subsection (a) of this Section and shall certify such copy if so requested." Section 3(d) of FOIA further provides:

Each public body shall, promptly, either comply with or deny a request for public records within 5 business days after its receipt of the request, unless the time for response is properly extended under subsection (e) of this Section. Denial shall be in writing as provided in Section 9 of this Act. Failure to comply with a written request, extend the time for response, or deny a request within 5 business days after its receipt shall be considered a denial of the request. A public body that fails to respond to a request within the requisite periods in this Section but thereafter provides the requester with copies of the requested public records may not impose a fee for such copies. A public body that fails to respond to a request received may not treat the request as unduly burdensome under subsection (g).

The facts are undisputed that CPS did not either comply with Dr. Kugler's request, extend the time for response pursuant to section 3(e) of FOIA (5 ILCS 140/3(e) (West 2010)), or deny the request within 5 business days after December 19, 2012, the date of CPS's receipt of the request. CPS's failure to comply with the requisite procedures constitutes a denial of the request. Further, section 9(a) of FOIA provides:

Each public body denying a request for public records shall notify the requester in writing of the decision to deny the request, the reasons for the denial, including a detailed factual basis for the application of any exemption claimed, and the names and titles or positions of each person responsible for the denial. Each notice of denial by a public body shall also inform such person of the right to review by the Public Access Counselor and provide the address and phone number for the Public Access Counselor. Each notice of denial shall inform such person of his right to judicial review under Section 11 of this Act.

Accordingly, by failing to properly respond to Dr. Kugler's December 19, 2012, FOIA request, CPS violated both sections 3(d) and 9(a) of FOIA.

FINDINGS AND CONCLUSIONS

- 1) On December 19, 2012, Dr. John Kugler submitted a FOIA request to CPS seeking information regarding CPS's emergency management plans.
 - 2) CPS did not respond to Dr. Kugler's FOIA request.
- 3) The failure of CPS to comply with Dr. Kugler's request, extend the time for response pursuant to section 3(e) of FOIA, or deny the request in whole or in part within 5 business days constituted a denial of the request under section 3(d) of FOIA. Denial of a request by failing to respond does not comply with the requirements of section 9(a) of FOIA.
- 4) On December 27, 2012, Dr. Kugler submitted a Request for Review of CPS's denial of his FOIA request to the Public Access Counselor. Dr. Kugler's Request for Review was timely filed and otherwise complies with the requirements of section 9.5(a) of FOIA (5 ILCS 140/9.5(a) (West 2011 Supp.)). Therefore, the Attorney General may properly issue a binding opinion with respect to this matter.
- 5) On January 4, 2013, the Public Access Bureau determined that further action was warranted and sent a letter to CPS requesting an explanation of its receipt and handling of Dr. Kugler's December 19, 2012, FOIA request. CPS did not respond to that inquiry or provide any explanation of its basis for failing to comply with the requirements of FOIA.

Therefore, it is the opinion of the Attorney General that CPS has violated sections 3(d) and 9(a) of FOIA by improperly denying Dr. Kugler's request for public records. Accordingly, CPS is hereby directed to take immediate and appropriate action to comply with

this opinion by providing Dr. Kugler with all responsive records, subject only to permissible redactions under section 7 of FOIA (5 ILCS 140/7 (West 2011 Supp.), as amended by Public Acts 97-783, effective July 13, 2012; 97-813, effective July 13, 2012; 97-847, effective September 22, 2012; 97-1065, effective August 24, 2012; 97-1129, effective August 28, 2012). If CPS determines that any portions of the responsive records are exempt from disclosure under section 7, CPS is directed to issue a written partial denial that fully complies with the requirements of section 9(a) of FOIA. Further, CPS is directed to issue timely responses to future FOIA requests by all persons in accordance with section 3(d) of FOIA.

This opinion shall be considered a final decision of an administrative agency for the purposes of administrative review under the Administrative Review Law. 735 ILCS 5/3-101 et seq. (West 2010). An aggrieved party may obtain judicial review of the decision by filing a complaint for administrative review in the Circuit Court of Cook or Sangamon County within 35 days of the date of this decision naming the Attorney General of Illinois and Dr. John Kugler as defendants. See 5 ILCS 140/11.5 (West 2010).

Pursuant to section 9.5(a) of the Freedom of Information (FOIA) (5 ILCS 140/9.5(a) (West 2010)), the Public Access Bureau received a Request for Review concerning a FOIA request submitted by Mr. Craig Mijares to Chicago Public Schools (CPS). On April 5, 2012, Mr. Mijares requested from CPS the "2011 Annual Vendor Name(s) and Annual Payments[,]" and the "2011 Checkbook which should include the Date, Payee and Amount". His Request for Review alleged that CPS did not respond to that request.

On June 18, 2012, the Public Access Bureau forwarded a copy of the Request for Review to CPS and requested a written explanation of its receipt and handling of Mr. Mijares' FOIA request. CPS did not respond. On July 13, 2012, this office sent CPS a second letter directing CPS to respond to our inquiry. CPS did not respond to that letter, either.

Following recent discussions between CPS officials and a representative of this office, CPS responded to the FOIA request on March 26, 2013, by stating that "CPS does not maintain checkbook ledgers. The CPS does not maintain documents responsive to your

request."² CPS subsequently clarified that "CPS has not maintained a checkbook ledger since 2008, when the switch was made to an electronic vendor payment system."³ On April 2, 2013, this office asked CPS to further clarify whether it possesses vendor name and payment information responsive to the first portion of Mr. Mijares' request. On April 3, 2013, CPS furnished responsive records to Mr. Mijares. Those responses resolve Mr. Mijares' complaint that CPS failed to respond to his April 5, 2012, FOIA request.

We note, however, the City did not provide a timely response in accordance with section 3(d) of FOIA (5 ILCS 140/3(d) (West 2010)), which provides, in pertinent part:

Each public body shall, promptly, either comply with or deny a request for public records within 5 business days after its receipt of the request, unless the time for response is properly extended under subsection (e) of this Section. Denial shall be in writing as provided in Section 9 of this Act. Failure to comply with a written request, extend the time for response, or deny a request within 5 business days after its receipt shall be considered a denial of the request.

Mr. Mijares' FOIA request was submitted via e-mail on April 5, 2012, at 5:41 p.m. Therefore, CPS should have extended the time for responding, denied the request, or provided all responsive records by April 13, 2012. CPS did not respond to the request in any manner or provide any records to Mr. Mijares for almost a year despite repeated inquiries by this office. CPS should be mindful of its obligation to issue timely responses to FOIA requests under section 3(d) of FOIA as well as its obligation to respond to this office within 7 business days after receipt of a Request for Review. 5 ILCS 140/9.5(c) (West 2011 Supp.).

The Public Access Counselor has received the Request for Review you submitted pursuant to section 9.5(a) of the Freedom of Information Act (FOIA) (5 ILCS 140/9.5(a) (West 2011 Supp)). In order to file a Request for Review, section 9.5(a) provides that the Request for Review must be filed with the Public Access Counselor in the Office of the Attorney General "[n]ot later than 60 days after the date of the final denial" of the FOIA request by the public body.

Based on the information that you provided to us, you submitted FOIA requests to Chicago Public Schools (CPS) on October 24, 2012, and October 25, 2012. You requested an update on the status of CPS' responses on November 8, 2012, and CPS replied that responses would be issued by November 20, 2012. You requested another update from CPS on November 28, 2012, but apparently did not receive a response. Your Request for Review alleges that as of January 13, 2013, CPS has not responded to your FOIA requests.

Section 3(d) of FOIA (5 ILCS 140/3(d) (West 2010)) provides, in pertinent part:

Each public body shall, promptly, either comply with or deny a request for public records within 5 business days after its receipt of the request, unless the time for response is properly extended under subsection (e) of this Section. Denial shall be in writing as provided in Section 9 of this Act. Failure to comply with a written request, extend the time for response, or deny a request within 5 business days after its receipt shall be considered a denial of the request.

Section 3(e) (5 ILCS 140/3(e) (West 2010)) further provides that "[t]he person making a request and the public body may agree in writing to extend the time for compliance for a period to be determined by the parties. If the requester and the public body agree to an extension, then "a failure by the public body to comply with any previous deadlines shall not be treated as a denial of the request for the records." In the absence of a written agreement between the parties to extend the response time, an "ongoing dialogue between a public body and a requester after the denial of [a] FOIA request [does] not toll the 60-day period for filing a Request for Review." Ill. Att'y Gen. PAC Req. Rev. Ltr. 21607, issued October 4, 2012.

You did not reach a written agreement with CPS to extend its time for responding to your FOIA requests. Thus, CPS effectively denied the FOIA request you submitted on October 24, 2012, by failing to respond by November 1, 2012; CPS denied the FOIA request you submitted on October 25, 2012, by failing to respond by November 2, 2012. You submitted your Request for Review to this office on January 13, 2013, which is more than 60 days after CPS denied your FOIA requests by failing to respond within 5 business days as required by section 3(d) of FOIA. Accordingly, section 9.5(a) precludes this office from reviewing CPS' denials of your FOIA requests.

You may wish to submit another FOIA request to CPS; if CHA issues a denial or denies your request by failing to issue a timely response, you may file a Request for Review with this office respond within 5 business days, you may file a Request for Review with this office "[n]ot later than 60 days after the date" of the denial.



This determination letter is issued pursuant to section 9.5(c) of the Freedom of Information Act (FOIA) (5 ILCS 140/9.5(c) (West 2012)). For the reasons that follow, the Public Access Bureau concludes that no further action is warranted concerning your Request for Review of the Chicago Public Schools' (CPS) response to your FOIA request.

On September 26, 2013, you submitted a FOIA request to CPS seeking copies of its current position file and current list of vendors and contractors. On October 17, 2013, you filed a Request for Review (2013 PAC 26508) with this office, asserting that CPS did not respond to your FOIA request. We forwarded a copy of that Request for Review to CPS and on October 25, 2013, CPS responded by providing you with copies of the requested records.

On October 26, 2013, you sent a follow-up e-mail to CPS, noting that the position file provided by CPS did not include the hire date for each employee and the funding source for each position. On October 28, 2013, Ms. Cassandra Daniels, on behalf of CPS, responded that "[y]our September 26, 2013 request does not seek specific information regarding CPS employee hire dates or funding sources. The CPS provided [its] position file as maintained." You replied, on that same day, contending that you "have position files dating back ten years [and CPS] has purposely left off the information that identifies an individual position (hire date and funding source) in the Chicago Public Schools." On November 6, 2013, you filed this second Request

for Review with the Public Access Bureau, alleging that CPS' October 25, 2013, response is incomplete because CPS did not provide the information you requested on September 26, 2013.

FOIA provides that "all records in the custody or possession of a public body" are open to inspection or copying. 5 ILCS 140/1.2 (West 2012). However, "a requester is entitled only to records that an agency has in fact chosen to create and retain." Yeager v. Drug Enforcement Admin., 678 F.2d 315, 321 (D.C. Cir. 1982). Under section 552(a)(3)(A) of the federal FOIA (5 U.S.C. § 552(a)(3)(A) (2012)) — which is similar to section 3(a) of the Illinois FOIA (5 ILCS 140/3(a) (West 2012)) — an agency must disclose documents if a requester "reasonably describes" the records he or she seeks and complies with applicable rules and procedures. A FOIA request "reasonably describes records if 'the agency is able to determine precisely what records are being requested.' "Kowalczyk v. Dep't of Justice, 73 F.3d 386, 388 (D.C. Cir. 1996), quoting Yeager v. Drug Enforcement Admin., 678 F.2d 315, 326 (D.C. Cir. 1982).

Here, your September 26, 2013, FOIA request specifically sought, in pertinent part, "a copy of the current CPS position file as of August 25, 2013". It is clear from CPS' October 25, 2013, response that it had determined that you were seeking the most recent position file created and maintained by CPS. During a telephone conversation with an Assistant Attorney General in the Public Access Bureau, Ms. Cassandra Daniels, on behalf of CPS, further clarified that it is CPS' customary practice to provide a copy of the Employee Position file as maintained on its website in response to a FOIA request for its position files, except when the requester specifies any additional information he/she wants included in the report. CPS also confirmed for this office that the position file that CPS provided to you is the only current position file maintained by CPS, and that it does not possess a current position file containing the additional fields that you requested. Based on the available information, we conclude that CPS' construction of your September 26, 2013, FOIA request was reasonable and that CPS complied with the requirements of FOIA by providing you with the a copy of the only current position file in its possession. You may wish to submit another FOIA request to CPS for the additional information that you seek.

Failure to comply with a written request, extend the time for response, or deny a request within 5 business days after its receipt shall be considered a denial of the request." (Emphasis added.) 5 ILCS 140/3(d) (West 2012). A Request for Review may be filed with the Public Access Counselor in the Office of the Attorney General "[n]ot later than 60 days after the date of the final denial[]" of the FOIA request by the public body. 5 ILCS 140/9.5(a) (West 2012).

Based on the information you provided, CPS acknowledged receipt of your request on September 30, 2013. Therefore, CPS denied your request by failing to respond to your request by October 7, 2013. You submitted your Request for Review to this office on December 26, 2013. Because you submitted your Request for Review more than 60 days after CPS denied your request, section 9.5(a) precludes this office from reviewing that denial. You may wish to submit a new FOIA request to CPS. If CPS fails to respond to your request within the requisite time period or denies your request for another reason, you may file a Request for Review with this office within 60 days of the denial.
