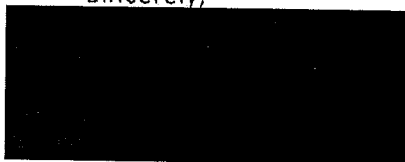

2016 Annual Report to the Illinois Attorney General

In addition to the Campus Annual Security Report, the Illinois Board of Higher Education (IBHE) requires higher education institutions to provide aggregated details concerning the campus policies and procedures for preventing sexual violence on campus. This includes: (1) the college's comprehensive policy; (2) the written notification of a survivor's rights and options; (3) the prevention and awareness programming and training offered; and (4-10) a breakdown of sexual violence incidents reported during the prior calendar year, including steps taken towards resolution. 110 ILCS 205/9.21(b).

There are reporting differences between the two reports. The Annual Security Report provides data relating to crimes that have occurred in a prescribed geographical area surrounding the campus, at properties owned or rented by the campus, or at activities sponsored by the campus. The IBHE aggregated report provides data relating to sexual violence reported during the reporting year where a student is a complainant or respondent. This does not take into account the location of the incident nor the date the incident took place; once the college is made aware of a sexual violence incident, it is included in the report.
