
Dear Sir/Madame:

COMPLAINT PURSUANT TO SECTION 614.023 OF THE
GOVERNMENT CODE OF THE STATE OF TEXAS

The following incidents have occurred and are within the personal knowledge of the undersigned or have been related to them by credible witnesses known by the undersigned to be credible:

1. Corporal Young is currently an FTO but has never gone through FTO School, which places all the liability on the City.

2. Corporal Young left the City with a trainee in his unit to go to a shooting in Fort Worth. He stayed at the shooting scene for two hours even though his assistance wasn't needed or even wanted. The trainee tried to inform dispatch several times but Cpl. Young told him to keep quiet. This incident was told to the Chief and Lt., but no discipline was taken.


3. While walking into I-Hop to eat breakfast Cpl. Young (in full uniform) saw a person he had previously arrested. Cpl. Young with the trainee with him took out his handcuffs and slammed them onto the table in front of the man and said, "You want to go at it again". Cpl. Young used profanity and disturbed the entire restaurant.


4. Corporal Young frequently goes out of the City to the stockyards to eat, without letting dispatch or anyone know that he isn't patrolling the City.


5. Corporal Young berates, belittles, screams, yells and uses profanity at officers he is training, even though he has been counseled about this type of activity by the Lt. On several occasions Cpl. Young has made his trainees get out of the unit and run to the end of a street to get a proper street name even though its over 100 degrees outside.


Because of the above described incidents we file this Complaint and express our lack of confidence in Cpl. Young and the command staff.
