## COMPLAINT PURSUANT TO SECTION 614.023 OF THE GOVERNMENT CODE OF THE STATE OF TEXAS

The following incidents have occurred and are within the personal knowledge of the undersigned or have been related to them by credible witnesses known by the undersigned to be credible:

- 1. Sgt. Milner shot and killed a dog that was on another side of a fence from him even though the animal control officer was there with a tranquilizer gun and the dog was not an immediate threat. Sgt. Milner then had the dog thrown in a dumpster along side city hall. Sgt. Milner never had to attend a disciplinary review board and as far as we know, he was never disciplined.
- 2. Sgt. Milner cut up the floor to a residence even though other options were available to him to apprehend the suspects hiding under the house.
- 3. Sgt. Milner has continually brought criminals into our City by working internet sex stings. One particular sting he gave out a 14 year old victim's address to pedophiles in open chat rooms in order to lure the suspects to her home. This was after he had been ordered to stop performing these types of sting operations by city officials. This child and her grandmother are now at risk of retaliation as some of the pedophiles were known gang members. Sgt. Milner told two officers that he had been chatting with the "Liserio's" and even showed the officers the photographs the gang members had posted in the chat room. Sgt. Milner gave the gang members the 14 year old female's local address a few blocks away from where they lived and tried luring them over to the house in order to make an arrest. This placed and still places the City in a grave liability situation.

- 4. Sgt. Milner continually shows photographs of young under age boys and girls in various stages of dress, not wearing any clothes or performing various sex acts to members of the department even when those members tell him they aren't interested in seeing the photographs.
- 5. Sgt. Milner worked an internal affairs investigation within the fire department that involved naked pictures of a fireman's girlfriend. Sgt. Milner was investigating how and why the nude pictures were being spread around the fire department. Sgt. Milner then showed numerous police officers and dispatchers the nude pictures instead of keeping them confidential.
- 6. Sgt. Milner recently worked a rape case then turned around and showed several officers the pictures of the female victim's injuries to her anus even though the two officers told him they weren't interested in seeing the pictures. Sgt. Milner just turned his computer screen to them and said, "Hey look at this" and showed the officers the photograph.
- 7. During a recent sex sting operation Sgt. Milner was asked if he had a picture of the suspect to which he said, "Sure do" and turned his computer screen to the officers. The computer screen had a single picture of a penis on it.
- 8. Sgt. Milner continually yells, uses profanities at officers, dispatchers and visitors with no repercussions even though the incidents have been witnessed by the Chief of Police.
- 9. Sgt. Milner was heard asking a female dispatcher (McKenzie Kitchen) how his officers ejaculation tasted. His direct quote was, "Hey McKenzie how does Thorne taste". He also told officers, "I asked McKenzie how my officers taste".
- 10. Sgt. Milner asked a female waitress at a restaurant (Williams Ranch House) if her breasts were real or fake. Sgt. Milner was on duty and with two other officers that were embarrassed by his comments, questions and his actions. After she commented he asked if he

could touch them to verify her answer. This incident was report to the Chief of Police by the restaurant's owner.

- 11. Sgt. Milner continually violates suspects' civil rights by stating he doesn't have to read them their Miranda warning as they are only detained and not in custody even though the suspects had been told by other officers they were under arrest and had been in a jail cell for several hours.
- 12. Sgt. Milner continually states that he does the hiring and the firing around the police department and everyone better do as he says.
- 13. Sgt. Miler has made statements that certain officers better learn whose ass to kiss if they want to be promoted.
- 14. Sgt. Milner was driving his unmarked City issued vehicle with a former lieutenant in the passenger seat and a juvenile victim in the back seat. Sgt. Milner was driving excessively fast, ran red lights and stop signs just to return to our police department because he hadn't got a warrant signed property. This put the citizens of other cities and the juvenile at risk as he had no red or blue lights or a siren in this vehicle. (The juvenile was the son of a dispatcher and the violations took place in River Oaks.)
- 15. A female inmate accused Sgt. Milner of inappropriately touching her in a sexual way but Sgt. Milner was allowed to investigate the complaint himself, instead of having an outside agency do the investigation or one of his supervisors do the investigation.
- 16. Sgt. Milner lives outside of Tarrant County but has a City provided take home car, even though policy states he is not to take a car home if he lives outside of Tarrant County.

- 17. Sgt. Milner has violated City policy by being employed by a company that holds a City contract.
  - 18. Sgt. Milner has a belligerent attitude.

Because of the above described incidents we file this Complaint and express our lack of confidence in Sgt. Milner and the command staff.
