NARRATIVE:

Det. Gallagher called into office by Sgr. Reyes. Gallgher met with Sgt. Reyes, Chief Miller and Det. Davison in the homicide office. We then went to Chiefs Browns office and met with him and Chief Perez. Chief Brown advised us that he had received a phone call from Dallas City Councilman Dwaine Caraway. Mr. Caraway advised Chief Brown that he had been in an argument with his wife and was now at a neighbors home. He called Chief Brown seeking advice. After a short discussion with Chief Brown concerning Texas law and Departmental policy. Chief Brown called Mr. Caraway and advised him that he would be sending detectives to his location to follow-up on his phone call . Det. Gallagher, Det Davison, Sgt Reyes, Chief Miller, Chief Perez and Lt. Fite found Mr. Caraway standing on the sidewalk in front of a home at 2003 Southerland St, Dallas, Texas. Mr. Caraway appeared calm and uninjured. He stated that he had argued with his wife who was still in their home around the corner. He believed his wife would be leaving the home and going to her brother's home in Arlington, TX. Mr. Caraway sat in a vehicle with Chief Miller, Sgt Reyes and Det. Davison. Det. Gallagher entered the home at 2003 Southerland St. I spoke with the home owner Ms Vera Williams's phone # 214-948-8466. She advised that she had not seen Mrs. Barbra Mallory Caraway but had spoken to Dwaine Caraway when he came to her home earlier in the evening. She stated that there was no indication from Mr. Caraway that any violence or crime had been committed, only an argument. She did not observe any injuries on Mr. Caraway, Also present in the home was a Mr. George Taylor phone # 713-553-8021. He stated that he was visiting from Houston, TX and had no indication that anything physical had occurred between Barbra and Dwaine Caraway.

Det. Gallagher then spoke with Larry Mallory phone # 972-951-7517, home address 3718 Wentworth Ct. Arlington, TX. He identified himself as the brother of Barbra Mallory Caraway and the brother-in-law of Dwaine Caraway. He stated that he received a phone call from his sister Barbra Caraway and she told him she had been in an argument with her husband Dwaine Caraway. She asked him to drive to her home in Dallas. Upon his arrival Dwaine Caraway was in a neighbor's house and he spoke to his sister Barbra in her home. He described the argument between Barbra and Dwaine Caraway as "child like". He also said he was sure that no violence or physical altercation had occurred between Barbra and Dwaine. I asked to speak with Barbra Caraway but he said she was upset and embarrassed that Dwaine had called the police. He did not believe she would talk to the police. I requested that he ask he again as it was important that I speak with Barbara Caraway in person. Several minutes later Larry Mallory drove up to the front of 2003 Southland St with Barbra Mallory in his vehicle. Det. Gallagher spoke with Barbra Caraway on the sidewallShe had no visible injury and said she had no physical confrontation with her husband Dwaine Caraway. She said she had an argument with him and was going to spend the night at her brother's home in Arlington, TX. She said she did not request nor need any police action.

NARRATIVE:

On 1-2-11 at 8:15 PM I was contacted by Chief David Brown via the phone concerning a domestic incident that had occurred involving D. Caraway and his wife (Barbara). I contacted Lt Fite who stated that she was working command presence and was in uniform at SE. I then contacted Sgt. Reyes and requested that he and the on-call dets meet me at HQ.

Upon arrival at HQ, myself, Sgt Reyes, Det Gallagher, Det Davidson and Chief Perez met Chief Brown in his conf room on 6. Chief Brown relayed that Mr. Caraway had called him from his residence stating that he and his wife were involved in a altercation. Chief Brown asked that SIU investigate this incident and for us to take whatever action was proper with regards to handling this call. Chief Brown gave us a phone # for Barbara and asked us to call her to ensure she was not injured.

We then went back to Sgt Reves Office and called the # Chief Brown had given us and spoke with Barbara and her brother who stated that she was not injured and they did not want to speak with DPD and further she would not open the door if we came to her house. then spoke over the phone with Mr. Caraway who said he would meet us at Lanark St/Southerland. Eventually, we (Chief Perez, Lt Fite, Eugene, Little John, Gallagher, myself) met Mr. Caraway in front of a neighbor's house just a few houses from his residence. It was cold outside so Mr. Caraway got into the car with Eugene, Little John and myself to discuss what had transpired between he and his wife. Mr. Caraway said his wife was about to start baking and removed several aprons of his that she was going to throw away. DC said he didn't want them removed and she became very angry and upset with him. Fearing that the disturbance was going to escalate DC retreated to a room where there was a door between them both. He held his leg against the door along with is arm to brace her from coming into that room. While he was in this position they talked through door and at some point she ran the blade of a knife through a small crack that separated the 2 doors. Barbara never struck DC with the knife and he did not believe that was her intent. While in this room DC called several people including Chief Brown to make him aware of what was going on.

This incident began at approx. 7:30 PM just after the Cowboy game had ended and several of their friends had departed. Chief Brown was contacted at approx. 8 PM and then phoned me at about 8:15 P.

After DC relayed this story to us in the car, Barbara left their house with her brother who was taking her back to his residence in Arlington. As her vehicle was leaving, Barbara got out of the truck so that Det. Gallagher and I could see that she was not injured. Det Gallagher actually stood peside her as this only lasted approx 10 seconds. We then drove DC to his residence where he showed us everything he had relayed to us earlier in the car.

After speaking with DC and observing no injuries to Barbara we determined that no actual offense had occurred. Both DC and Barbara both told us they did not wish to pursue any charges as neither of them was injured and everything was OK. On 1-3-11 an MIR #1970-Y was generated by Det Davidson documenting this incident.
