The DULS_USERS table allows for user names up to 40 characters, but the variable in the stored proc itself is only set at 30. One of the names the procedure was struggling with was XXXX which contains a whopping 31 characters. My guess is that the USER_NAME field in the DULS_USERS table was expanded to 40 characters some time ago, but the change never made it down to the workflow search. The temporary workaround here is to make sure user names don't exceed 30 characters, but for a long term fix a CR and a patch request would need to be added to modify the search to extend the variables.
