With 1:43 left in the 3rd period Minnehaha's [redacted] picked up the puck and went behind her offensive net. She lost control of the puck and turned to pick it up. At that time a dark player moved from the front of the net to make a play on the loose puck. As dark got close to the play the puck was played from behind the net to the front of the net. Dark player pivoted to move with play to the front of the net. At that time [redacted] with fell where she was standing. She was not contacted illegally, did not fall into the boards and did not appear to fall awkwardly to the ice. An immediate scoring opportunity took place then play was stopped. Following the stoppage I consulted my partner, the linesman, the EMT on staff and the Minnehaha AD as to what they saw and everyone agreed that the player appeared to fall unaided. Following the player being taken from the ice both teams agreed say a prayer at center ice and call the game. Overall the game was a very clean with a penalty shot being granted to Minnehaha in the second period that was not successful and 3 or 4 other minor penalties for tripping and hooking.
