12 RC: Ramsey County dispatch.

14 Dispatch: Hey, this is [inaudible], I've been calling you guys about my son! You guys [inaudible] can you please send the cops over there? Please?

17 RC: What address ma'am?

19 Caller: He's got something in his hand, and he's ...

21 RC: Ma'am I need you to calm ... I need you to try to calm down and give the address in [inaudible], okay?

24 Caller: And, and, and, and I, I told you guys it was [inaudible]. I can't, I can't, I can't ... [inaudible]

27 RC: I wasn't the one you spoke with. You need to tell me again.

29 Caller: It's 657 Can, "Cantoo ...," "Cantoon" right off of Seventh Street. They were over there earlier, ma'am. You got all this and put your information ... Could you please hurry up ...

33 RC: Ma'am?

35 Caller: I'm on my way but I'm not gonna make it!

37 RC: Did you say it's 657 Canton Street?

39 Caller: Yeah! Please! Please! [Crying]

41 RC: And you said he had something in ...

43 Caller: Oh, God, I'm not gonna make it!

45 RC: Listen, you said he had something in his hand?

47 Caller: Yes. They just called. They're fucking fighting or something. But the guy, he's  
48 got something in his hand. They can't get it; they can't fucking stop him.

50 RC: Do you know what he has in his hand?  
51  
52 Caller: Ma'am! I do not know! Please, please!  
53  
54 RC: Who ... okay ... but ...  
55  
56 Caller: I don't know. I know ...  
57  
58 RC: Ma'am ...  
59  
60 Caller: ... you have to ask these questions but I don't know.  
61  
62 RC: I, I understand. It's okay. Who told you that he has something in his hand?  
63  
64 Caller: [Crying, inaudible] Somebody, I don't know. I think it was Darlene, but  
65 somebody called my number and I heard screaming. And they go, I go, 'Well, is  
66 Philip going to be okay?' and they go, 'No, he's in the house. He got something in  
67 his hand.' And I yelled at, and I told them, 'Go get him, go help him. He can't ...  
68 . Help me. Please, do you have the cops on their way?

70 RC: Well, we have a call in process, but I'm updating some of the information you're  
71 giving me here.

73 Caller: [Inaudible, crying] Fuck.  
74  
75 RC: Do you have the phone number of anyone who is on scene with him?  
76  
77 Caller: Ooh, fuck. I can't do that. I don't know. I'm driving.  
78  
79 RC: Okay, well it would be helpful and would ... it might expedite police getting there  
80 if I can talk to someone on-scene.  
81  
82 Caller: Okay, it's [REDACTED] yeah.  
83  
84 RC: And so a 651 area code?  
85  
86 Caller: They're the one to call. It's 651.  
87  
88 RC: And you don't know who's ... It might be Darlene's?  
89  
90 Caller: Yeah. I don't know. Darlene's or Christie's or somebody like that. One of his  
91 friend's.

93 RC: Okay. I'm updating the officers and I'm also going to call them to get some more  
94 information, okay? So we'll have someone out there in just a second ...  
95  
96 Caller: Have you got the cops on their way, though?  
97  
98 RC: Um, not yet, but updating ...  
99  
100 Caller: Please send the cops!  
101  
102 RC: [Inaudible]  
103  
104 Caller: I'm gonna hang up on you!  
105  
106 RC: We have a call [inaudible] already. Like I said, I'm updating them and I'm gonna  
107 get more information from the friend. So we'll have them out there as soon as we  
108 can.
