**911** – Who pepper sprayed her?

**Male Caller** – Yep, her knees are skun up. She said she tried to rape him. She's missing shoes. Should I go in there and look around?

**911** – No. All right, we've got someone going over there.

**Male Caller** – Okay, okay.

**911** – Is it attempted rape?

**Male Caller** – Ah yes.

**911** – Okay, does she have any description on the person?

**Male Caller** – Do you have any description at all? (redacted) is his name.
