FACTUAL CIRCUMSTANCES SURROUNDING ARREST OR INCIDENT:

On 10-05-2011 at approximately 1306 hours, Officer Uhrich was traveling on Marysville Road southbound, south of Dolan Harding Road, in unincorporated Yuba County. Officer Uhrich encountered a white 1999 Plymouth Breeze that was stopped on the west shoulder of the roadway. Officer Uhrich observed a white female standing outside of the vehicle on the driver's side. He inquired if she needed assistance and she that she was stretching. Officer Uhrich pulled away and remembered a vehicle broadcasted from his Dispatch (BOL) of a stolen vehicle with Oregon plates, occupied by a male and female. The occupants were wanted out of Oregon and Washington states for homicide and considered armed and dangerous. Officer Uhrich turned around and passed the vehicle again. As he passed, he observed the vehicle's license plate, 025CCH and he requested dispatch to re-advise of the BOL vehicle. He turned around again and took position behind the vehicle, which was now traveling southbound. He was advised of of the vehicle plate and affirmed that it was the same. Officer Uhrich followed the vehicle and requested back-up. After approximately two miles, with the Plymouth driving slowly knowing the patrol vehicle was behind it, turned right onto Getties Court. Officer Uhrich initiated a felony stop and the subjects were taken into custody without incident.

NON-RELEASABLE INFORMATION:

- 1. Identity of suspect prior to arrest.
- 2. Results of investigating procedures prior to arrest.
 - Items 1 & 2 can be released if:
 - · will aid in arrest
 - will aid in investigation
 - will warn public of danger
- Investigative procedures involving officer involved shootings or other personnel actions.
- 4. Prior criminal record, reputation or character of suspect.
- 5. Identity of any personal information of a juvenile arrestee or suspect.
- Confession or existence of a confession.

- 7. The Officers opinion of a possible plea bargain.
- 8. Any photographs or mug shots except:
 - will aid in arrest
 - will aid in investigation
 - will warn public of danger
- 9. The identity, credibility, or testimony of prospective witnesses.
 - Any personal opinion as to the suspects guilt, innocence, or merits of the case.
 - Any information that would be known to be inadmissible in court.
 - References to investigative procedures such as fingerprints, polygraph tests, or ballistic tests.

* Juvenile arrest information relating to a collision cannot be disclosed.

*NOTE: Information on juvenile in custody arrests or detentions is not subject to disclosure to the public. Such disclosures are limited to other enforcement agencies or persons or agencies having a legitimate official need for purposes of official disposition of the case.
