I, the undersigned, say, on information and belief, that in the County of Yolo, State of California:

Count 1: On or about and between July 26, 1999 and September 11, 1999, JUSTIN PRENTICE MOREJOHN did commit a FELONY, namely, a violation of Section 288(a) of the California Penal Code, LEWD OR LASCIVIOUS ACT UPON CHILD UNDER FOURTEEN, in that JUSTIN PRENTICE MOREJOHN did willfully, unlawfully and lewdly commit a lewd and lascivious act upon and with the body and certain parts and members thereof of a child under the age of fourteen years, to wit, Child Doe #1 - age 13, with the intent of arousing, appealing to and gratifying the lust,

passions and sexual desires of JUSTIN PRENTICE MOREJOHN and such child.

Count 2: On or about and between July 26, 1999 and December 5, 1999, JUSTIN PRENTICE MOREJOHN did commit a FELONY, namely, a violation of Section 288(a) of the California Penal Code, LEWD OR LASCIVIOUS ACT UPON CHILD UNDER FOURTEEN, in that JUSTIN PRENTICE MOREJOHN did willfully, unlawfully and lewdly commit a lewd and lascivious act upon and with the body and certain parts and members thereof of a child under the age of fourteen years, to wit, Child Doe #2 - age 10, with the intent of arousing, appealing to and gratifying the lust, passions and sexual desires of JUSTIN PRENTICE MOREJOHN and such child.

Count 3: On or about and between December 6, 1999 and March 5, 2000, JUSTIN PRENTICE MOREJOHN did commit a FELONY, namely, a violation of Section 288(a) of the California Penal Code, LEWD OR LASCIVIOUS ACT UPON CHILD UNDER FOURTEEN, in that JUSTIN PRENTICE MOREJOHN did willfully, unlawfully and lewdly commit a lewd and lascivious act upon and with the body and certain parts and members thereof of a child under the age of fourteen years, to wit, Child Doe #2 - age 11, with the intent of arousing, appealing to and gratifying the lust, passions and sexual desires of JUSTIN PRENTICE MOREJOHN and such child.

Count 4: On or about and between March 6, 2000 and June 5, 2000, JUSTIN PRENTICE MOREJOHN did commit a FELONY, namely, a violation of Section 288(a) of the California Penal Code, LEWD OR LASCIVIOUS ACT UPON CHILD UNDER FOURTEEN, in that JUSTIN PRENTICE MOREJOHN did willfully, unlawfully and lewdly commit a lewd and lascivious act upon and with the body and certain parts

and members thereof of a child under the age of fourteen years, to wit, Child Doe #2 - age 11, with the intent of arousing, appealing to and gratifying the lust, passions and sexual desires of JUSTIN PRENTICE MOREJOHN and such child.

Count 5: On or about and between June 6, 2000 and September 5, 2000, JUSTIN PRENTICE MOREJOHN did commit a FELONY, namely, a violation of Section 288(a) of the California Penal Code, LEWD OR LASCIVIOUS ACT UPON CHILD UNDER FOURTEEN, in that JUSTIN PRENTICE MOREJOHN did willfully, unlawfully and lewdly commit a lewd and lascivious act upon and with the body and certain parts and members thereof of a child under the age of fourteen years, to wit, Child Doe #2 - age 11, with the intent of arousing, appealing to and gratifying the lust, passions and sexual desires of JUSTIN PRENTICE MOREJOHN and such child.

Count 6: On or about and between September 6, 2000 and December 5, 2000, JUSTIN PRENTICE MOREJOHN did commit a FELONY, namely, a violation of Section 288(a) of the California Penal Code, LEWD OR LASCIVIOUS ACT UPON CHILD UNDER FOURTEEN, in that JUSTIN PRENTICE MOREJOHN did willfully, unlawfully and lewdly commit a lewd and lascivious act upon and with the body and certain parts and members thereof of a child under the age of fourteen years, to wit, Child Doe #2 - age 11, with the intent of arousing, appealing to and gratifying the lust, passions and sexual desires of JUSTIN PRENTICE MOREJOHN and such child.

Count 7: On or about and between December 6, 2000 and March 5, 2001, JUSTIN PRENTICE MOREJOHN did commit a FELONY, namely, a violation of Section 288(a) of the California Penal Code, LEWD OR LASCIVIOUS ACT UPON CHILD UNDER FOURTEEN, in that

JUSTIN PRENTICE MOREJOHN did willfully, unlawfully and lewdly commit a lewd and lascivious act upon and with the body and certain parts and members thereof of a child under the age of fourteen years, to wit, Child Doe #2 - age 12, with the intent of arousing, appealing to and gratifying the lust, passions and sexual desires of JUSTIN PRENTICE MOREJOHN and such child.

Count 8: On or about and between March 6, 2001 and June 5, 2001, JUSTIN PRENTICE MOREJOHN did commit a FELONY, namely, a violation of Section 288(a) of the California Penal Code, LEWD OR LASCIVIOUS ACT UPON CHILD UNDER FOURTEEN, in that JUSTIN PRENTICE MOREJOHN did willfully, unlawfully and lewdly commit a lewd and lascivious act upon and with the body and certain parts and members thereof of a child under the age of fourteen years, to wit, Child Doe #2 - age 12, with the intent of arousing, appealing to and gratifying the lust, passions and sexual desires of JUSTIN PRENTICE MOREJOHN and such child.

Count 9: On or about and between June 6, 2001 and September 5, 2001, JUSTIN PRENTICE MOREJOHN did commit a FELONY, namely, a violation of Section 288(a) of the California Penal Code, LEWD OR LASCIVIOUS ACT UPON CHILD UNDER FOURTEEN, in that JUSTIN PRENTICE MOREJOHN did willfully, unlawfully and lewdly commit a lewd and lascivious act upon and with the body and certain parts and members thereof of a child under the age of fourteen years, to wit, Child Doe #2 - age 12, with the intent of arousing, appealing to and gratifying the lust, passions and sexual desires of JUSTIN PRENTICE MOREJOHN and such child.

Count 10: On or about and between September 6, 2001 and December 5, 2001, JUSTIN PRENTICE MOREJOHN did commit a FELONY,

namely, a violation of Section 288(a) of the California Penal Code, LEWD OR LASCIVIOUS ACT UPON CHILD UNDER FOURTEEN, in that JUSTIN PRENTICE MOREJOHN did willfully, unlawfully and lewdly commit a lewd and lascivious act upon and with the body and certain parts and members thereof of a child under the age of fourteen years, to wit, Child Doe #2 - age 12, with the intent of arousing, appealing to and gratifying the lust, passions and sexual desires of JUSTIN PRENTICE MOREJOHN and such child.

Case Enhancement a: It is further alleged that JUSTIN PRENTICE MOREJOHN is a person described in Section 667.61(b) of the California Penal Code, ENHANCEMENT FOR SEXUAL OFFENDERS, in that the offenses described above in Counts One and two through ten were committed under one of the circumstances specified in Section 667.61(e) of the California Penal Code, specifically Section 667.61(e)(5).

Case Enhancement b: Notice pursuant to Penal Code Section 1170(h)(3), 1170(f) or other statutes, JUSTIN PRENTICE MOREJOHN is not eligible to be sentenced to a term of county imprisonment, on an executed sentence, due to a prior or current conviction, sentence enhancement, or because he or she is required to register as a sex offender. This allegation is not
