COMPLAINT

I, the undersigned, say, on information and belief, that in
the County of Yolo, State of California:

Count 1 : On or about and between July 26, 1999 and
September 11, 1999, JUSTIN PRENTICE MOREJOHN did commit a
FELONY, namely, a violation of Section 288(a) of the California
Penal Code, LEWD OR LASCIVIOUS ACT UPON CHILD UNDER FOURTEEN, in
that JUSTIN PRENTICE MOREJOHN did willfully, unlawfully and
lewdly commit a lewd and lascivious act upon and with the body
and certain parts and members thereof of a child under the age
of fourteen years, to wit, Child Doe #1 - age 13, with the
intent of arousing, appealing to and gratifying the lust,

1 passions and sexual desires of JUSTIN PRENTICE MOREJOHN and such
2 child.

3 Count 2 : On or about and between July 26, 1999 and
4 December 5, 1999, JUSTIN PRENTICE MOREJOHN did commit a FELONY,
5 namely, a violation of Section 288(a) of the California Penal
6 Code, LEWD OR LASCIVIOUS ACT UPON CHILD UNDER FOURTEEN, in that
7 JUSTIN PRENTICE MOREJOHN did willfully, unlawfully and lewdly
8 commit a lewd and lascivious act upon and with the body and
9 certain parts and members thereof of a child under the age of
10 fourteen years, to wit, Child Doe #2 - age 10, with the intent
11 of arousing, appealing to and gratifying the lust, passions and
12 sexual desires of JUSTIN PRENTICE MOREJOHN and such child.

13 Count 3 : On or about and between December 6, 1999 and
14 March 5, 2000, JUSTIN PRENTICE MOREJOHN did commit a FELONY,
15 namely, a violation of Section 288(a) of the California Penal
16 Code, LEWD OR LASCIVIOUS ACT UPON CHILD UNDER FOURTEEN, in that
17 JUSTIN PRENTICE MOREJOHN did willfully, unlawfully and lewdly
18 commit a lewd and lascivious act upon and with the body and
19 certain parts and members thereof of a child under the age of
20 fourteen years, to wit, Child Doe #2 - age 11, with the intent
21 of arousing, appealing to and gratifying the lust, passions and
22 sexual desires of JUSTIN PRENTICE MOREJOHN and such child.

23 Count 4 : On or about and between March 6, 2000 and June 5,
24 2000, JUSTIN PRENTICE MOREJOHN did commit a FELONY, namely, a
25 violation of Section 288(a) of the California Penal Code, LEWD
26 OR LASCIVIOUS ACT UPON CHILD UNDER FOURTEEN, in that JUSTIN
27 PRENTICE MOREJOHN did willfully, unlawfully and lewdly commit a
28 lewd and lascivious act upon and with the body and certain parts

1 and members thereof of a child under the age of fourteen years,
2 to wit, Child Doe #2 - age 11, with the intent of arousing,
3 appealing to and gratifying the lust, passions and sexual
4 desires of JUSTIN PRENTICE MOREJOHN and such child.

5 Count 5 : On or about and between June 6, 2000 and
6 September 5, 2000, JUSTIN PRENTICE MOREJOHN did commit a FELONY,
7 namely, a violation of Section 288(a) of the California Penal
8 Code, LEWD OR LASCIVIOUS ACT UPON CHILD UNDER FOURTEEN, in that
9 JUSTIN PRENTICE MOREJOHN did willfully, unlawfully and lewdly
10 commit a lewd and lascivious act upon and with the body and
11 certain parts and members thereof of a child under the age of
12 fourteen years, to wit, Child Doe #2 - age 11, with the intent
13 of arousing, appealing to and gratifying the lust, passions and
14 sexual desires of JUSTIN PRENTICE MOREJOHN and such child.

15 Count 6 : On or about and between September 6, 2000 and
16 December 5, 2000, JUSTIN PRENTICE MOREJOHN did commit a FELONY,
17 namely, a violation of Section 288(a) of the California Penal
18 Code, LEWD OR LASCIVIOUS ACT UPON CHILD UNDER FOURTEEN, in that
19 JUSTIN PRENTICE MOREJOHN did willfully, unlawfully and lewdly
20 commit a lewd and lascivious act upon and with the body and
21 certain parts and members thereof of a child under the age of
22 fourteen years, to wit, Child Doe #2 - age 11, with the intent
23 of arousing, appealing to and gratifying the lust, passions and
24 sexual desires of JUSTIN PRENTICE MOREJOHN and such child.

25 Count 7 : On or about and between December 6, 2000 and
26 March 5, 2001, JUSTIN PRENTICE MOREJOHN did commit a FELONY,
27 namely, a violation of Section 288(a) of the California Penal
28 Code, LEWD OR LASCIVIOUS ACT UPON CHILD UNDER FOURTEEN, in that

1 JUSTIN PRENTICE MOREJOHN did willfully, unlawfully and lewdly
2 commit a lewd and lascivious act upon and with the body and
3 certain parts and members thereof of a child under the age of
4 fourteen years, to wit, Child Doe #2 - age 12, with the intent
5 of arousing, appealing to and gratifying the lust, passions and
6 sexual desires of JUSTIN PRENTICE MOREJOHN and such child.

7 Count 8 : On or about and between March 6, 2001 and June 5,
8 2001, JUSTIN PRENTICE MOREJOHN did commit a FELONY, namely, a
9 violation of Section 288(a) of the California Penal Code, LEWD
10 OR LASCIVIOUS ACT UPON CHILD UNDER FOURTEEN, in that JUSTIN
11 PRENTICE MOREJOHN did willfully, unlawfully and lewdly commit a
12 lewd and lascivious act upon and with the body and certain parts
13 and members thereof of a child under the age of fourteen years,
14 to wit, Child Doe #2 - age 12, with the intent of arousing,
15 appealing to and gratifying the lust, passions and sexual
16 desires of JUSTIN PRENTICE MOREJOHN and such child.

17 Count 9 : On or about and between June 6, 2001 and
18 September 5, 2001, JUSTIN PRENTICE MOREJOHN did commit a FELONY,
19 namely, a violation of Section 288(a) of the California Penal
20 Code, LEWD OR LASCIVIOUS ACT UPON CHILD UNDER FOURTEEN, in that
21 JUSTIN PRENTICE MOREJOHN did willfully, unlawfully and lewdly
22 commit a lewd and lascivious act upon and with the body and
23 certain parts and members thereof of a child under the age of
24 fourteen years, to wit, Child Doe #2 - age 12, with the intent
25 of arousing, appealing to and gratifying the lust, passions and
26 sexual desires of JUSTIN PRENTICE MOREJOHN and such child.

27 Count 10 : On or about and between September 6, 2001 and
28 December 5, 2001, JUSTIN PRENTICE MOREJOHN did commit a FELONY,

1 namely, a violation of Section 288(a) of the California Penal
2 Code, LEWD OR LASCIVIOUS ACT UPON CHILD UNDER FOURTEEN, in that
3 JUSTIN PRENTICE MOREJOHN did willfully, unlawfully and lewdly
4 commit a lewd and lascivious act upon and with the body and
5 certain parts and members thereof of a child under the age of
6 fourteen years, to wit, Child Doe #2 - age 12, with the intent
7 of arousing, appealing to and gratifying the lust, passions and
8 sexual desires of JUSTIN PRENTICE MOREJOHN and such child.

9 Case Enhancement a : It is further alleged that JUSTIN
10 PRENTICE MOREJOHN is a person described in Section 667.61(b) of
11 the California Penal Code, ENHANCEMENT FOR SEXUAL OFFENDERS, in
12 that the offenses described above in Counts One and two through
13 ten were committed under one of the circumstances specified in
14 Section 667.61(e) of the California Penal Code, specifically
15 Section 667.61(e)(5).

16 Case Enhancement b : Notice pursuant to Penal Code Section
17 1170(h)(3), 1170(f) or other statutes, JUSTIN PRENTICE MOREJOHN
18 is not eligible to be sentenced to a term of county
19 imprisonment, on an executed sentence, due to a prior or current
20 conviction, sentence enhancement, or because he or she is
21 required to register as a sex offender. This allegation is not


