Just so were real clear as of today I've not received a dime.

I have other inmates writing me wanting to know if I get any money, for they know where victim's are as well. I'm just telling them the truth no don't do it its funny last three times I'll try to call Leonard no one takes my call, I know if he's not in the office, it rings over to his cell phone. This is what I have \$10,000.00 RESTITUTION fine, when I first got to prison they took 20% of any money sent to me, then they raised it to 55% so I only get \$45. out of every hundred, so I said piss on this, I stopped having money sent to me.

You want to know how many victims Herzog and [REDACTED] have, multiple 24x3. This is what I was told by Herzog. I plan to move forward while Leonard and our deal is completed/Kept, otherwise I'll find someone else to work with. one thing you'll learn about me is I'm a man of my word, when I'm not around, which I've been clean of for 13 years.

Justin a cousin of mine from Modesto said how I beat him, what a bunch of shit, his Dad Frankly got me really started in the drugs at a young age, my mom & Dad raised his sisters three sons Tony, Frankly, Bobby, when that side of the family weren't allowed to keep burning money. Then we were no good. I've never used a needle with drugs, so Justin don't know anything, he just went on T.V.

I'm the only one that's willing in the future to help recover Herzogs & Jasons other victim. were not done yet. I gave three areas, each one held victims, when people thought I just wanted to go on sending drive, Steven Moore looks like a real ass. That dig they just crushed all them bones, there was no cell for all that. They could have dug 5' feet away from well, they broke threw at the bottom. This is why Stockton, upon Modesto have so many missing people. because it is by dumb luck they come across a body. I even

The reason I set a agreement for certain amount  
with Leonard, was first To pay my RESTITUTION  
off, get my parents a headstone and have it placed  
at the family plot. my parents were cremated but  
I still want To leave a marker for them.

I wanted To put 5 Thousand in a account for my  
grandson, Then he can have it at age of graduation.  
if he does not graduate Then it goes To his  
father. I wanted some money To live on, and for  
my own burial. some personal things, Typewriter  
new CD/Player, CD's, T.V., clothing, food.  
inmates are allowed \$220.00 store each month.

They have food drives as fund raisers. yes like  
I could order a pizza from outside the prison.  
They do things To raise money for different  
groups.

I want To get my life down on paper before I  
die, I've already been made famous, for all the  
wrong reasons. Tonight was the first time I talked  
To my grandson, it was so great. when I die, I want  
To be cremated and pourd out behind evergreen ledge  
it has special meaning To me. well that's it for now.
