**AFFIDAVIT IN SUPPORT OF ARREST WARRANT**

Proof by affidavit consisting of seven (7) pages I, Detective Steven Anderson, of the Modesto Police Department, do hereby declare:

That I have reviewed the involved agency's investigative reports, and that I am therefore informed and believe and thereupon allege:

That the defendant, HOOKER, James Christopher, DOB: 05/02/1970 is described as a White male adult, 5'8", 188 pounds, blonde hair, blue eyes, California Driver's license number C6403915.

That the defendant has not been previously located, arrested, or booked on the within described offenses:

288a(b) (1) P.C. Oral Copulation with a Minor Under 18 Years Old

**SUMMARY:**

On 03/28/12 Your affiant received a phone message from a 31 year old confidential victim (CV). The message stated she had some information regarding James HOOKER. CV said she wished to share this information with me. I returned CV's phone call. CV said when she was seventeen (17) years old, during the summer of 1998, she had a relationship with

HOOKER. CV also said HOOKER had performed oral sex on her when she was seventeen (17) years old.

Your affiant, and Sgt Mitch PAINE met with CV at her home. CV told your affiant the following; CV received your affiant's name from the police department, and decided to call after she saw several media outlets reporting on the relationship between HOOKER, and a former student Jordan POWERS. She met HOOKER on a Future Business Leaders of America (FBLA) trip to Irvine California in March or April of 1998. CV explained HOOKER was an advisor for Davis High School in Modesto, she was a student at Beyer High School in Modesto.

CV said she graduated from Beyer High School in June of 1998. She did not turn eighteen (18) until February of 1999. CV said after she had graduated from Beyer High School, she attended an FBLA conference in Orlando Florida with HOOKER, and a Davis High School graduate.

After CV returned home from the FBLA conference in Orlando, she explained she and HOOKER began to instant message, and email each other, starting a romantic relationship.

CV explained she visited HOOKER while he was teaching summer school at Modesto High School. CV said she "made out" with HOOKER several times while on campus. CV also said she visited him while he was teaching the class, and explained they would write notes back and forth during the

class. CV also said she had visited HOOKER on Davis High School's campus during the summer, helping him set up the student store. CV said she had "made out" with HOOKER on Davis High School's campus as well. CV described making out as kissing.

CV said she had visited HOOKER'S mother's home around August of 1998. CV explained HOOKER had told her he was living at his mother's home, because he lived in Fresno, but had started working in Modesto. HOOKER told CV his wife, and child were still living in Fresno. CV described the house as out in the country area near Turlock. CV said it was a single story ranch home, and sketched a map of the home. Your affiant looked at the map, and found it, and the description similar to HOOKER'S current home located at [REDACTED] California. CV said while at HOOKER'S mother's home, in his bedroom, HOOKER had performed oral sex on CV.

CV said after the oral sex incident, she visited a drive in movie in the Ceres or Turlock area. CV said they saw "Armageddon". CV said during the movie, they were "making out" and discussed having sexual intercourse, however they did not have a condom, and the vehicle was uncomfortable. Your affiant looked into this matter, and found Armageddon was released July 1<sup>st</sup> 1998.

CV said the relationship lasted through the summer of 1998, ending about two weeks prior to her leaving for college.

Your affiant asked CV if HOOKER was aware of her being seventeen, CV said they had discussed her age, and made jokes about it. CV told your affiant during the FBLA trip to Orlando Florida, HOOKER had her I.D. and enough information to be able to authorize medical care.

CV provided a copy of an email she had received from HOOKER on June 25<sup>th</sup>, 2002. The email was titled "Memories". The content of the email consisted of HOOKER telling CV he had found some pictures of them from a "distant summer". The email continued to say he was sorry for any stress he added to her life, and had to make a choice about where to focus his love. It continued to say he had to run from what they had, and that his time with CV was "truly amazing". HOOKER said he would like to hear how the last four (4) years of CV's life have been. HOOKER also told CV she was "beautiful, and have such incredible eyes." CV also provided your affiant with pictures of HOOKER, taken in the summer of 1998. One of the pictures is of HOOKER, standing outside a portable classroom. CV said the picture is at Modesto High School during summer school.

CV said she had told people about the incident through out the years, and provided your affiant names.

Your affiant spoke to [REDACTED] who is CV's mother. [REDACTED] said she remembers finding a note in CV's pocket while doing laundry during the summer of 1998. [REDACTED] said the note had writings from her daughter, and another person. [REDACTED] said the note was "flirtatious" in

nature, and was concerned. [REDACTED] said when she questioned her daughter about the incident, she said it was a teacher who she was writing back and forth with. [REDACTED] said she told her daughter to end the relationship immediately.

Your affiant spoke to [REDACTED] who is CV's husband, and was her boyfriend during the relationship she had with HOOKER. [REDACTED] told your affiant he had found a love note from HOOKER to CV in her pant pocket in the summer of 1998. [REDACTED] also said CV told him about HOOKER performing oral sex on CV about six months after her relationship with HOOKER had ended.

Your affiant spoke with [REDACTED]. [REDACTED] is a friend of CV's. [REDACTED] told your affiant she remembered CV telling her about a relationship she had with a teacher.

Your affiant spoke with [REDACTED]. [REDACTED] is a friend of CV's. [REDACTED] told your affiant she remembered CV telling her about a relationship she had with a teacher, and remembered the teacher's name was "James."

Your affiant spoke with [REDACTED] the wife of Christopher "James" HOOKER. [REDACTED] told your affiant, she learned of CV in January of 2012 when she learned of another eighteen (18) year old student HOOKER had an affair with. [REDACTED] told your affiant HOOKER told her a student who had gone on the FBLA trip to Florida with him and had pursued a relationship with him. [REDACTED] [REDACTED] said James HOOKER told her he had visited her at her mother's house. During that visit CV had come out of a

room naked, coming on to HOOKER. [REDACTED] said James HOOKER told her he had touched the CV, but did not have sexual intercourse with her. [REDACTED] said she did not know what the touching consisted of. [REDACTED] told your affiant she was living in Fresno California at the time this incident would have happened.

On 04/04/12, your affiant went with CV to [REDACTED] [REDACTED] CV said she recognized the home, but said it had changed, and said the west driveway and the west side of the home were not previously there. Your affiant confirmed with [REDACTED] the west side of the home was an addition added after 1998.

On 04/04/12 at your affiant's request, CV sent HOOKER an email in attempt to establish dialogue with HOOKER for evidentiary purposes. On 04/05/12, at approximately 1230 hours, your affiant met with [REDACTED], the mother of James HOOKER. [REDACTED] lives at [REDACTED] [REDACTED] shared the residence with James and [REDACTED] HOOKER. [REDACTED] said James HOOKER called her yesterday (04/04/12), and asked her to retrieve his passport.

Your affiant reviewed HOOKER'S criminal history, and found he had none.


After investigating this matter, I Detective Steven Anderson, have probable cause to believe, the suspect, James Christopher HOOKER DOB 05/02/1970, oral copulated CV,

violating California Penal Code section 288a(b)(1) P.C. Oral Copulation on a Minor under Eighteen Years Old. Furthermore, your affiant found the statute of limitations per 803(f) P.C. is one year after the allegation is reported to law enforcement, as long as the crime involved substantial sexual contact, and there is independent cooberating evidence.

Therefore your affiant respectfully requests a warrant of arrest for James Christopher HOOKER, DOB 05/02/1970 for the above outlined offense.

I declare under the penalty of perjury that I have read this affidavit and know its contents thereof, and the same is true of my own knowledge, except as to the matters which are therein stated upon my information and belief, and as to those matters I believe to be true.
