That defendants, Citizens for a Voice in Government, Major Funding by Investment Manager, Brandon Powers, Lysa Ray, and Chris Hansen, admit that they violated the Political Reform Act, as stipulated and agreed to within the attached Stipulation for Entry of Judgment.

For their violations of the Political Reform Act of 1974, it is ordered that defendants, Citizens for a
Voice in Government, Major Funding by Investment Manager, Brandon Powers, Lysa Ray, and Chris
Hansen, shall pay a total penalty of \$50,000, pursuant to the terms of the Stipulation for Entry of
Judgment entered into by the parties. Payment of this amount shall be made by cashier's check, payable
to the "General Fund of the State of California," upon execution of the attached Stipulation for Entry of
Judgment.

The parties shall each bear their own costs. This Judgment shall take effect immediately upon entry. The clerk is directed to enter this Judgment forthwith.
