CRIMINAL COMPLAINT

The District Attorney of El Dorado County, based upon information and belief, hereby alleges:

COUNT 1

On or about the 13th day of September, 2014, in the County of El Dorado, the crime of ARSON OF FOREST LAND, in violation of **PENAL CODE SECTION 451(c)**, a Felony, was committed by WAYNE ALLEN HUNTSMAN, who did willfully and maliciously set fire to and burn, and cause to be burned, forest land located in and around Pollock Pines, California, to wit: the fire known as the King Fire.

NOTICE: The above offense is a serious felony within the meaning of Penal Code Section 1192.7(c).

SPECIAL ALLEGATION - ARSON WITH AGGRAVATING FACTORS

It is further alleged, pursuant to Penal Code section 451.1(a)(2) that the following aggravating factors exist: A firefighter, peace officer, or other emergency personnel suffered great bodily injury as a result of the offense.

SPECIAL ALLEGATION - PRIOR OFFENSES-ELIGIBILITY FOR PROBATION

It is further alleged as to COUNT 1 that WAYNE ALLEN HUNTSMAN was convicted of the following felonies within the meaning of Penal Code Section 1203(e)(4):
