EL DORADO COUNTY DISTRICT ATTORNEY VERN PIERSON ANNOUNCES THE GRAND JURY INDICTMENT AGAINST WAYNE ALLEN HUNTSMAN

El Dorado County District Attorney Vern Pierson announced today that an El Dorado County Grand Jury indicted Wayne Allen Huntsman on charges of felony arson related to the King Fire.

On December 3, 2014, an El Dorado County Grand Jury indicted Huntsman with a violation of Penal Code § 451(c), Arson of Forest Land, a felony, and with multiple Special Allegations of Arson with Aggravating Factors. Today, Huntsman was arraigned on the Indictment in El Dorado County Superior Court and his bail remains set at \$10,000,000. The defense filed a motion to recuse the judge and the matter is now set for a Trial Setting Conference on January 23, 2015, at 1:30 PM in Department 2 of the El Dorado County Superior Court with Judge Melikian.

INDICTMENT

The Grand Jury of El Dorado County accuses WAYNE ALLEN HUNTSMAN, as follows:

COUNT I

On or about the 13th day of September, 2014, in the County of El Dorado, the crime of ARSON OF FOREST LAND, in violation of PENAL CODE SECTION 451(c), a Felony, was committed by WAYNE ALLEN HUNTSMAN, who did willfully, unlawfully, and maliciously set fire to and burn and cause to be burned forest land located in and around Pollock Pines, California, to wit: the fire known as the King Fire.

SPECIAL ALLEGATION - ARSON WITH GREAT BODILY INJURY

It is further alleged as to Count I, pursuant to Penal Code section 451.1(a)(2) that the following aggravating factor exist: A firefighter suffered great bodily injury as a result of the offense.

SPECIAL ALLEGATION - ARSON WITH MULTIPLE VICTIMS

It is further alleged as to Count I, pursuant to Penal Code section 451.1(a)(3) that the following aggravating factor exist: The defendant proximately caused great bodily injury to more than victim as a result of the offense.

SPECIAL ALLEGATION - ARSON WITH MULTIPLE STRUCTUES BURNED

It is further alleged as to Count I, pursuant to Penal Code section 451.1(a)(4) that the following aggravating factor exist: The defendant proximately caused multiple structures to burn as a result of the offense.

SPECIAL ALLEGATION - AGGRAGRATED ARSON

It is further alleged as to Count I, pursuant to Penal Code Section 451.5(a) the defendant willfully, maliciously, deliberately, with premeditation, and with intent to cause injury to one or more person and to cause damage to property under circumstances likely to produce injury to one or more persons and to cause damage to one or more structures or inhabited dwellings, set fire to, burned, and caused to be burned, any residence, structure, forest land, and property with one or more of the following aggravating factors:

- The fire caused property damage and other losses in excess of six million five hundred thousand dollars (\$6,500,000), pursuant to Penal Code Section 451.5(a)(2); and,
- The fire caused damage to, or the destruction of, five of more inhabited structures, pursuant to Penal Code 451(a)(3).

SPECIAL ALLEGATION - PRIOR OFFENSES - ELIGIBILITY FOR PROBATION

It is further alleged as to Count I, that said WAYNE ALLEN HUNTSMAN was convicted of the following felonies within the meaning of Penal Code Section 1203(e)(4):
