Count Enhancement 1a: It is further alleged that during the commission of the felony charged above CHANDALE DONTRAY SHANNON JR and DAVID ASHLEY FROSTE and, that a principal in said felony offense was armed with a firearm, within the meaning of Section 12022(a)(1) of the California Penal Code, ARMED WITH FIREARM.

Count 2: On or about October 18, 2016, JONATHAN FROSTE did commit a FELONY, namely, a violation of Section 32 of the California Penal Code, ACCESSORY TO A FELONY, in that after the commission of a felony JONATHAN FROSTE did willfully and unlawfully harbor, conceal, and aid a principal in said felony, to wit MURDER of Enrique Rios, with the intent that said principal avoid or escape from arrest, trial, conviction and punishment after JONATHAN FROSTE had knowledge that said principal had committed MURDER.

Count 3: On or about November 4th, 2016, DAVID ASHLEY FROSTE and JONATHAN FROSTE did commit a FELONY, namely, a violation of Section 207(a) of the California Penal Code, KIDNAPPING, in that DAVID ASHLEY FROSTE and JONATHAN FROSTE did willfully, unlawfully, forcibly, and by any other means of instilling fear steal, take, hold, detain, and arrest any person, to wit, Elijah Moore, in the State of California, and DAVID ASHLEY FROSTE and JONATHAN FROSTE did carry such victim into another part of the same county.

Case Enhancement 3a: It is further alleged that during the commission of the felony charged above, DAVID ASHLEY FROSTE did willfully, unlawfully, and personally use a deadly or dangerous weapon, within the meaning of Section 12022(b)(1) of the

California Penal Code, USE OF DEADLY WEAPON[knife or scissors].

Count 4: On or about November 4th, 2016, CHANDALE DONTRAY SHANNON JR and DAVID ASHLEY FROSTE and JONATHAN FROSTE did commit a FELONY, namely, a violation of Section 187(a) of the California Penal Code, MURDER, in that CHANDALE DONTRAY SHANNON JR and DAVID ASHLEY FROSTE and JONATHAN FROSTE did willfully and unlawfully kill a human being, to wit, Elijah Moore, with malice aforethought.

Count Enhancement 4a: It is further alleged that during the commission of the felony charged above CHANDALE DONTRAY SHANNON JR and DAVID ASHLEY FROSTE and JONATHAN FROSTE that a principal in said felony offense was armed with a firearm, within the meaning of Section 12022(a)(1) of the California Penal Code, ARMED WITH FIREARM.

Case Enhancement a: It is also alleged that during the commission of the murders as charged above in this complaint, CHANDALE DONTRAY SHANNON JR and DAVID ASHLEY FROSTE did murder another, to wit, Enrique Rios and Elijah Moore, within the meaning of Section 190.2(a)(3) of the California Penal Code, SPECIAL CIRCUMSTANCES FOR MULTIPLE MURDERS.

Case Enhancement b: It is also alleged that the murder as charged above was committed while DAVID ASHLEY FROSTE and JONATHAN FROSTE was engaged in or was an accomplice in the commission of, attempted commission of, and the immediate flight after committing a felony violation of Section 207 of the California Penal Code, Kidnapping, within the meaning of Section 190.2(a)(17) of the California Penal Code, SPECIAL CIRCUMSTANCES FOR MURDER DURING THE COMMISSION OF KIDNAPPING.
