COUNT ONE

On or about February 1, 2020, at and in the County of Sacramento, State of California, the defendants, LAISE BURTON HANDS, RICHARD LAVONTAE JONES, GANGSTER LAVELL LAWSON, and MAHADDIE ISHRAEZALI UNDERWOOD, did commit a felony, namely: a violation of Section 25400(a)(1) of the Penal Code of the State of California, in that said defendants did willfully and unlawfully carry concealed within a vehicle which was under their control and direction a pistol, revolver and other firearm, to wit, a .40 caliber handgun with ammunition readily accessible, capable of being concealed upon the person.

It is further alleged that both the firearm and unexpended ammunition capable of being discharged from that firearm were in the immediate possession of the defendants and were readily accessible to the defendants, and the firearm was loaded; and, further, the defendants are not listed with the Department of Justice pursuant to Penal Code Section 11106(c)(1) as the registered owners of that particular firearm within the meaning of Penal Code Section 25400(c)(6).

COUNT TWO

For a further and separate cause of action, being a different offense from but connected in its commission as the charges set forth in Count One hereof: On or about February 1, 2020, at and in the County of Sacramento, State of California, the defendants, LAISE BURTON HANDS, RICHARD LAVONTAE JONES, GANGSTER LAVELL LAWSON, and MAHADDIE ISHRAEZALI UNDERWOOD, did commit a felony, namely: a violation of Section 27545 of the Penal Code of the State of California, in that said defendants did willfully and unlawfully transfer and sell a firearm other than a handgun, to wit, a .40 caliber handgun with ammunition readily accessible, without at least one party to the transaction being a licensed firearm dealer and through a licensed firearm dealer.

3 **COUNT THREE**

4 For a further and separate cause of action, being a different offense from but connected in its
5 commission as the charges set forth in Counts One and Two hereof: On or about February 1,
6 2020, at and in the County of Sacramento, State of California, the defendant, LAISE BURTON
7 HANDS, did commit a felony, namely: a violation of Section 2800.2(a) of the Vehicle Code of
8 the State of California, in that said defendant did willfully and unlawfully, while operating a
9 motor vehicle and with the intent to evade, flee and otherwise attempt to elude a pursuing peace
10 officer's motor vehicle while all of the following conditions existed: the peace officer's motor
11 vehicle exhibited at least one lighted red lamp visible from the front and the defendant saw and
12 reasonably should have seen the lamp, the peace officer's motor vehicle was sounding its siren as
13 was reasonably necessary, the peace officer's motor vehicle was distinctively marked, the peace
14 officer's motor vehicle was operated by a peace officer.

16 It is further alleged that the defendant drove with a willful wanton disregard for the safety of
17 persons and property.

19 **PRIOR CONVICTION (CASE # 264690)**

20 **1.**

21 It is further alleged that the defendant, LAISE BURTON HANDS, on September 21, 2017, in the
22 Juvenile Court of the State of California, in and for the County of Sacramento, suffered a
23 sustained petition for the crime of Assault With a Semi-Automatic Firearm, in violation of
24 Section 245(b) of the Penal Code, a serious felony, within the meaning of Section 1192.7(c) of
25 the Penal Code, and that by reason thereof, that he comes within the provisions of Section
26 667(b)-(i) and Section 1170.12 of the Penal Code, in that the defendant was a person of 16 years
27 of age and older, to wit, 16, born on 3/10/1999, at the time of the commission of the above
28 offense, which is an offense set forth in Welfare and Institutions Code Section 707, subdivision
29 (b).

7 Vehicle Code of the State of California, in that said defendant was the driver of a vehicle
8 involved in an accident resulting in damage to property, who did unlawfully fail to stop the
9 vehicle at the scene of the accident and comply with subsections (1) and (2) of Vehicle Code
10 Section 20002(a).

12 **COUNT FIVE**

13 For a further and separate cause of action, being a different offense from but connected in its
14 commission as the charges set forth in Counts One through Four hereof: On or about February 1,
15 2020, at and in the County of Sacramento, State of California, the defendants, LAISE BURTON
16 HANDS, RICHARD LAVONTAE JONES, GANGSTER LAVELL LAWSON, and
17 MAHADDIE ISHRAEZALI UNDERWOOD, did commit a misdemeanor, namely: a violation
18 of Section 148(a)(1) of the Penal Code of the State of California, in that said defendants did
19 willfully and unlawfully resist, delay and obstruct SACRAMENTO POLICE DEPARTMENT
20 OFFICER CUMBERLAND AND OTHER PEACE OFFICERS, who were then and there peace
21 officers attempting to and discharging the duty of their office and employment.

27 commission as the charges set forth in Counts One through Five hereof: On or about February 1,
28 2020, at and in the County of Sacramento, State of California, the defendant, LAISE BURTON
29 HANDS, did commit a misdemeanor, namely: a violation of Section 12500(a) of the Vehicle
30 Code of the State of California, in that said defendant did unlawfully drive a motor vehicle upon
31 a highway without holding a valid driver's license issued under the Vehicle Code of the State of
