

"NOTICE: The above offense is a serious felony within the meaning of Penal Code section 1192.7(c)."

It is further alleged that probation shall not be granted to, nor shall the execution or imposition of sentence be suspended pursuant to Penal Code Section 1203.65(a).

"NOTICE: Conviction of this offense will require you to register pursuant to Penal Code Section 290. Registration pursuant to Penal Code section 290 will be for the rest of your life. Willful failure to register is a crime."

"NOTICE: Pursuant to the provisions of PC Section 293.5 the use of pseudonym "Jane or John Doe", if it appears in the complaint or information, is for purposes of protecting the privacy of the alleged victim."

## COUNT TWO

On or about March 27, 2019, in the County of SACRAMENTO, the crime of ORAL COPULATION OF A PERSON UNDER 18, in violation of Penal Code section 287(b)(1), a felony, was committed by JAMES BRIAN

RHODES, who did unlawfully participate in an act of oral copulation with JANE DOE, a person under the age of eighteen years.

### COUNT THREE

On or about April 24, 2019, in the County of Placer, the crime of UNLAWFUL SEXUAL INTERCOURSE, in violation of Penal Code section 261.5(c), a felony, was committed by JAMES BRIAN RHODES, engaged in an act of unlawful sexual intercourse with JANE DOE, a minor, not the spouse of the defendant, the minor being more than three years younger than the defendant.

# COUNT FOUR

On or about April 27, 2019, in the County of Placer, the crime of UNLAWFUL SEXUAL INTERCOURSE, in violation of Penal Code section 261.5(c), a felony, was committed by JAMES BRIAN RHODES, engaged in an act of unlawful sexual intercourse with JANE DOE, a minor, not the spouse of the defendant, the minor being more than three years younger than the defendant.

### COUNT FIVE

On or about May 17, 2019, in the County of Placer and/or SACRAMENTO, the crime of UNLAWFUL SEXUAL INTERCOURSE, in violation of Penal Code section 261.5(c), a felony, was committed by JAMES BRIAN RHODES, engaged in an act of unlawful sexual intercourse with JANE DOE, a minor, not the spouse of the defendant, the minor being more than three years younger than the defendant.

# COUNT SIX

On or about May 19, 2019, in the County of Placer, the crime of UNLAWFUL SEXUAL INTERCOURSE, in violation of Penal Code section 261.5(c), a felony, was committed by JAMES BRIAN RHODES, engaged in an act of unlawful sexual intercourse with JANE DOE, a minor, not the spouse of the defendant, the minor being more than three years younger than the defendant.

### COUNT SEVEN

On or about May 20, 2019, in the County of Placer and/or SACRAMENTO, the crime of UNLAWFUL SEXUAL INTERCOURSE, in violation of Penal Code section 261.5(c), a felony, was committed by JAMES BRIAN RHODES, engaged in an act of unlawful sexual intercourse with

JANE DOE, a minor, not the spouse of the defendant, the minor being more than three years younger than the defendant.

## COUNT EIGHT

On or about May 26, 2019, in the County of SACRAMENTO, the crime of UNLAWFUL SEXUAL INTERCOURSE, in violation of Penal Code section 261.5(c), a felony, was committed by JAMES BRIAN RHODES, engaged in an act of unlawful sexual intercourse with JANE DOE, a minor, not the spouse of the defendant, the minor being more than three years younger than the defendant.

### COUNT NINE

On or about May 28, 2019, in the County of SACRAMENTO, the crime of UNLAWFUL SEXUAL INTERCOURSE, in violation of Penal Code section 261.5(c), a felony, was committed by JAMES BRIAN RHODES, engaged in an act of unlawful sexual intercourse with JANE DOE, a minor, not the spouse of the defendant, the minor being more than three years younger than the defendant.

# COUNT TEN

On or about May 30, 2019, in the County of SACRAMENTO, the crime of UNLAWFUL SEXUAL INTERCOURSE, in violation of Penal Code section 261.5(c), a felony, was committed by JAMES BRIAN RHODES, engaged in an act of unlawful sexual intercourse with JANE DOE, a minor, not the spouse of the defendant, the minor being more than three years younger than the defendant.

### COUNT ELEVEN

On or about June 13, 2019, in the County of Placer and/or SACRAMENTO, the crime of UNLAWFUL SEXUAL INTERCOURSE, in violation of Penal Code section 261.5(c), a felony, was committed by JAMES BRIAN RHODES, engaged in an act of unlawful sexual intercourse with JANE DOE, a minor, not the spouse of the defendant, the minor being more than three years younger than the defendant.

### COUNT TWELVE

### COUNT THIRTEEN

On or about June 16, 2019, in the County of Placer, the crime of UNLAWFUL SEXUAL INTERCOURSE, in violation of Penal Code section 261.5(c), a felony, was committed by JAMES BRIAN RHODES, engaged in an act of unlawful sexual intercourse with JANE DOE, a minor, not the spouse of the defendant, the minor being more than three years younger than the defendant (in the defendant's truck).

### COUNT FOURTEEN

On or about June 17, 2019, in the County of SACRAMENTO, the crime of UNLAWFUL SEXUAL INTERCOURSE, in violation of Penal Code section 261.5(c), a felony, was committed by JAMES BRIAN RHODES, engaged in an act of unlawful sexual intercourse with JANE DOE, a minor, not the spouse of the defendant, the minor being more than three years younger than the defendant.

#### COUNT FIFTEEN

On or about June 27, 2019, in the County of Placer and/or SACRAMENTO, the crime of UNLAWFUL SEXUAL INTERCOURSE, in violation of Penal Code section 261.5(c), a felony, was committed by JAMES BRIAN RHODES, engaged in an act of unlawful sexual intercourse with JANE DOE, a minor, not the spouse of the defendant, the minor being more than three years younger than the defendant.

# COUNT SIXTEEN

On or about July 3, 2019, in the County of Placer and/or SACRAMENTO, the crime of UNLAWFUL SEXUAL INTERCOURSE, in violation of Penal Code section 261.5(c), a felony, was committed by JAMES BRIAN RHODES, engaged in an act of unlawful sexual intercourse with JANE DOE, a minor, not the spouse of the defendant, the minor being more than three years younger than the defendant.

### COUNT SEVENTEEN

On or about July 5, 2019, in the County of Placer and/or SACRAMENTO, the crime of UNLAWFUL SEXUAL INTERCOURSE, in violation of Penal Code section 261.5(c), a felony, was committed by JAMES BRIAN RHODES, engaged in an act of unlawful sexual intercourse with JANE DOE, a minor, not the spouse of the defendant, the minor being more than three years younger than the defendant.

On or about July 25, 2019, in the County of SACRAMENTO, the crime of UNLAWFUL SEXUAL INTERCOURSE, in violation of Penal Code section 261.5(c), a felony, was committed by JAMES BRIAN RHODES, engaged in an act of unlawful sexual intercourse with JANE DOE, a minor, not the spouse of the defendant, the minor being more than three years younger than the defendant.

### COUNT TWENTY

On or about August 21, 2019, in the County of SACRAMENTO, the crime of UNLAWFUL SEXUAL INTERCOURSE, in violation of Penal Code section 261.5(c), a felony, was committed by JAMES BRIAN RHODES, engaged in an act of unlawful sexual intercourse with JANE DOE, a minor, not the spouse of the defendant, the minor being more than three years younger than the defendant.

### COUNT TWENTY-ONE

On or about August 22, 2019, in the County of Placer and/or SACRAMENTO, the crime of UNLAWFUL SEXUAL INTERCOURSE, in violation of Penal Code section 261.5(c), a felony, was committed by JAMES BRIAN RHODES, engaged in an act of unlawful sexual intercourse with JANE DOE, a minor, not the spouse of the defendant, the minor being more than three years younger than the defendant.

### COUNT TWENTY-TWO

On or about November 20, 2019, in the County of Placer and/or SACRAMENTO, the crime of UNLAWFUL SEXUAL INTERCOURSE, in violation of Penal Code section 261.5(c), a felony, was committed by JAMES BRIAN RHODES, engaged in an act of unlawful sexual intercourse with

JANE DOE, a minor, not the spouse of the defendant, the minor being more than three years younger than the defendant.

# COUNT TWENTY-THREE

On or about December 4, 2019, in the County of SACRAMENTO, the crime of UNLAWFUL SEXUAL INTERCOURSE, in violation of Penal Code section 261.5(c), a felony, was committed by JAMES BRIAN RHODES, engaged in an act of unlawful sexual intercourse with JANE DOE, a minor, not the spouse of the defendant, the minor being more than three years younger than the defendant.

# COUNT TWENTY-FOUR

On or about December 4, 2019, in the County of SACRAMENTO, the crime of SODOMY OF PERSON UNDER 18, in violation of PENAL CODE SECTION 286(b)(1), a felony, was committed by JAMES BRIAN RHODES, who did unlawfully participate in an act of sodomy with JANE DOE, a person under the age of eighteen years.

"NOTICE: Conviction of this offense will require you to register pursuant to Penal Code Section 290. Registration pursuant to Penal Code section 290 will be for the rest of your life. Willful failure to register is a crime." 1

# JURISDICTION

For counts 1-24, pursuant to Penal Code section 784.7(b) If more than one violation of Section 243.4 , 261.5 , 273a , 273.5 , or 646.9 occurs in more than one jurisdictional territory, and the defendant and the victim are the same for all of the offenses, the jurisdiction of any of those offenses and for any offenses properly joinable with that offense, is in any jurisdiction where at least one of the offenses occurred.

Additionally for Counts 1-24, pursuant to Penal 783 when a public offense is committed in this State, in a motor vehicle or on board a vessel navigating a river, bay, slough, lake, or canal, or lying therein, in the prosecution of its voyage, or on a railroad train or car, motor vehicle, common carrier transporting passengers or on an aircraft prosecuting its trip, the jurisdiction is in any competent court, through, on, or over the jurisdictional territory of which the vessel, train, car, motor vehicle, common carrier or aircraft passes in the course of its voyage or trip, or in the jurisdictional territory of which the voyage or trip terminates.
