

Hi all -

Per meeting and conversation today and then some additional follow-up, attached and below is updated timeline for next steps in Detroit timeline.

In particular, it reflects:

The new intial Governor determination date of Friday, March 1.

A Thursday, March 14, date for Governor to confirm the emergency (post hearing as required legally) and recommend ELB candidate, AND for the ELB to confirm and make this EFM appointment.

And then Friday, March 15, for Governor, Treasurer and the EFM candidate to do media rounds/interviews and key stakeholder meetings.

Key decision points and things we need to make sure work:

Ensuring March 14 is best date for final determination. This is before the Economic Summit and essentially two weeks from initial determination. Ensures fastest time frame and perception wise we're well before March 28 new act effective date while ensuring respect for all process and due diligence while not diverting media attention from Econ Summit.

We need to verify if Gov's 3 p.m. announcement in Detroit that day (March 14) is enough time for ELB to meet and confirm candidate after than

We need to decide if best for Gov and EFM candidate to appear together that day for said announcement.

Your dad was a man of great conviction and character. What a nice tribute! Thanks for sending this. Hope all is progressing well on your end. Governor already asking me if you are ready to start yet. Honestly...dog years! Am working out details to but in writing to you but loosely, it will have the following components:

- Base compensation of \$275,000 per annum
- Contract period not to exceed 18 months with incentives if job is completed sooner based on mutually agreed milestones
- Intent to raise private funding for performance measure/outcomes bonus
- Suitable leased furnished apartment in the City
- Commutation expenses roughly equivalent to what it would cost to
 physically move a family of four from Maryland to a comparable home in Detroit Metropolitan area
- Security detail 24/7 while in Michigan

Kevyn, I know you have to work logistics on your end but I do want you to know our folks are already behaving as if you accepted the job. I guess that's human nature since the chemistry and vision was so aligned with our own. I told you last week that my instincts were you were cut from the same cloth as us and now the team can feel it too.
