On Thursday, February 8, 2007, the Department of Equal Educational Opportunities (EEO) concluded its investigation into an alleged discrimination complaint. During the investigation, sufficient evidence existed, including your own admittance to corroborate that you did indeed use a de-rogatory term, "nigger" in the presence of subordinates, during a transportation event on Sunday, February 4, 2007.

You have failed to meet the performance standards required of your position as Terminal Supervisor. Specifically, you have inappropriately used an ethnic reference. This conduct is prejudicial to good order and violates School Board Policy 4001.1 – Non- discrimination Policy Statement as it states in part, "this policy is established to provide and environment free of discrimination and harassment based on age, race, color, disability, gender, marital status, national origin, religion or sexual orientation."

Your behavior constitutes a serious breach of conduct that will not be tolerated; therefore, I am issuing you this written reprimand that is consistent with School Board Policy 4.9 and past practices of the District. In addition, I am directing you to attend a Nondiscrimination Training session and am providing you the attached copy of School Board Policy 4001.1 — Nondiscrimination Policy Statement for future reference and adherence.

Please be advised that any further failure on your part to perform to the standards established for the effective and productive performance of your job duties will result in further disciplinary action, up to and including termination of employment.

Please keep in mind, any further instances of this similar nature will result in and up to further disciplinary action.
