

Before me this date personally appeared LOPEZ, GINA (2801) who being first duly sworn deposes and says that on _____ day of _____, (year) _____ at 2421 N 57TH WAY, HOLLYWOOD, FL (crime location) the above named defendant committed the above offenses charged and the facts showing probable cause to believe the same are as follows:

ON 07/30/11 AT 2059 HOURS, HOLLYWOOD POLICE DISPATCH RECEIVED A 911 CALL FROM JOHN KERTESZ. HE STATED THAT HE HAD DISCOVERED HIS WIFE UNRESPONSIVE AND BLEEDING EXTENSIVELY FROM THE HEAD IN HIS HOME LOCATED AT 2421 N. 57TH WAY IN HOLLYWOOD. HOLLYWOOD POLICE AND FIRE RESCUE RESPONDED TO THE SCENE AND THE FEMALE, IDENTIFIED AS IRENE KERTESZ, WAS PRONOUNCED DEAD BY FIRE RESCUE PERSONNEL. THERE WAS OBVIOUS BLUNT FORCE TRAUMA TO THE VICTIM'S HEAD.



Probable Cause Affidavit

Before me this date personally appeared LOPEZ, GINA (2801) who being first duly sworn deposes and says that on _____ day of _____, (year) _____ at 2421 N 57TH WAY, HOLLYWOOD, FL (crime location) the above named defendant committed the above offenses charged and the facts showing probable cause to believe the same are as follows:

THE VICTIM'S BODY WAS IN THE SOUTHEAST BEDROOM OF THE HOUSE, WHICH APPEARED TO BE USED AS AN EXTRA BEDROOM AND HOME OFFICE. SHE DID HAVE OBVIOUS TRAUMA TO HER HEAD, THE BODY WAS COLD TO THE TOUCH, AND THERE WAS OBVIOUS SIGNS OF RIGOR WHICH INDICATED TO ME THAT SHE HAD BEEN DECEASED FOR A FEW HOURS. THE BLOOD AROUND THE BODY WAS MOSTLY DRIED INDICATING THAT IT HAD BEEN THERE FOR SOME LENGTH OF TIME. BASED ON THE OBSERVATIONS FROM THE CRIME SCENE AND AN INSPECTION OF THE BODY, IT WAS DETERMINED THAT THE VICTIM HAD SUSTAINED HER INJURIES SEVERAL HOURS PRIOR TO BEING DISCOVERED BY HER HUSBAND. DR. WARDAK FROM THE BROWARD COUNTY MEDICAL EXAMINER'S OFFICE ARRIVED ON SCENE AND RULED THAT THE DEATH WAS A HOMICIDE.

THIS DETECTIVE INTERVIEWED THE REPORTEE, JOHN KERTESZ, AT WHICH TIME HE STATED THAT HE LEFT THE HOUSE AROUND 1300 HOURS ON 7/30/11, AND WHEN HE LEFT, HIS WIFE IRENE KERTESZ, AND SON JASON KERTESZ WERE HOME. HE STATED THAT HE TALKED TO HIS WIFE FOR THE LAST TIME VIA HER CELL PHONE AT APPROXIMATELY 1250 HOURS. AS MR. KERTESZ WAS LEAVING THE HOUSE AT APPROXIMATELY 1300 HOURS, SHE ARRIVED HOME. MR. KERTESZ ADVISED THAT HE THEN WENT TO THE SEMINOLE CASINO AND STAYED UNTIL APPROXIMATELY 1730 HOURS, AFTERWHICH, HE DROVE HIS FRIEND, FRED MCKENZIE, TO HIS HOME IN PLANTATION. HE THEN STARTED DRIVING TO THE HOLLYWOOD BEACH AREA TO HAVE DINNER WITH ANOTHER FRIEND. DURING THIS TIME, MR. KERTESZ RECEIVED A CALL FROM HIS SON, JASON KERTESZ, ON HIS WIFE'S PHONE. KERTESZ SAID HIS SON ASKED HIM IF HE WOULD BE HOME FOR DINNER. HE TOLD HIS SON THAT HE HAD OTHER PLANS, BUT THOUGHT IT WAS STRANGE THAT HIS SON WOULD CALL AND ASK, AND HE ASKED HIS SON WHERE HIS WIFE WAS. JASON TOLD HIM SHE WAS TAKING A NAP WHICH WAS ALSO OUT OF THE ORDINARY FOR HER. MR. KERTESZ'S DINNER PLANS WERE CANCELLED THEN, AND HE ARRIVED HOME AT AROUND 1900 HOURS. HE OBSERVED THAT HIS WIFE'S CAR WAS NOT IN THE DRIVEWAY, AND NOBODY WAS HOME. JOHN KERTESZ STATED HE ATTEMPTED TO CALL HIS WIFE'S CELL PHONE, AND IT WENT TO VOICEMAIL, BUT HE IMMEDIATELY GOT A CALL BACK FROM HIS SON ON HIS WIFE'S

Before me this date personally appeared LOPEZ, GINA (2801) who being first duly sworn deposes and says that on _____ day of _____, (year) _____ at 2421 N 57TH WAY, HOLLYWOOD, FL (crime location) the above named defendant committed the above offenses charged and the facts showing probable cause to believe the same are as follows:

NUMBER. MR. KERTESZ ASKED JASON KERTESZ WHERE HIS MOTHER WAS AND JASON STATED THAT SHE MUST HAVE GONE OUT. AFTER APPROXIMATELY AN HOUR, JOHN KERTESZ CALLED HIS WIFE'S NUMBER AGAIN BUT AGAIN GOT JASON KERTESZ AND NO EXPLANATION AS TO WHERE HIS WIFE WAS. HE TRIED TO CALL ONE MORE TIME AT APPROXIMATELY 2052 HOURS AND GOT THE VOICEMAIL.

JOHN KERTESZ SAID HE WAS NOW VERY AFRAID FOR HIS WIFE'S SAFETY AND WENT INTO THE MASTER BEDROOM AND DISCOVERED THAT THE DRESSER DRAWER THAT HIS WIFE KEPT THEIR BILLS AND PAPERWORK IN WAS PULLED OPEN AND SOME OF THE CONTENTS WERE ON THE BED. JOHN KERTESZ STATED HE BEGAN CHECKING OTHER ROOMS OF THE HOUSE. HE STATED THAT THE DOOR TO A BEDROOM THEY USE AS AN OFFICE WAS CLOSED AND LOCKED WHICH WAS VERY UNUSUAL, BUT CONTRIBUTED IT TO THE FACT THAT THEIR SON HAD STOLEN MONEY AND ITEMS FROM THE HOUSE PREVIOUSLY AND THEY HAD BEGUN LOCKING THINGS UP AND HIDING THEM. HE THOUGHT THAT HIS WIFE MAY HAVE LOCKED THE DOOR SO THAT JASON COULD NOT STEAL THEIR COMPUTER. HE STATED HE PICKED THE LOCK OF THE DOOR AND DISCOVERED HIS WIFE LAYING ON THE GROUND UNRESPONSIVE AND BLEEDING FROM THE HEAD. JOHN KERTESZ STATED HE IMMEDIATELY DIALED 911 AND FOLLOWED THE DISPATCHER'S INSTRUCTIONS AND ATTEMPTED FIRST AID UNTIL EMERGENCY PERSONNEL ARRIVED ON SCENE.

MR. KERTESZ TOLD ME THAT HE FELT THAT HIS SON, JASON, HAD KILLED HIS WIFE. HE ELABORATED BY SAYING THAT JASON HAD A DRUG PROBLEM AND HAD ALREADY STOLEN THEIR OTHER VEHICLE, A WHITE KIA OPTIMA, AND HAD GIVEN IT TO A MAN HE OWED MONEY TO. HE FURTHER STATED THAT HIS WIFE'S RENTAL CAR, A WHITE HYUNDAI SONATA, WAS MISSING. HE ADVISED THAT HIS WIFE HAD SEVERAL CREDIT CARDS AND A BANK OF AMERICA ATM CARD, AND ASKED THAT I CHECK TO SEE IF THEY WERE IN HER PURSE. THE PURSE APPEARED TO HAVE BEEN RIFLED THROUGH, AND THERE WERE NO CREDIT CARDS THERE. THE KEYS TO THE HYUNDAI SONATA WERE NOT THERE EITHER. MR. KERTESZ STATED THAT HE KNEW THAT JASON HAD BOUGHT "CRACK" COCAINE

Before me this date personally appeared LOPEZ, GINA (2801) who being first duly sworn deposes and says that on _____ day of _____, (year) _____ at 2421 N 57TH WAY, HOLLYWOOD, FL (crime location) the above named defendant committed the above offenses charged and the facts showing probable cause to believe the same are as follows:

IN THE LIBERIA AREA BEFORE, AND HE BELIEVED THAT THE KIA OPTIMA AND POSSIBLY JASON MAY BE IN THAT AREA.

MR. KERTESZ STATED THAT THE FRONT DOOR TO THE HOUSE HAD BEEN LOCKED WHEN HE GOT HOME, AND THAT HE HAD TO UNLOCK THE BOTTOM LOCK WITH HIS KEY TO ENTER THE HOUSE. THERE WAS NO SIGNS OF FORCED ENTRY ANYWHERE INTO THE HOUSE.

THE VICTIM STILL HAD ALL OF HER JEWELRY ON HER AT THE TIME SHE WAS DISCOVERED. NOTHING ELSE IN THE HOUSE APPEARED TO HAVE BEEN TOUCHED OR DISTURBED OTHER THAN A DRAWER IN THE VICTIM'S BEDROOM WHICH CONTAINED PAPERWORK REGARDING HER CREDIT CARD ACCESS NUMBERS AND PIN INFORMATION. OTHER ITEMS OF VALUE WERE PRESENT AND NOT DISTURBED. THE ONLY PERSONS WITH KNOWLEDGE OF THE LOCATION AND IMPORTANCE OF THOSE ITEMS WAS WOULD BE THE VICTIM, HER HUSBAND, JOHN, AND THEIR SON, JASON.

WHILE SEARCHING THE HOUSE PURSUANT TO A SEARCH WARRANT, A SOFTBALL BAT WAS DISCOVERED IN THE MASTER BATHROOM'S BATHTUB. IT APPEARED TO HAVE BEEN CLEANED RECENTLY, AND THE FLOOR OF THE BATHROOM WAS STILL SLIGHTLY WET. THE BASEBALL BAT WAS LATER FOUND TO BE THE PROPERTY OF SEAN KERTESZ, THE VICTIM'S OTHER SON, AND HAD BEEN STORED IN A ZIPPERED BAT BAG IN THE CLOSET OF THE ROOM THE VICTIM WAS DISCOVERED IN. THE ONLY PERSON OR PERSONS WITH KNOWLEDGE OF THIS WOULD BE MEMBERS OF THE FAMILY, INCLUDING JASON KERTESZ. LATER PROCESSING OF THE AFOREMENTIONED BAT AND BATHTUB REVEALED THE PRESENCE OF BLOOD IN THE AREA AROUND WHERE THE BAT WAS FOUND. A SEARCH OF THE BEDROOM BELONGING TO JASON REVEALED THE PRESENCE OF BLOOD TO BE DETECTED IN HIS BATHROOM SINK. IN ADDITION, A PAIR OF WHITE BASKETBALL SHORTS WAS DISCOVERED WITH WHAT APPEARED TO BE A BLOOD TRANSFER ON THEM WERE DISCOVERED ON HIS BED. A PRESUMPTIVE TEST OF THIS STAIN CONFIRMED THE PRESENCE OF BLOOD.

AN EXIGENT REQUEST WAS SENT TO A, T & T FOR THE PHONE RECORDS ASSOCIATED WITH THE VICTIM'S CELL PHONE. ONE OF THE NUMBERS CONTACTED WAS THE FRIENDLY CHECKER CAB

Before me this date personally appeared LOPEZ, GINA (2801) who being first duly sworn deposes and says that on _____ day of _____, (year) _____ at 2421 N 57TH WAY, HOLLYWOOD, FL (crime location) the above named defendant committed the above offenses charged and the facts showing probable cause to believe the same are as follows:

COMPANY. CONTACT WAS MADE WITH FRIENDLY CHECKER AND THEY INDICATED THAT THE NUMBER WITH CALLER ID "IRENE KERTESZ" HAD CALLED BUT A YOUNGER WHITE MALE HAD BEEN PICKED UP TWO TIMES; ONCE, AT 1734 MCKINLEY STREET AND AGAIN AT THE SUPER BUDGET INN. ONE TIME HE WAS TAKEN TO THE HESS GAS STATION, LOCATED AT 1840 N. FEDERAL HIGHWAY, WHERE HE USED THE ATM MACHINE THERE. VIDEO OBTAINED FROM THE HESS STATION'S SURVEILLANCE SHOWED AN INDIVIDUAL MATCHING THE PHYSICAL APPEARANCE OF JASON KERTESZ USING THE MACHINE. THESE PHOTOS WERE LATER IDENTIFIED AS JASON KERTESZ BY BEVERLY RODRIGUEZ AND RAY FRAZIER. A CHECK OF THE VICTIM'S CREDIT CARD USAGE INDICATED THAT ONE OF HER CARDS WAS USED AT THE ATM AT THE HESS GAS STATION LOCATED AT 1840 N. FEDERAL HIGHWAY ON MORE THAN ONE OCCASION, BUT INCLUDED THE TIME THAT COINCIDED WITH THE FRIENDLY CHECKER CAB CALL. THE VICTIM'S CAPITAL ONE CREDIT CARDS WERE USED ON THE DAY THE VICTIM WAS MURDERED BY JASON KERTESZ BEGINNING AT 1538 HOURS AT SHERIDAN PLAZA WHICH IS APPROXIMATELY TWO BLOCKS FROM THE VICTIM'S RESIDENCE, THEN AGAIN AT 1552 AT THE CHEVRON STATION LOCATED AT 4051 STIRLING ROAD, THEN AGAIN AT 1838 HOURS AT THE HESS GAS STATION LOCATED AT 1840 N. FEDERAL HIGHWAY. ALL OF THESE WERE CAPTURED ON SURVEILLANCE CAMERAS AND RECORDED. WHILE WE WERE ATTEMPTING TO LOCATE JASON KERTESZ, IT WAS DISCOVERED THAT HE HAD TWO ACTIVE WARRANTS FOR HIS ARREST. LATER IN THE MORNING ON MONDAY, AUGUST 1, 2011, WE RECEIVED A CALL FROM CRIMESTOPPERS THAT JASON KERTESZ WAS SITTING IN FRONT OF 1734 MCKINLEY STREET, AND THAT HE WAS DISTRAUGHT. BEFORE WE ARRIVED, JASON GOT INTO A FRIENDLY CHECKER CAB AND LEFT THE AREA. CONTACT WAS MADE WITH FRIENDLY CHECKER CAB DISPATCH AND ADVISED THAT THE CAB WAS ENROUTE TO GULFSTREAM PARK. WE BEGAN TRYING TO LOCATE THE CAB IN QUESTION BUT PRIOR TO US CATCHING IT, JASON KERTESZ GOT NERVOUS AND JUMPED OUT NEAR AVENTURA HOSPITAL AND FLED THE AREA ON FOOT. Probable Cause Affidavit

Before me this date personally appeared LOPEZ, GINA (2801) who being first duly sworn deposes and says that on _____ day of _____, (year) _____ at 2421 N 57TH WAY, HOLLYWOOD, FL (crime location) the above named defendant committed the above offenses charged and the facts showing probable cause to believe the same are as follows:

TIME WERE FOUR CREDIT CARDS WITH IRENE KERTESZ'S NAME ON THEM. HE ALSO HAD A BLUE SCULLY CAP THAT MATCHED ONE HE WAS SEEN WEARING IN THE VIDEO SURVEILLANCE OF HIM USING THE ATM MACHINE.

DETECTIVE SPARKMAN AND I ATTEMPTED TO SPEAK WITH JASON KERTESZ AT THE AVENTURA POLICE DEPARTMENT, BUT HE STATED HE HAD NOTHING TO DISCUSS WITH US AND WOULD NOT SPEAK WITH US WITHOUT AN ATTORNEY PRESENT. THESE DETECTIVES HAD NO FURTHER DISCUSSION WITH THE ARRESTEE.

I THEN WENT BACK TO 1734 MCKINLEY STREET AND MADE CONTACT WITH BEVERLY RODRIGUEZ AND RAY FRAZIER. BEVERLY RODRIGUEZ HAD MADE CONTACT WITH THE INITIAL RESPONDING OFFICERS AND ADVISED THEM THAT SHE HAD CONTACTED CRIMESTOPPERS AND 911 TO ADVISE OF JASON KERTESZ'S LOCATION. SWORN STATEMENTS WERE TAKEN FROM THEM AND RAY FRAZIER STATED THAT ON JULY 30, 2011, THE DATE OF THE MURDER, IN THE EARLY EVENING, JASON KERTESZ HAD ARRIVED AT THEIR APARTMENT WITH A HIS MOTHER'S VEHICLE AND A POCKETFUL OF MONEY. HE ALSO HAD CREDIT CARDS IN HIS POCKET, AND WHEN THEY ASKED WHOSE THEY WERE, HE TOLD THEM THAT HE HAD STOLEN THEM FROM A "JOHN" OF A KNOWN PROSTITUTE, KRISTIN MCNEIL. RAY FRAZIER FURTHER ADVISED THAT HE RODE IN THE CAR WITH JASON AND WAS PRESENT WHEN JASON RECEIVED SEVERAL PHONE CALLS FROM HIS FATHER. RAY HEARD JASON TELL HIS FATHER THAT HIS MOTHER WAS TAKING A NAP, AND THEN LATER THAT SHE MUST HAVE GONE OUT, EVEN THOUGH JASON WAS IN POSSESSION OF THE CAR. RAY ADVISED THAT JASON THEN TOLD HIM THAT HE HAD TO GET RID OF THE CAR, AND HE PARKED IT IN THE 1900 BLOCK OF THE ALLEYWAY BETWEEN POLK STREET AND BUCHANAN STREET.
