Effective immediately, you are suspended from your position as the Chief of Police pursuant to Section 26 of the City Charter of the City of Miami. I have taken this action because you have failed to obey my orders and have taken other actions that indicate just and reasonable cause to demonstrate that you cannot properly perform your duties as the Chief of Police. Those actions include:

- You directed three police staff members in your administration be stripped of all responsibilities thereby circumventing my express directive to "hold off" on their demotions.
- You have continued to disregard my request about reducing overtime expenses by organizational restructuring and adjustments to deployment of resources consistent with the policy directives I have communicated to you.

During the time of your suspension, you may not issue any commands, orders or directives. remove or destroy any records materials or equipment of the City of Miami, use any City equipment, enter the premises of any City of Miami Police Facilities or exercise direction or control in any way over the Police Force of the City of Miami and its members.

I shall immediately inform the City Commission of my decision and the cause of suspension. The City Commission will, within five (5) days from the date of receipt of my notice, proceed to provide you with an opportunity to be heard in defense of the charges.

If after a full hearing, the Commission determines the charges are well grounded, then the commission will enter its affirmative judgment which is final. When the affirmative judgment of the commission is entered, your suspension immediately becomes a removal, but, if the judgment of the commission is in the negative, the suspension ceases, and you will be reinstated.

When we met this past Monday and I notified you about making changes to my senior staff, you indicated to me that you had no problems with it as long as I did not seek personnel from outside the police department. I assured you that this was not the case, and that I simply needed to make changes to my staff due to some legitimate concerns which were adversely affecting police operations.

However, when I met with you yesterday to have the documents finalized, you advised me that I could not make changes to my senior staff at this time, and that you would let me know when I would be able to do so.

The restrictions you have imposed on me in regard to the selection, placement and movement of my senior staff will necessitate that I circumvent or bypass the authority of selected staff members in order to ensure that the goals of the police department are not compromised. Obviously ,this is not the optimal way to run any organization and I ask that you furnish me with a date certain as to when the requested personnel changes can take place, which will restore the ability for the police department to operate as intended.

Referencing my prior email of August 2, 2011 and your email response of August 3, 2011, concerning Lieutenant Luis Cabrera, as I informed you, Lieutenant Cabrera still shows as the Deputy Chief of Police in the city's system, when in fact I requested and was granted permission in November 2010, to roll him back to his civil service rank of lieutenant, something that he also requested in writing. In essence, the police department staffing reflects one Deputy Police Chief and three Assistant Police Chiefs, for which we are not budgeted and I do not need. I reiterate my previous assertion that Mr. Cabrera either returns to the police department as a lieutenant, or he resigns his position in the police department and is rehired as an Assistant City Manager.

We have reviewed the overtime expenditures in the police department.

As we dicussed previously, most of the overtime costs derive from the fact that we currently have 54 officers less than we had the previous year, this is a 5% reduction in the number of police officers in the police department. To fill minimum staffing requirements, which ensure high visibility in our neighborhoods and officer safety, we have had to utilize overtime. I will stress, just as I did at our previous meeting that representatives of the Fraternal Order of Police (FOP) were present, there has been significant savings to the city at the other end as a result of salary savings caused by the 54 police officer vacancies. The Tactical Operations Section has played a vital and pivotal role in keeping crime under check. The reassignment of these officers to patrol isn't that simple, while it will save on overtime costs, there may be a significant increase in crime in our city. The plan that you are asking that we implement, which was the brainchid of the president and vice-president of the FOP, will save money, which is that organization's primary concern at time of negotiations, disregarding its effect on crime or officer safety, something I see as a priority.

Furthermore, I want to point out that there is no budget in the police department for overtime costs associated with the Three Kings Parade, the Martin Luther King Parade, the Jose Marti Parade and other similar events, as such we have had to absorb these overtime expenditures that total hundreds of thousands of dollars. I was assured by your predecessors that the department would be reimbursed for these costs, but that did not materialize.

In the next few weeks, I anticipate that we will be able to hire the first 16 of the 53 officers that I requested last year, this should help with our shortages. As requested, I will make the personnel changes you cited in your email, but in that case, I will not be held accountable for the increase in crime. I will also forward the documents you requested.
