**PLEA AGREEMENT**

COMES NOW KATHERINE FERNANDEZ RUNDLE, State Attorney of the Eleventh Judicial Circuit of Florida, by and through the undersigned Assistant State Attorney, and hereby enters into this contract for a plea agreement ("agreement") with the defendant, JUSTIN DREW BIEBER ("defendant"), and his attorneys, Roy Black, Howard Srebnick and Mark A.J.Shapiro. This agreement shall become enforceable against the respective parties after its ratification and acceptance by Judge William Altfield. The defendant is presently charged with one count of Resisting Arrest Without Violence, one count of Driving Under the Influence, and one count of Driving with an Expired Driver's License, in case numbers B14-2900, A10S5SE, and A10WN7E, respectively.

The terms of this agreement are as follows:

1. As to the charge of Driving Under the Influence, case number A10S5SE, the defendant shall plead guilty to a reduced charge of Careless Driving. In exchange for his plea, the defendant shall be adjudicated guilty. In addition, he agrees to complete the following special conditions:
  - 1) Complete YOUIMPACT victim impact program;
  - 2) Pay a \$500.00 fine;
  - 3) Attend twelve (12) hours of Anger Management Classes; and
  - 4) Pay all court costs associated with this case
2. As to the charge of Resisting Arrest Without Violence, case number B14-2900, the defendant shall plead guilty and shall be adjudicated guilty. In addition, he agrees to complete the special conditions specified in paragraph 1, concurrently and coterminously with the Careless Driving

count.


3. As to the charge of Driving with an Expired Driver's License, case number A10WN7E, the defendant has provided proof that he presently has a valid driver's license. The State will agree to nolle prosequere this charge.
4. Should the defendant fail to complete any of the conditions of this agreement, the defendant may be charged with contempt of court as governed by Rule 3.840, Florida Rules of Criminal Procedure.
5. The defendant agrees that he has discussed the possible immigration consequences of accepting this agreement with his attorneys and further understands that if he is not a United States citizen the Immigration and Naturalization Service will consider this conviction in any deportation decision.

The defendant fully understands all the terms and conditions of this agreement and freely, knowingly, and voluntarily agrees to abide by the terms of this agreement.

WHEREFORE, the Office of the State Attorney and the attorneys for the defendant do hereby move this Honorable Court to accept and ratify this agreement.

DEFENDANT'S PLEA OF GUILTY IN ABSENTIA

THE DEFENDANT, Justin Drew Bieber, pursuant to Florida Rules of Criminal Procedure 3.172 and 3.180(d), hereby changes his previously entered plea of "not guilty" in the above captioned case, to guilty, in absentia. In conjunction with, and in furtherance of the defendant's change of plea in absentia, the defendant acknowledges and states, under oath, the following:

1. I am the defendant in the above captioned case. I wish to change my previously entered plea of "not guilty," to guilty.
2. I am changing my plea to guilty freely and voluntarily and of my own accord with full understanding of all the matters set forth in this pleading, because I am guilty of the charge of Resisting Arrest Without Violence and Careless Driving, and believe that doing so is in my best interest.
3. I am twenty years old and have earned a high school equivalency certificate. I do not suffer from any physical or mental health issues, nor am I under the influence of any drugs or intoxicants which might prevent me from knowingly and intelligently entering into this plea.

4. For the purposes of this plea, I hereby stipulate that there is a factual basis in support of the charge.

5. Other than the terms of the negotiated plea agreement between myself and the State of Florida, no other promises have been made to me nor suggested that I will receive a lighter sentence or any other form of leniency if I enter this plea. No one has subjected me to any force, duress, threats, intimidation, or pressure to compel or induce me to plea guilty.

The terms of the negotiated settlement are as follows:

a) I will plead guilty to a reduced count of Careless Driving, a civil traffic infraction, and I will be adjudicated guilty;

b) I will plead guilty to Resisting Arrest Without Violence, a first degree misdemeanor, and I will be adjudicated guilty;

c) The remaining count of Driving with an Expired Driver License, will be nolle prossed;

d) I will pay a fine of \$500.00 and all attendant Court Costs;

e) I will attend and successfully complete at least 12 hours of anger management counseling, administered by a qualified professional counselor;

f) I will participate in, and successfully complete, the "You Impact" program, which I may attend on-line.

6. I understand that if I willfully fail to complete any of the conditions of the plea agreement in this case, I will be subject to contempt of court proceedings and, if determined to be in contempt, could be sentenced to any possible sanction permitted under law, up to and including 6 months of incarceration.

7. I am represented by attorneys Roy Black, Howard Srebnick and Mark A.J. Shapiro, who have fully explained to me the nature of the charges against me, the consequences of changing my plea

to guilty, and that if I decided to proceed to a trial on the charges now pending against me, the maximum possible penalty, if found guilty on each charge, is a total of one year and 240 days of incarceration, plus fines, to wit:

- Driving Under the Influence: A term of imprisonment not exceeding 180 days and a \$1,000 fine.
- Resisting Arrest Without Violence: A term of imprisonment not exceeding one year or a \$1,000 fine.
- Driving on an Expired Driver License (Greater than 6 months): A term of imprisonment not exceeding 60 days and a \$500.00 fine.

8. I understand that I have the right to persist in my plea of not guilty, the right to receive a speedy and public trial, the right to be tried by a jury, the right to have a lawyer represent and assist me throughout all stages, the right to compel the production of evidence and the attendance of witnesses to testify on my behalf, the right to confront and cross-examine all witnesses against me, and the right to testify on my own behalf or not to testify or be compelled to incriminate myself. Furthermore, I understand that a jury, at my request, will be told that my decision not to testify may not be considered as evidence of guilt against me.

9. I understand that by pleading guilty, there will not be a further trial of any kind, and that by pleading guilty, I am waiving my right to a trial.

10. I understand that upon entering my plea of guilty, without express reservation of the right to appeal, I am giving up my right to appeal all matters related to the judgment, including the issue of guilt or innocence, and may only seek review by collateral attack.


11. I understand that because I am not a citizen of the United States of America, my plea of guilty will be considered by Immigration officials in any deportation proceedings, and may subject me

to deportation pursuant to the laws and regulations governing the United States Immigration and Naturalization Service.

12. I understand that if the offense to which I am pleading is one for which automatic, mandatory driver's license suspension or revocation is required by law to be imposed, my plea of guilty will provide the basis for the suspension or revocation of my driver's license.


13. I request that the Court accept my plea in absentia and acknowledge that in so doing will adjudicate me guilty and impose all of the above-stated terms and those stated in the written plea agreement, executed by me and incorporated by reference herein. I hereby waive my right to be present in court and to offer anything in mitigation prior to sentencing.

I am satisfied with my attorneys' representation of me.
