

75 EXPRESS LANES

Project Overview

The Florida Department of Transportation (FDOT) has constructed express lanes along I-75 from north of NW 138th Street, in Miami-Dade County, to I-595 in Broward County. Construction for the express lanes began in August 2014 and are anticipated to be opened to traffic March 2018.

The four-lane tolled facility has been constructed in the existing I-75 median, and is separated from the general use lanes by a grass median buffer. The express lanes feature two lanes in each direction, divided by a concrete barrier wall, and also include full width paved shoulders.

The express lanes direct connection ramps for 595 Express and the Homestead Extension of Florida's Turnpike (HEFT) are also scheduled to open to traffic in March 2018. Please note, construction for several other proposed ramp movements along HEFT will continue into late 2018, early 2019.

The estimated overall construction cost for the I-75 Express Lanes Project is \$485 million.

Project Key Components

- Express lanes direct connections to 595 Express, Palmetto Express* and HEFT
- Express lanes entrance and exit ramps
- Integrated ITS (Intelligent Transportation System)/Tolling systems
- Sound barrier walls along residential neighborhoods
- · Emergency access for first responders
 - * The Palmetto Express has tentatively been scheduled to open in fall 2018.









Project Benefits

This project will expand the existing express lanes system as part of the South Florida Regional Managed Lanes Network which will improve mobility, relieve congestion and provide additional travel options along the existing I-75 corridor.

The Florida Department of Transportation is implementing express lanes along 28 miles of the I-75 and State Road (SR) 826 (Palmetto Expressway) corridors, from just south of the SR 836 (Dolphin Expressway), in Miami-Dade County, to I-595 in Broward County.

Express Lanes Use

Customers will be able to access the express lanes at designated entry and exit points only. Destinations and the corresponding express lanes toll will be posted on electronic signs well in advance of the entrance, giving customers plenty of time to choose whether or not to use the express lanes. Upon entering the express lanes, customers will pay the toll amount displayed on the sign until reaching the next decision point. Customers will never pay a higher toll amount than the rate displayed on the sign. If the toll decreases after entering the express lanes, customers will pay the lower amount until they reach the next decision point.

Express Lanes Entry & Exit Points

Northbound Entrance Ramps

- North of NW 138th Street
- Direct Connect Ramp from Turnpike NB
- Turnpike SB (Opening Winter 2018/2019)
- · North of Sheridan Street

Northbound Exit Ramps

- South of SR 820/Pines Boulevard
- South of SR 818/Griffin Road
- South of I-75, I-595, SR 869/Sawgrass Expressway Interchange
- Direct Connect Ramp to 595 Express EB (Weekdays a.m. and Weekends)

Southbound Entrance Ramps

- Direct Connect Ramp from 595 Express WB (Weekdays p.m.)
- South of I-75, I-595, SR 869/Sawgrass Expressway Interchange
- · South of SR 818/Griffin Road
- South of SR 820/Pines Boulevard

Southbound Exit Ramps

- · North of Sheridan Street
- Turnpike NB (Opening Winter 2018/2019)
- · Direct Connect Ramp to Turnpike SB
- North of NW 138th Street

Express Lanes Tolls

The 75 Express Lanes are similar to other express lanes facilities, such I-595 Express and 95 Express. Although, the tolling exemptions implemented along 95 Express will not be implemented on 75 Express, as these lanes are not a part of the High Occupancy Vehicle (HOV) lane conversion program that exempts certain vehicles from paying tolls.

Tolls in the express lanes will be collected electronically. Therefore, you must have an active, properly mounted SunPass or other interoperable transponder as no cash or TOLL-By-Plate is accepted in the express lanes.
