UPON ARRIVAL I MADE ENTRY WITH OTHER OFFICERS INTO THE FIRST FLOOR OF BUILDING ONE. WE CONTINUED TO CLEAR THE FIRST AND SECOND FLOOR OF BUILDING ONE ENCOUNTERING NUMEROUS TEACHERS, ADMINISTRATORS, AND STUDENTS. WE THEN MOVED UPSTAIRS TO THE SECOND FLOOR OF BUILDING TWO. WE AGAIN ENCOUNTER MULTIPLE TEACHERS AND STUDENTS WHO WERE HIDING INSIDE ROOMS AND CLOSETS. IT SHOULD BE NOTED THAT I DID NOT COME ACROSS ANY PERSONS WHO WERE INJURED OR DECEASED DURING THIS PROCESS. I DID NOT CONDUCT ANY FURTHER INVESTIGATION INTO THIS INCIDENT.

ON 2/14/18 AT APPROXIMATELY 1515 HOURS, I RESPONDED TO MARJORY STONEMAN DOUGLAS HIGH SCHOOL IN REFERENCE TO AN ACTIVE SHOOTER CALL. WHILE EN ROUTE TO THE SCHOOL, DISPATCH COMMUNICATED THAT THE SUSPECT, LATER IDENTIFIED AS NIKOLAS CRUZ, WAS OBSERVED IN THE AREA OF WYNDHAM LAKES BLVD AND CORAL RIDGE DRIVE. I REDIRECTED TO THE AREA AS OFFICERS WERE TAKING CRUZ INTO CUSTODY. WHILE ON SCENE, I ASSISTED WITH TRAFFIC CONTROL, SCENE SECURITY AND MEDIA STAGING OUTSIDE OF THE GOLDEN BAY RESIDENTIAL COMMUNITY (11700 WYNDHAM LAKES BLVD SOUTH).

ON 2/14/18, AT APPROXIMATELY 1430 HRS I RESPONDED TO MARJORY STONEMAN DOUGLAS HIGH SCHOOL REFERENCE TO AN ACTIVE SHOOTER. UPON ARRIVAL, I PARKED AT THE SOUTH GATES OF THE SCHOOL AND DEPLOYED MY DEPARTMENTAL ISSUED AR-15 RIFLE. UNKNOWN AT THIS TIME WHERE THE ACTIVE SHOOTER WAS LOCATED, I STARTED CLEARING THE BUSES LOCATED IN THE SOUTH PARKING LOT. WHILE CLEARING THE BUSES, I CAME IN CONTACT WITH BUS DRIVERS AND DIRECTED THEM OFF THE BUS AND SENT THEM TOWARDS DET. HALLMAN, WHO ASSISTED THEM OFF SCHOOL GROUNDS. ONCE THE BUSES WERE CLEARED, I STARTED CHECKING THE PORTABLES WITH SGT. REID AND DET. DELUCA. ONCE THE PORTABLES WERE CLEARED, I ASSISTED THE OFFICERS AND DEPUTIES WITH SECURING THE SOUTH SIDE OF THE SCHOOL WHILE THE CLASSROOMS WERE BEING CHECKED BY SWAT PERSONNEL.

AFTER CLEARING THE SCENE, I RESPONDED TO THE HERON BAY MARRIOTT WITH DETECTIVES FROM CIU TO COORDINATE WITH FBI FOR INTERVIEWING THE STUDENTS WHO WERE INSIDE THE SCHOOL. ONCE THE INTERVIEWS WERE COMPLETED BY THE DETECTIVES, I CLEARED THE SCENE. I HAD NO FURTHER INVOLVEMENT IN THE CASE.

ON 2/14/18 AROUND 1500 HOURS, I RESPONDED TO AN ACTIVE SHOOTER AT STONEMAN DOUGLAS HIGH SCHOOL. I TOOK UP A PERIMETER POSITION IN THE SHOPPING CENTER IN THE 5600 BLOCK OF CORAL RIDGE DRIVE AS I WAS INFORMED THE SHOOTER WAS STILL AT LARGE. INFORMATION WAS THEN PROVIDED THAT THE SHOOTER WAS POSSIBLY IN THE MCDONALD'S LOCATED IN THE SHOPPING CENTER I WAS AT. OTHER UNITS IMMEDIATELY CONVERGED ON THE MCDONALD'S WHILE I MAINTAINED MY PERIMETER POSITION DUE TO THE POSSIBILITY THE SHOOTER WAS INSIDE ONE OF THE BUSINESSES I WAS IN FRONT OF OR WITHIN THE PARKING LOT. THE SUSPECT WAS NOT LOCATED AT MCDONALD'S. ONCE THE SUSPECT WAS DETAINED AT A NEARBY LOCATION, I RESPONDED TO THE HERON BAY MARRIOTT TO ASSIST BUSES THAT WERE GOING TO DROP PEOPLE OFF FROM THE SCHOOL. I POSITIONED MY VEHICLE WITH LIGHTS ACTIVATED IN THE CENTER MEDIAN OF THE PARKING LOT ENTRANCE TO ASSIST IN DIRECTING THE BUSES INTO PARKING LOT.

ONCE BUSES ARRIVED, I ASSISTED IN ESCORTING STUDENTS AND ADULTS TO THE SIGN IN TABLES.

AROUND 1800 HOURS, I RELIEVED BSO DEPUTY C. NEVES AT ONE OF THE SIGN IN TABLES AND SIGNED IN INDIVIDUALS WHILE CONDUCTING PRELIMINARY INTERVIEWS TO DISTINGUISH BETWEEN WITNESSES AND NON-WITNESSES THAT WERE BEING SEPARATED.

I WAS LATER RELIEVED OF SIGN IN DUTIES AND ASSISTED SORTING INDIVIDUALS ENTERING THE BUILDING AND TRAFFIC CONTROL IN THE PARKING LOT. THIS TASK WAS LATER TURNED OVER TO BSO.

On Wednesday, February 14, 2018, I responded to Marjory Stoneman Douglas High School located at 5901 N Pine Island Rd., Parkland, FL after a broadcast report over CSPD Dispatch's main channel of an active shooter on MSD campus.

Upon arrival, I parked my unmarked police vehicle on Pine Island Rd., directly East of the faculty and staff parking lot/bus drop-off. I retrieved my carbine from it's case in my trunk and proceed along the East side of the high school, past buildings 1 and 8. As I approached building 12, I observed CSPD officers enter the East door of building 12. I joined with Detective Winn and moved North and then West along the parking lot and positioned myself to cover the North and West side of building 12 in the event the suspect exited the building or in case shots were fired from a elevated position from the building.

After word was received that the suspect was observed on video exiting the building to the West and South approximately 20 minutes earlier, Detective Winn and I moved further West along building 13 and down to the SW corner of building 13.

I was directed by Captain McKeone to hold that position and cover building 6 while SWAT officers conducted building clearings. As buildings were cleared, I helped to direct students and staff as they egressed the campus to a safe staging area to the North.

Once the scene was secured, I was directed to respond to the Marriott Heron Bay Golf Resort. Upon arrival, contact was made with Sergeant Reid and I was instructed to assist the Victim Advocates from Coral Springs PD, Broward Sheriff's Office, and the Federal Bureau of Investigation. I was released from these duties at 9:30 pm.

I had no further involvement in this case.

I then cleared approximately 2-3 more adjacent buildings and assisted in evacuating more students.
