On Monday, 011413, at approximately 1600 hours, I responded to the Police station regarding a report of delayed assault that occurred in December 0f 2012.

Upon arrival, I met with the reporting party, Lisa Anne Thomas who introduced herself as a former cocktail waitress at the Omphoy Hotel in Palm Beach.

Ms. Thomas requested a police report because she said she was "smacked on the arm" by the owner, Jeff Greene on December 28th at around 5:00pm. She said Jeff Greene walked up to her and "smacked her on the arm" and said, "can you turn down the music." She said she was very offended that he hit her on the arm and later resigned her job. She said she met with her supervisor, and documented the incident with the hotel before she resigned. She said her attorney directed her to file a police report.

I asked her if she had any injuries and if she thought he intended to physically hurt her and if there were any fighting words. Ms. Thomas said "No," but she was offended that Jeff Greene smacked her on the arm and she thought that was inappropriate. I asked her if there was any witnesses and she said "Yes" that information was documented with the hotel. I asked her if she wanted to prosecute and she said "No."

She requested a police report for the purpose of documenting the incident. She was issued a courtesy card with a case number for her records.
