**COUNT 1-DISTRIBUTION OF A CONTROLLED SUBSTANCE - SCHEDULE II(F3)**

**On or about 11/29/2011, Patrick J Sullivan unlawfully, feloniously, and knowingly sold or distributed Methamphetamine, a schedule II controlled substance; in violation of section 18-18-405(1),(2)(a)(I)(A), C.R.S.**

**COUNT 2-ATTEMPT TO INFLUENCE A PUBLIC SERVANT(F4)**

**On or about 9/20/2011, Patrick J Sullivan unlawfully and feloniously attempted to influence Officers and Employees of the Arapahoe County Sheriff's Department , a public servant, by means of deceit, with the intent thereby to alter or affect the public servant's decision, vote, opinion, or action concerning a matter which was to be considered or performed by the public servant or the agency or body of which the public servant was a member; in violation of section 18-8-306, C.R.S.**

**COUNT 3-POSSESSION OF METHAMPHETAMINE - 2 GRAMS OR LESS(F6)**

**On or about 11/29/2011, Patrick J Sullivan unlawfully, feloniously, and knowingly possessed two grams or less of a material, compound, mixture, or preparation that contained Methamphetamine, a controlled substance; in violation of section 18-18-403.5(1),(2)(b)(I), C.R.S.**


**COUNT 4-PROSTITUTION - SOLICITING(M3)**

**On or about 11/29/2011, Patrick J Sullivan unlawfully solicited another for the purpose of prostitution; in violation of section 18-7-202, C.R.S.**
