**10. CHARGE I: Violation of the UCMJ, Article 80**

Specification: In that AIR FORCE CADET STEPHAN H. CLAXTON, United States Air Force, Cadet Squadron 34, United States Air Force Academy Cadet Wing, did, at or near the United States Air Force Academy, Colorado, on or about 4 November 2011, attempt to engage in sexual contact with [REDACTED] by unbuttoning and unzipping her pants while she was substantially incapacitated.

**CHARGE II: Violation of the UCMJ, Article 92**

Specification: In that AIR FORCE CADET STEPHAN H. CLAXTON, United States Air Force, Cadet Squadron 34, United States Air Force Academy Cadet Wing, who knew of his duties did at or near the United States Air Force Academy, Colorado, between on or about 1 March 2011 and on or about 31 March 2011, was derelict in the performance of those duties in that he willfully failed to refrain from drinking while under the legal age of 21, as it was his duty to do.

**CHARGE III: Violation of the UCMJ, Article 120**

Specification: In that AIR FORCE CADET STEPHAN H. CLAXTON, United States Air Force, Cadet Squadron 34, United States Air Force Academy Cadet Wing, did, at or near the United States Air Force Academy, Colorado, between on or about 1 March 2011 and on or about 31 March 2011, engage in sexual contact with Air Force Cadet [REDACTED] to wit: placing Air Force Cadet [REDACTED] hand on his penis, and such sexual contact was without legal justification or lawful authorization and without the permission of Air Force Cadet [REDACTED]
