Probable Cause:

On 05-15-12, at approximately 0103 hours reporting officers Vonfeldt 97003 (311A) and myself Ofc. Foust 96028 (313A) were dispatched to 6 Clermont St. on a physical domestic in progress. The roommate called 911 because she heard a bang and the victim asked her to call. The victim then got on the phone reporting that her hand was hurt.

Upon arrival, the suspect later identified as EDDIE FISHER (12-17-73) waved down Ofc. Vonfeldt as he arrived on scene. Upon contact, with the suspect he had a small laceration in the middle of his forehead with a small amount of fresh blood. He related that his girlfriend was acting hysterical and had trapped him in the bathroom. He reported that she struck him several times in the head. He then had to jump over her to get away. He went on to say that he was trying to get in his car and leave when the victim came outside and took his dog.

The roommate and original caller (07-88) reported that she heard the victim and suspect come in around 2315 hours and could hear the two arguing and fell back asleep. She reported that he (FISHER) tried to leave several times but she () would follow him outside and not let him leave. She (Engel) heard her () yell at the suspect (FISHER) to leave several times and she heard FISHER yell at her once. Then () came down to her () room and at told her to call the cops and that he had hurt her and took her phone. She observed the bathroom sink off the wall and saw that the victim's finger and lip were bleeding. She related that the two have been going out for approximately two months and she had just recently learned that he (FISHER) had been cheating on her.

While trying to determine what happened we were able to speak to the 7 year old who told us she saw "EDDIE" trying to get into the

· bathroom and eventually did. She heard a commotion but did not see what happened in the bathroom. She also told us "she" did not do anything and that it was all Eddie.

The victim related that they had been coming home from the bar and that she had received a text and he (FISHER) got upset because he thought she was cheating on him. When they arrived at 669 N. Clermont St. (house) they had a verbal argument and that escalated into FISHER grabbing her by the head and throwing her down. The victim) then grabbed the keys and the dog and ran into the house to hide. She ran into the bathroom and put her back against the door and braced herself with her feet on the sink cabinet. He continued to force the door until the cabinet broke off the wall and he gained access. The suspect continued to go after the victim until she threatened to call the cops at which point she left and she was able to go down stairs and have Engel call 911.

The suspect was transported to DHMC due to his intoxication and minor injury. The victim was also transported to DHMC for her injuries which were a bruise on her left tricep area, left thigh bruise, a cut lip, and an abrasion on her hand. The cabinet housing the sink had been broken off the wall and pushed halfway down to the floor.

The suspect and victim have been dating for approximately two months.
