Half Weld County Sheriff's Office, being duly aworn upon oath says that

there is probable cause for the warrantless arrest of the above named defendant for the charge(s) stated above, and that the following facts and all information entered above are true and correct to the best of his/her knowledge, information, and belief and support the arrest of the defendant:

The following event occurred in Weld County, Colorado. Your affiant has learned the following facts by personal observations and/or reading police reports, and/or talking with other persons.

On the date of 091412 at approximately 1724 hrs, Weld County Communications received a call where originally they could only hear people screaming that they needed an ambulance. At 1725 hrs, they received information that stated, "brother shot himself." At 1729 hrs, Deputy Stauts arrived on scene at 4237 Grand Teton Road, Greeley, Weld County, State of Colorado. When Deputy Stauts arrived he saw a party later identified as Jordan Limas (06/22/1994) standing on the front porch waving him in.

As Deputy Stauts got into the residence he saw a male party, later identified as Andre Limas (07/19/2001), lying on the floor near the front door. Deputy Stauts saw blood on his shirt and what appeared to be a hole in the upper right portion of Andre's chest. Reserve Deputy Bomar, who was with Deputy Stauts, immediately checked for vital signs on Andre. After no vital signs were found, the Deputies began CPR on Andre. Shortly after beginning CPR, Weld County Paramedics arrived on scene, where they transported Andre to Northern Colorado Medical Center. Andre Limas later succumbed to his injuries and was pronounced deceased at 1819 hrs by Dr. Vickerman.

After Andre was transported by Weld County Paramedics, Deputy Stauts spoke with Jordan Limas. Jordan told Deputy Stauts that while he was inside of the residence, he saw his younger brother Andre Limas come out, as he pointed at a bedroom, with a gun in his hand. He stated he then told Andre that he was not going anywhere with that, and that he thought maybe he was taking it outside to

show his friends. Jordan told Daputy Stauts that he struggled to get the gun away from Andre, when the gun went off.

After speaking with Jordan Limas, Deputy Stauts spoke with Latisha Briseno (01/10/1991). Latisha stated that she is Jordan's live in girlfriend. She told Deputy Stauts that at the time of the event, she was in the bathroom. Latisha stated that she heard a gunshot go off and she came out of the bathroom. When she came out of the bathroom, she stated that Jordan was screaming for help and for her to call 911. Latisha stated that she then called 911.

Deputy Scofield later arrived on scene to assist Deputy Stauts. After his arrival, Deputy Scofield placed Jordan Limas in custody and transported him to the Weld County Sheriff's Office where he was interviewed by Detective Korgan-Reed.

Jordan told Detective Korgan-Reed that he stole the gun; a small, black, semi-auto, approximately one month ago. He said that he had the firearm sitting on the dining room table at his residence, when he heard Andre open and close the door from outside. Jordan said when Andre came into the residence, he was originally in his bedroom. As he came out of his bedroom he saw that Andre had picked the firearm up and was going to walk outside where his friends were standing, Jordan stated that he told Andre that the gun was not a toy and Andre told him, "Ys right." Jordan stated that he grabbed the firearm from Andre and there was a struggle for it. He grabbed the gun from Andre and had it in his hand. As Jordan was moving away from Andra, Jordan stated that the gun went off and he heard the shot. He said they then looked at each other and Andre was stating, "Jord, Jord, it hurts." Jordan stated he then saw blood on Andre's shirt. Jordan stated that he then dropped the gun near the front door.

Jordan stated that after Andre was shot, he then grabbed Andre and was holding him. He said that Andre began to lose strength and fell to his kness. Jordan stated that he then took Andre outside and sat him on a chair on the porch, near the front door. Jordan stated that he was screaming, "Call 911, call 911," Jordan stated that Latisha Briseno then came to him and he told her to call 911. He said that Latisha called 911 as well as his grandpa, Mattilde Santillian. He said that after his grandps arrived at the house, his grandps took Andre back inside. As his grandpa was moving Andre inside of the residence, Jordan stated that he picked the gun up and hid ic in his bed.
