In response to your request of April 18, 2012, for transfer to your home country of Saudi Arabia pursuant to the Inter-American Convention on Serving Criminal Sentences Abroad, and as provided for in C.R.S. § 24-60-2301 and in Colorado Department of Corrections (CDOC) Administrative Regulation 550-5 Transfer of Foreign National Offenders to Treaty Nations, I hereby make the following determination:

You were originally sentenced in Arapahoe County to the CDOC on August 31, 2006, for the following crimes: Theft \$15,000 or more, C.R.S. § 18-4-401 (1), (2)(d) (8 years); 12 counts of Sexual Contact- sentence enhancer-Present Threat, C.R.S. §§ 18-3-404 (2), 18-3-402 (4)(b) (20 years-Life); Criminal Extortion, C.R.S. § 18-3-207 (1)(a), (b)(II) (6 years); False Imprisonment-Misdemeanor, C.R.S. § 18-3-303 (6 months); and False Imprisonment-Misdemeanor, C.R.S. § 18-3-303 (12 months). You were received by the CDOC on August 31, 2006, to begin serving your sentence. On February 25, 2011, your sentence was modified from 20 years to Life, to 6 years to Life. This sentence reduction made you immediately eligible for parole, as of January 21, 2011.

It is acknowledged through review of your institutional record that you have involved yourself in several positive activities while incarcerated. You have completed the 7 Habits on the Inside and the Pre-Release programs, you have maintained "satisfactory and above" work ratings in your position in the Pre-Release Program, and have documented positive involvement in the Incentive Unit program at the Limon Correctional Facility.

However, due to the nature of your crime and according to C.R.S. § 18-1.3-1004 (3), each sex offender receiving an indeterminate sentence, shall be required as a part of the sentence to undergo treatment to the extent appropriate pursuant to C.R.S. § 16-11.7-105. Information provided indicates that you have been given multiple opportunities to be screened by the Sex Offender Treatment and Monitoring Program. To date you have declined those opportunities to be assessed for potential placement in treatment. You have reportedly declined based upon religious reasons/conflicts with your Islamic faith. I have reviewed information provided from our Chief of Behavioral Health which indicates that the treatment providers work with offenders

to identify cultural/religious values and beliefs that support their change efforts, and work with religious leaders for advice in resolving identified concerns.

After a thorough review and careful consideration of all information provided to me in this matter, I have decided not to support your request for transfer to Saudi Arabia at this time.

I would encourage you to reconsider your position regarding participation in required treatment. Should you change your mind, you should contact your case manager about initiating the process to be screened for the treatment program. Your successful participation in the Sex Offender Treatment and Monitoring Program would reflect positive progression and, although there can be no guarantees of future determinations, could result in your eventual parole or transfer to a Saudi Arabian prison.
