Probable Cause:

On May 14, 2014 at approximately 4:20 pm Denver Police Officer Greg JUAREZ, 00044 responded to a call for cover from Denver Police Narcotics Detectives at 300 S Eliot Street in the McDonalds parking lot. Detectives Nick ROGERS, 86037, Jaime DISBROW, 98044 and John ROBLEDO, 05122 made the arrest of the suspect who they identified as Isaac VIGIL, dob; 04/09/1982 for Possession of Drug Paraphernalia and a warrant for Assault, Felony Menacing and Possession of a Weapon by Previous Offender in Adams County. The detectives called for cover due to the violent and aggressive behavior of the suspect who they observed smoking suspected methamphetamine. The suspect was constantly moving, thrashing and jumping with both feet off the ground during the search of his clothing incident to his arrest. He made comments of "I'm gonna shoot you" several times to Detective ROBLEDO and "You better have a vest on."

Officer JUAREZ transported the suspect to the District 4 Station after an additional search of the suspect who he described as extremely agitated. While enroute to the station, the suspect, who was in the rear seat cage, continued yelling, kicking the doors and windows of the police car and said, "Fuck you, I'm not going back to jail" and "I've got something for you guys." The suspect told Ofc JUAREZ he had been smoking meth for three days, he was not going back to prison, police would have to kill him and he wanted to die. The suspect told Officer JUAREZ, "I'm gonna kill you" five or six times during the drive to the station.

At the station sally port, the suspect refused to get out of the car and Ofc JUAREZ requested assistance from another officer. Detective ROBLEDO also assisted by going to the rear passenger

door of the car. The suspect told the officers he wasn't getting out of the car and "You're going to hear a pop" as they attempted to pull him out. Officer JUAREZ stated he then saw a muzzle flash as the suspect fired a gun from behind his back and Detective ROBLEDO saw a gun which he thought was pointed at him as the suspect was being pulled out the driver's side rear door.

Officers took cover at the rear of the police car and an additional shot from the suspect was fired. Officer John SISNEROS, 01041 fired one shot at the suspect which he believed struck the suspect. The suspect indicated he was done, but did not follow commands to get out of the car. Officers approached with a shield and removed the suspect from the police car. While on the ground, prior to the paramedic's arrival, the suspect yelled "I have meth up my ass!" He was transported to the DHMC for treatment of a gunshot wound to his abdomen and Officer HOFF, 04048 rode in the ambulance. The suspect screamed he had meth inside him and that it was hurting him. Three baggies of suspected meth were recovered at the hospital and Officer HOFF placed the evidence in the Property Bureau. The preliminary testing (Presumptive Drug Screening) of the recovered suspected drugs completed by the Forensic Chemistry Unit, show the substance to be methamphetamine.

The gun fired by the suspect and recovered from the back seat of Officer JUAREZ'S police car was a Raven P25 Auto .25 caliber handgun with an unknown serial number. The serial number of the gun had been scratched off (defaced). A criminal history check of the suspect showed he has an arrest for Possession of a Weapon by Previous Offender in April 2014 and a felony conviction for Possession of a Weapon by a Convicted Felon in 2002 and sentenced to 4 years in prison.
