

Narrative:

On December 7th, 2015 at approximately 16:06 hours, a school bus carrying 8 passengers (ages ranging from 7-15 year old) was involved in a single vehicle crash on Highway 7 at approximately milepost 25, in Boulder County, CO. The driver (Elizabeth Burris DOB 4-29-76) was reported to be driving erratically and crashed shortly after, rolling the school bus 1/4 times onto its driver's side.

Two of the children (15yr old) on board the bus were confirmed to have serious bodily injury, three of the children had minor injuries and three released without injury.

I responded to the hospital to speak with Burris in regards to the crash. After asking what happened, Burris stated that she didn't remember why the crash happened but was able to recall minor details such as checking the mirrors and making sure she was within her lane. Burris stated that she drifted off of the road, attempted to gain control and over-corrected. Burris showed indicia of drug impairment and stated that she was on about 6 different prescription medications and was unsure if she named them all.

At 18:51 hours, Burris consented to voluntary roadside maneuvers and did not perform them as instructed. Burris consented to a blood draw that was completed at 19:45 hours according to the Department of Health's rules and regulations.

After all processing and medical clearances, Burris was booked into the Boulder County Jail.
