9 Your first conference committee appointed on HB07-1170,
10 concerning the compensation of elected district attorneys, has met and
11 reports that it has agreed upon the following:

13 That the House accede to the Senate amendments made to the bill,
14 as said amendments appear in the rerevised bill, with the following
15 changes:
