- Deputy Chief of Operations for the Denver Police Department (DPD) responsible for overseeing approximately 1,250 officers in six police districts, three investigative divisions, and a civilian crime lab.
- Bilingual (Spanish speaker) individual who values service over self and leads through strong work ethic, integrity, transparency, internal, and external accountability, and a high regard for all segments of the community, by all members of the organization.
- City leader with a community-centered approach, who demonstrates value of police-community relationships through meaningful partnerships and mutual respect.
- Focused on results-oriented problem solving, inclusive collaboration, and innovative solutions through open and honest communication.
- More than 32 years of law enforcement experience with 18 years in command and executive level
  positions with a full understanding of the challenges, demands, responsibilities and opportunities
  associated with leading the Denver Police Department.

## CAREER LEADERSHIP HIGHLIGHTS

## **Collaborations and Community**

- Partnered with the Office of Marijuana Policy on the implementation of citizen driven initiatives related to recreational marijuana and social consumption. Ensured appropriate police systems and resources were in place for enforcement of state and local laws and compliance with the Federal Cole Memorandum.
- Mandated operational responses as part of the city response to the opioid crisis and the influx of heroin use along the heavily traveled bike paths in the heart of the city, and in and around Civic Center Park.
- Represent DPD on task force boards to include Metro Gang (MGTF), Joint Terrorism (JTTF), Front Range (FRTF) and the Rocky Mountain High Intensity Drug Trafficking Area (HIDTA), and served as Budget Committee Chair 2015-2017.
- Served as Mayor's Gang Impact Team Co-Chair on collaboration with federal/state/local law enforcement, other city agencies, community and faith-based organizations to address a spike in gang gun violence. Measurable results **87**% decrease in gang related homicides from 2015 to 2017.
- Collaborator on Junior Achievement (JA) "Kickstart your Future," which works to provide summer alternatives for youth in areas impacted by gang crime.
- Board Member of the Citizen's Appreciate Police (CAP) Board.
- Worked to create MOU between Denver Public Schools (DPS), DPD and community organizations, memorializing collaboration in School Resource Officers selection, management, and responsibilities. This has been recognized as a national model, decreasing the "school to prison pipeline" by focusing on restorative justice practices and decision-making partnerships with DPS.

#### **Innovations**

- Implementation of the Crime Gun Intelligence Center (CGIC), a national model integrating the National Integrated Ballistics Information Network (NIBIN), gunshot detection technology, federal partnerships, and specialized investigations to reduce gun crime.
- Implementation of Clinician Partnership where licensed clinicians partner with officers on calls involving mental health issues in an effort to better serve a population with unique needs.
- Spearheaded a Combined Communication Center (911) and Operations working group designed to review safety response issues and ensure efficient and appropriate utilization of resources and personnel, eliminating costly redundancy. Measurable results 33% reduction in responses to "Welfare Check" calls that did not require a police response, and a 32% reduction in "Flagged Addresses" which unnecessarily require special police response consisting of multiple units.
- Body Worn Camera implementation, including research, pilot study, planned rollout and continued analyses.

- Civilianization to reduce officer workload, enhance proactive availability and crime prevention activity.
   In 2018, Civilian Crash Report Technicians have taken 2400 (31%) of all Crash reports during their hours of operation.
- Created Elder Abuse Unit in collaboration with District Attorney's office to meet new legislative mandates, and boost customer service to senior community members.
- Collaborated with Denver Health Medical Center, Combined Communications Center, and Denver Fire Department to develop a safer response to "Excited Delirium" calls for service.

#### Government

- Conducted all operational aspects of \$230 Million annual budget resulting in surplus funds each year since 2012.
- Presentations to, and collaborations with, Mayor and/or City Council on issues related to police efforts, including the impact of pending legislation and changes to police policy.
- Testified to the Colorado State Legislature as the DPD liaison on multiple issues.
- Responded to several independent audits of various operational issues by the elected City Auditor, including presenting to the Audit Committee.
- Served on management team during contract negotiations for five Collective Bargaining Agreements with the Denver Police Protective Association.

### **Major Events**

- Venue Section Chief for both National Special Security Event (NSSE) sites for the 2008 Democratic National Convention.
- Command officer for multiple large events, including the 2012 Presidential Debates at the University of Denver, the Denver Broncos Super Bowl Victory Parade, the Major League Baseball World Series, multiple NHL/NBA/MLB All Star Games, and various marathons, concerts, and conventions.
- Oversight and strategic planning for safe and appropriate responses to demonstrations and protests arising from social justice issues while effectively collaborating with organizers for successful events through crowd management.
