1. Detective Jesse Rameriz. #61049, the Affiant, state under oath that the facts known to the Affiant which establish probable cause to believe that a criminal offense was committed, and that the offense was committed by the above-named person(s), are the following:

On 11/28/17 your Affiant (A Police Officer for 16 years and currently assigned to the Denver Police Department Major Crimes Bureau, Domestic Violence Unit), was assigned the follow-up investigation of Denver Police Offense Report #2017-794508 completed by Officer Gary Yampolsky #06024.

On 11/27/17, at approximately 1708 hrs., Officer Gary Yampolsky #06024 completed a General Offense Report for Aggravated Assault. Officer Yampolsky conducted the preliminary investigation in this matter by contacting and interviewing the victim, who related that she had been involved in an intimate relationship with the suspect, Leland Pankey (06/29/79), for approximately 3 years.

Ave on a domestic violence call. Steven Sanchez, property manager, called police to say a resident was assaulted by her husband and she is in their office.

Upon arrival, I saw Officer Boutin 01082 was already speaking to the victim. The victim was identified as , stated that her husband of 3.5 years, Leland Pankey 6/29/79, held her down on the couch and began to strangle her. Mr. Pankey was accusing of spying on him by the use of electronic devices.

hard. stated that Mr. Pankey put both of his hands around her neck and began to squeeze very hard. stated that she could not breath and lost consciousness for an unknown amount of time. When came to Mr. Pankey began to strangle her again. lost consciousness again. lost and redness and small scratches on her neck.

After waking up ran to the leasing office. Both children remained at home with Mr. Pankey. suffers from multiple skeletal injuries from a motor vehicle accident in 2015. stated that Mr. Pankey took her driver's license, house keys and car keys, and her credit cards and left the apartment.

Your Affiant contacted the victim, verified the facts of the case. further related that her throat was still sore and she had received several red marks around her neck from the strangulation.

Your Affiant received photos from the victim showing her injuries, red marks/bruising to the front of her neck and also the left side of her neck and face.

The victim positively identified the suspect from a single photo provided by your Affiant.

Based on the aforementioned information, your Affiant respectfully requests that a probable cause arrest warrant be approved for the suspect, Leland Kyle Pankey (06/29/1979), For Second Degree Assault, C.R.S. §18-3-203, a Class 4 Felony
