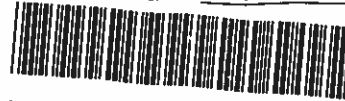

STATEMENT OF PROBABLE CAUSE

ARREST ON TRAFFIC/NATURAL RESOURCES CITATIONS/CRIMINAL CHARGES/MUNICIPAL ORDINANCES/PUBLIC LOCAL LAWS

THE DEFENDANT HAS BEEN ARRESTED UPON THE FOLLOWING INFORMATION OR OBSERVATION: (MAKE A PLAIN, CONCISE AND DEFINITIVE STATEMENT OF ESSENTIAL FACTS CONSTITUTING THE OFFENSE CHARGED)

THE CENTRAL COMPLAINT NUMBER IS 8E- 10210.

ON 19 MAY 2007 AT APPROX. 1915 HRS, I AND OFC.MENDEZ (I042), RESPONDED TO A COMMON ASSAULT CALL AT 500 MT HOLLY ST. UPON OUR ARRIVAL, WE MET MS. JACKIE TAYLOR, WHO OWNS THE RESIDENCE AND DAUGHTER OF THE VICTIM, JOHN TAYLOR - 90 YEARS OLD, WHO STATED THAT THE VICTIM WAS ASSAULTED, PHYSICALLY BY THEIR CARETAKER, ANASTACIA OLUOCH(DEF), B/F, D.O.B. 09-17-53, WHO WAS AT THE LOCATION AT THE TIME OF OUR ARRIVAL. MS. TAYLOR STATED THAT AS A RESULT OF MISTREATMENT TO HER FATHER(VICTIM) AT ANOTHER NURSING FACILITY, SHE OPT TO HAVE THE VICTIM CARED FOR IN HER HOME BY THE DEF, WHO WAS RECOMMENDED TO MS. TAYLOR. MS TAYLOR STATED THAT SHE PLACED A DVR-RECORDER (VIDEO RECORDER) IN HER HOME, WHERE THE VICTIM WAS TO OBSERVE ANY FURTHER MISTREATMENT TO THE VICTIM. THE SUSPECT RESIDES AT THE LOCATION ONLY MON-FRI., TO TAKE CARE OF THE VICTIM. MS. TAYLOR STATED THAT SHE CAME HOME TODAY AND VIEWED THE VIDEO RECORDING, WHICH SHOWED ON TODAY, 05/19/2007 AT APPROX 1000 HRS., THE DEF STRUCK THE VICTIM IN THE STOMACH SEVERAL TIMES AS THE VICTIM HELD ON TO THE BED RAIL AND THE DEF ALSO STRUCK THE VICTIM ON THE VICTIM'S HANDS, WITH THE DEF'S CLOSED FIST, WHILE THE VICTIM HELD ONTO THE RAIL. THE VICTIM WHO WAS UNABLE TO DEFEND HIMSELF WAS UNABLE TO COMMUNICATE WHAT HAPPENED TO HIM AND IF HE HAD SUSTAINED ANY INJURY. UPSET BY THE ASSAULT, MS. TAYLOR CALLED FOR POLICE TO PRESS CHARGES AGAINST THE DEF. THE VIDEO RECORDING WAS SHOWN TO ME (AND OFC. MENDEZ) AND THE DEF WAS AT THE LOCATION AT THE TIME OF OUR ARRIVAL. DET, JERRY HEID, SENIOR CITIZEN POLICE LIAISON, WAS NOTIFIED OF THE INCIDENT. THERE WERE NO VISIBLE INJURIES ON THE VICTIM AT THIS TIME. MEDICAL TREATMENT WAS REFUSED BY MS. TAYLOR. THE DEF WAS PLACED UNDER ARREST, WAS CHARGED ACCORDINGLY AND TRANSPORTED TO
