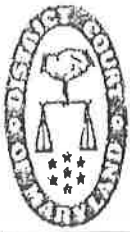

On above date and time, I was dispatched to a theft from vehicle report at the Monkton Grille, located at 16949 York Rd. Monkton, MD. 21111. Upon arrival, I was met by victims Dukes, Hess, and Ullman. They advised that while they were working at the restaurant someone stole items from their vehicles which were parked on the back lot. All three vehicles were unlocked. Victims Dukes, Hess, and Ullman could not provide any suspect information, but Victim Ullman did remember seeing a young boy on the property during the timeframe that the thefts had occurred. She described this boy as possibly homeless, a small white male with blonde hair in his early teens. She stated that this same boy has been around the area before, begging for food or cigarettes. She did not know his name. I drove over to the 7 Eleven at 16956 York Rd. Monkton, MD. 21111 to see if anyone saw this boy. I spoke with a subject in the 7 Eleven who wished to remain anonymous. This subject advised that he knew a boy who comes into the 7 Eleven often attempting to buy cigarettes, but he did not know his name. This subject stated that he once observed this boy get into an unknown vehicle with an adult, so he took a picture of the tag on this vehicle. He was able to look back in his phone and find the tag number. He also stated that he believed the boy lived on Quiet Oaks Lane near Hereford Rd. The tag he provided was Maryland

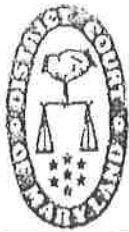

A153904. A check through MVA revealed that the vehicle was registered to Edward Nemphos at 605 Quiet Oaks Lane, Monkton, MD. 21111. I responded to this address and observed a young teenager who fit the description, except that he had dark brown hair. As I was speaking with this teenager, another teenager, who fit the description came out of the house along with his parents. They came over to my car and were identified as suspect Alexander Nemphos and his parents, Edward Nemphos and Barbara Lorenzo. Alexander Nemphos was clearly intoxicated and a strong odor of alcohol was about his person. I advised the parents of the thefts from autos that I was investigating, and while I was speaking, suspect Alexander Nemphos blurted out that he spoke to a "kid" earlier in the day who had admitted to stealing items from vehicles at the Monkton Grille. I asked him who this kid was, and he stated that he did not know him. I then spoke to the parents alone and advised them that Alexander fit the description perfectly and I believed he was responsible. I confronted Alexander in front of his parents and told him that I believed he was lying to me. He immediately broke down and stated that he was the one who broke into the cars. He then stated that he had the property. He took us to several locations around the house where he had concealed the items. The following property was

recovered at the house; Victim Dukes' cell phone, and Victim Hess' I-Pod, and \$10.00. At this time, Edward Nemphos took me aside and advised me that his handgun had been stolen at his place of business in Baltimore City several months ago, and he was worried that Alexander might have something to do with it. I asked Alexander where the gun was and at first he denied having it. I asked him again several minutes later, and he stated that it was not in his room. I asked him again several minutes later and he finally admitted that he had hidden it in his room in a plastic container. At this time I notified Cpl. Crew #3525 and he responded to the scene. The gun was recovered and packaged as evidence. I asked Alexander what he was going to do with the gun, and he stated that he was going to kill his parents with it and then drive to school (Carver Center) and shoot the school police officer and then take the officer's gun and ammunition and kill as many teachers and students as he could. He then stated that he had made several bombs and was going to blow up the school. Alexander stated that he had written his plans down in a journal. He also stated that he had three bombs in his bedroom. I observed what appeared to be two explosive devices in the bedroom behind a dresser. At this time the Hazardous Device Unit was notified and responded to the scene. The house was evacuated and secured for

the Hazardous Device Unit. Detectives Green #3818 and Strausner #4848 responded and took custody of three explosive devices and explosive making materials. The journal was also found in the bedroom and had details of his intent to kill his parents and attack the school along with a suicide note. Alexander stated that he had intended to go through with his plan on Halloween (10/31/14) and had in fact taken the firearm to school in his backpack, but remembered that he did not have the bombs, so he did not go through with the plan. He stated that he drank whiskey prior to going to school and was too intoxicated to carry out the plan. He stated that he was going to try again on Monday (11/03/14). This time he was not going to drink so he could carry out his plan without being impaired. He stated his intent was to kill the school officer and then take his weapon and ammunition and deploy the bombs. He then stated that he would shoot anyone who attempted to thwart his plan, and students who have bullied him in the past. Alexander advised that he has been bullied for several years and has told teachers, but nothing has ever been done to stop it. The journal was taken as evidence. He was taken into custody and transported to Precinct 7 for processing. All these events occurred in Baltimore County. The value of Victim Edward Nemphos' handgun is \$125.00. Recovery value is \$125.00. Victim Hess
