# STATEMENT OF PROBABLE CAUSE

ARREST ON TRAFFIC / NATURAL RESOURCES / MASS TRANSIT CITATIONS / CRIMINAL CHARGES / MUNICIPAL ORDINANCES / PUBLIC LOCAL LAWS INCLUSIONAL PROPERTY AND STATE AND STATE OF THE POLITICISM CONTRACTOR OF T

ON SUNDAY, DECEMBER 14, 2014 AT APPROXIMATELY 1929 HOURS, DISPATCHER #43 CONTACTED THE HOMICIDE OFFICE ADVISING THAT AN OFFICER HAD BEEN SHOT AT THE INTERSECTION OF GWYNNS FALLS AND WARWICK STREETS AND WAS BEING TRANSPORTED TO SINAI HOSPITAL. YOUR WRITER ALONG WITH DETECTIVE ROBERT BURNS, DETECTIVE SERGEANT SEAN JONES, AND DETECTIVE LIEUTENANT CHRIS JONES RESPONDED TO THE SCENE ARRIVING AT 1941HOURS. INVESTIGATION REVEALED THAT OFFICERS ANDREW GROMAN, JENSON PODBIELSKI AND JAMES SCOGLIO WERE WORKING UNIFORMED PATROL IN THE AREA OF THE 2600 BLOCK GWYNNS FALLS PKWY. OFFICER SCOGLIO STATED WHILE ON FOOT AT THE GULF GAS STATION, HE OBSERVED A SILVER CADILLAC BEARING MD TAG 2BL8864 OCCUPIED BY SEVERAL UNKNOWN PERSONS. OFFICER SCOGLIO STATED HE NOTED THE SMELL OF MARIJUANA EMANATING FROM THE VEHICLE. OFFICER SCOGLIO RADIOED FOR OFFICERS GROMAN AND PODBEILSKI TO STOP THE VEHICLE AS IT TRAVELLED EASTBOUND ON GWYNNS FALLS PKWY FROM THE

ARREST ON TRAFFICINATURAL RESOURCESIMASS TRANSIT CITATIONS/CRIMINAL CHARGES/MUNICIPAL ORDINANCES/PUBLIC LOCAL LAWS

GULF GAS STATION. OFFICERS GROMAN AND PODBEILSKI ACTIVATED THEIR LIGHTS AND SIREN AND STOPPED THE VEHICLE IN THE 2600 BLK GWYNNS FALLS PKWY AT TIOGA PKWY. OFFICERS GROMAN AND SCOGLIO APPROACHED THE VEHICLE ON THE DRIVER'S SIDE WHILE OFFICER PODBEILSKI APPROACHED FROM THE PASSENGER SIDE. MOMENTS LATER OFFICERS JOHNSON AND BROWN (COPPIN STATE UNIVERSITY POLICE) ARRIVED AND ASSISTED WITH THE CAR STOP. THE DRIVER, IDENTIFIED AS TAVON SULLIVAN WAS ASKED TO EXIT THE VEHICLE AND COMPLIED. THE DRIVER WAS LEAD FROM THE VEHICLE AND SEATED ON THE SIDEWALK ON THE PASSENGER'S SIDE OF THE VEHICLE. OFFICER GROMAN BEGAN TO INSTRUCT THE REAR PASSENGER, LATER IDENTIFIED AS DONTE JONES (#1/M DOB 7/3/1995) TO SHOW HIS HANDS AND EXIT THE VEHICLE. HE DID NOT COMPLY AND WAS INSTRUCTED ONCE MORE AFTER OFFICER GROMAN WITHDREW HIS ELECTRONIC COMPLIANCE DEVICE (TAZER). OFFICER GROMAN DEPLOYED HIS TASER TOWARDS THE NON-COMPLIANT SUSPECT AS HE WITHDREW A BLACK REVOLVER (ROSSI .357 CALIBER REVOLVER SERIAL# F477546) THAT WAS CONCEALED IN HIS CLOTHING, THE SUSPECT FIRED AT LEAST ONE SHOT AT OFFICER GROMAN AND PROCEEDED TO EXIT THE VEHICLE AND FLEE ON FOOT. OFFICER SCOGLIO AND OFFICER BROWN GAVE CHASE ON FOOT AND FOLLOWED THE SUSPECT INTO THE 3000 BLOCK OF TIOGA PARKWAY. OFFICER SCOGLIO DEPLOYED HIS TASER ONCE DURING THE CHASE BUT MISSED. THE SUSPECT RAN TO THE REAR YARD OF 3030 TIOGA PARKWAY AND SCALED THE FENCE IN AN ATTEMPT TO ESCAPE. OFFICER SCOGLIO RELOADED HIS TASER AND FIRED AT

THE SUSPECT ONCE MORE AS HE ATTEMPTED TO FLEE BY CLIMBING THE FENCE. THE SUSPECT RAN TO
THE REAR OF THE HOUSE WHERE HE WAS APPREHENDED BY OFFICERS SCOGLIO AND BROWN. OFFICER
GROMAN SUSTAINED A SINGLE GUNSHOT WOUND TO HIS LOWER ABDOMEN. HE WAS TRANSPORTED TO SINAI
HOSPITAL AND TAKEN INTO SURGERY FOR HIS INJURIES. OFFICER GROMAN WAS LISTED IN SERIOUS
BUT STABLE CONDITION. THE SUSPECT WAS PLACED UNDER ARREST AND TRANSPORTED TO THE HOMICIDE
UNIT. UPON HIS ARRIVAL AT THE HOMICIDE UNIT, DONTE JONES WAS ADVISED OF HIS
RIGHTS (WAIVER OF RIGHTS FORM) AND AGREED TO SPEAK WITH INVESTIGATING DETECTIVES. HE
ADMITTED TO POSSESSING A HANDGUN DURING THE VEHICLE STOP AND CONFESSED TO SHOOTING AT P/O
GROMAN AT LEAST TWICE AND FLEEING THE SCENE. THE INTERVIEW AND SUBSEQUENT CONFESSION WERE
MEMORIALIZED BY VIDEO RECORDING. ALL EVENTS OCCURRED IN BALTIMORE CITY, STATE OF
MARYLAND.
