On February 1, 2016 at approximately 10:17 p.m. Detective Brown of the NED-DDU telephoned the Homicide Unit to
advise there was a serious stabbing at the location of the 1500 block of Pentridge Road on the campus of Morgan State
University and was requesting assistance. Detective Brown advised that she was at the crime scene and the victim was
transported to Johns Hopkins Hospital. Detective Matchett and Detective Brockdorff responded to the hospital while
Detective Lieutenant Hagan and Detective Sergeant Santos responded to the crime scene.

Upon arrival to the hospital it was determined that the victim was transported from 1530 Pentridge Road to Johns Hopkins Hospital via Medic #16 where despite medical assistance he was pronounced deceased by Dr. Gaborkelen at 10:27 p.m. The victim was identified as Gerald Williams (M/B/20 dob 6/30/95) Preliminary investigation revealed that he sustained a stab wound to the left groin. Detectives then responded to the 1500 block of Pentridge Road to the crime scene. This block contains residential buildings for the State University students. The crime scene was located in the parking lot next to 1530 Pentridge Road. Located within the crime scene were blood and items of clothing. The crime scene was processed by Crime Lab Technician Colter. Witnesses were located and transport to the Homicide Unit to be interviewed. The Office of the Chief Medical Examiner was notified and responded to the hospital to collect the remains for an autopsy.

On February 2, 2016 Detective Matchett and Detective Brockdorff attended the autopsy of the victim. It was performed by Dr. Aronica and Dr. Kessler who ruled the victim's death a Homicide by Stabbing.

During the course of the investigation witnesses were located and interviewed. They identified Harry Robertson AKA "Lucky" as the individual responsible for stabbing the victim. Mr. Robertson was identified via photographic arrays. Assistant State's Attorney Robinson has been notified of the status of the investigation and recommends an arrest warrant at this time.
