On February 20th, 2019 at 2134 hours, Officers from the Eastern District Patrol recieved a shot spotter call for the 300 block of E. 22nd Street. Upon arrival, Officer's located a crime scene in front of 320 E. 22nd Street. The crime scene consisted of two 9MM shell casings and broken glass in the street. No victim was located at the scene.

A vehicle pulled into the emergency lane of John Hopkins Hospital with Ms. Kaylyn High (F/B 21) seated in the passenger seat suffering from a gunshot wound to the back of the head. (F/B 22) was operating the vehicle. Ms. High was rushed into emergency surgery for her injuries.

Further investigation, revealed and her child's father, Mr. Ramon Burks (M/B SID 3472236) were involved in a physical altercation in the 300 block of E. 22nd Street. Defendant struck with a closed fist multiple times in the face. suffered minor injuries enters her vehicle to drove off after the altercation. passes the defendant in her vehicle when the Defendant withdraws a 9MM semi-automatic handgun and discharges his handgun twice, striking Ms. High, a passenger, with a bullet in the back of the head. Despite medical staff efforts, Ms. High was pronounced deceased at 0324 hours by Dr. Tsagkalidis. Ms. High was transported to the OCME office for a post mortem examination to be performed.

A witness was shown a photographic array and positively identified Mr. Ramon Burk Jr SID 3472236 as the person who shot Ms. High. Witness identity will be provided for court purposes at a later date to prevent retaliation towards the witness. Statement was recorded through video/ audio.

All events occurred in the City Of Baltimore, State of Maryland.
